Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 2386, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO THE UNIVERSITY OF HAWAII CAPITAL IMPROVEMENTS PROGRAM PROJECT ASSESSMENT SPECIAL FUND,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to establish the University of Hawaii capital improvements program project assessment special fund for the purpose of defraying certain administrative costs related to the implementation of its capital improvement projects (CIP).

Your Committee on Conference finds that currently, operating general funds are used to defray certain costs of CIP projects and to provide centralized management, oversight, and administration in the implementation of CIP projects. Your Committee on Conference agrees that the costs related to these projects should instead be assessed and amortized against each individual project. Your Committee on Conference notes that the Department of Accounting and

General Services has a similar project assessment fund for the same purposes.

Your Committee on Conference has amended this measure by inserting an effective date of July 1, 2010.
