Your Committee on Ways and Means, to which was referred S.B. No. 2960 entitled:

"A BILL FOR AN ACT RELATING TO THE DEPARTMENT OF EDUCATION,"

begs leave to report as follows:

The purpose of this measure is to restructure the administration of the Department of Education.

More specifically, this measure divides the Department of Education into two major divisions:

- (1) The Academic Achievement Division, which will be responsible for improvements in student achievement and administering educational policy; and
- (2) The Administrative Division, which will be responsible for providing quality support and central services.

This measure also establishes two deputy superintendent positions, to be appointed by the Superintendent of Education, to head the new divisions.

Your Committee received no written comments on this measure.

Your Committee finds that this measure would implement a key recommendation of the Task Force on Reinventing Government by realigning the Department of Education's functions and redistributing existing administrators' responsibilities to improve the organizational structure and accountability of the
