The purpose of this measure is to clarify county restrictions on group living facilities.

Your Committees received testimony in support of this measure Testimony in opposition was received from from four individuals. Written testimony presented to the Committee may one individual. be reviewed on the Legislature's website.

This measure adds temporal restrictions on commercial deliveries, and ambient noise and pollutant emission standards at lot boundaries to the county requirements that must be satisfied in order for group living facilities to operate.

Your Committees find that many residents, including the elderly, mentally ill, and disabled, for a variety of reasons and circumstances may benefit from residing in group living facilities that provide deinstitutionalized, residential settings that are more conducive to their care, health and autonomy, and quality of However, as the number of group living facilities increases life. in traditional residential areas, the potential negative impacts that they may unintentionally cause due to increases in care provider and visitor traffic, commercial deliveries, noise, and other impacts resulting from the facilities may affect their

surrounding neighbors, thereby reducing the latter's quality of life and quiet, peaceful enjoyment of residential living.
