HB 2417, HD1 (HSCR215-10) Status

RELATING TO ACTIVITY DESKS.

TCI, CPC/JUD

Establishes record keeping requirements for client trust accounts held by activity desks. Clarifies that activity desks shall include registration numbers on all advertising materials of an activity provider. Prohibits an activity desk from booking or placing a reservation for activities with an activity provider until payment is received or direct payment to the provider is arranged. Increases activity desk bond or letter of credit

cap to \$250,000. Effective January 1, 2112. (HB2417 HD1)

HB 2083, HD1 (HSCR124-10) **Status**

RELATING TO MILK LABELING.

AGR, CPC/JUD

Requires milk and soy milk beverages to be labeled with the date of pasteurization or the date of packaging. Effective January 20, 2020.

HLT, CPC/JUD RELATING TO HEALTH INSURANCE. HB 2089, HD1 Requires health insurers to report annually on how health insurance (HSCR264-10) premiums are being spent; and spend a minimum amount of the **Status** premiums on medical expenses. Requires the Insurance Division of the Department of Commerce and Consumer Affairs to collect from health care providers, analyze, and disseminate health care information for use in a publication to assist the public in choosing health care providers. Effective July 1, 2020. (HB2089 HD1) HLT/HUS, RELATING TO HEALTH. HB 2087 Exempting QUEST plans from paying interest under the clean claims CPC/JUD (HSCR286-10) act when delays are due to non-payment by government payers to Status QUEST plans. RELATING TO PLANNED COMMUNITY ASSOCIATIONS. HSG, CPC/JUD HB 2110 Permits members of planned community associations to make (HSCR21-10) electronic recordings of association meetings for personal use. Status HSG, CPC/JUD RELATING TO PLANNED COMMUNITY ASSOCIATIONS. HB 2624, HD1 Conforms planned community association laws with respect to proxies (HSCR206-10) to comparable provisions regulating condominium property regimes. Status Takes effect January 1, 2011. (HB2624 HD1) CPC/JUD RELATING TO PRIVATE TRANSFER FEES. HB 2288 Prohibits the imposition of fees for a future transfer of real property. Status Specifies exceptions. RELATING TO INTOXICATING LIQUOR. CPC/JUD HB 2905 Prohibits use by minors of false identification to purchase liquor. Status Establishes fines and other penalties. Designates 50% of revenues from fines to county programs for underage drinking awareness and

prevention. Authorizes the issuance of citations as an alternative to

arrest for violations associated with intoxicating liquor.
