HB 2939, HD1 (HSCR109-10) **Status**

RELATING TO THE LONG TERM CARE COMMISSION. Requires the long term care commission to review the feasibility of establishing a long term care fund to assist residents who would otherwise not qualify for any government or private long term care insurance program. Requires the Commission to recommend appropriate funding mechanisms.
