Requires all public schools, including charter schools, to implement a minimum of two hundred days of classroom instruction per school year. Prohibits any collective bargaining agreement under chapter 89, Hawaii Revised Statutes, from containing provisions that would

shorten the school year for public school employees to less than two

hundred days of classroom instruction per school year.

SB 2797 RELATING TO VOLUNTARY EMPLOYEES' BENEFICIARY EDH/LBR, WAM

Testimony ASSOCIATION TRUSTS.

Makes permanent the voluntary employees' beneficiary association

<u>Status</u> trusts, established in 2005 as a temporary program.
