Proposed SD1:

Clarifies that the exemption from subdivision requirements for leases, easements, and other possessory interests for renewable energy facilities applies to renewable energy facilities on urban, rural, or agricultural land approved by the land use commission and county planning commissions, and renewable energy facilities on conservation land permitted by the board of land and natural resources.
