RELATING TO VETERANS.

Requires the Director of the Office of Veterans' Services to act on behalf of deceased veterans found to be indigent at the time of death and without surviving immediate family members to ensure the burial or cremation and inurnment of the veteran's remains in a state veterans

cemetery.

SB 2831, SD1 (HSCR767-10)

<u>Status</u>

RELATING TO THE PROCUREMENT CODE.

Makes permanent the requirements for withholding payment to a subcontractor effectuated by Act 175, Session Laws of Hawaii 2009.

SB 2543, SD2, HD1

(HSCR865-10)

Status

RELATING TO TECHNOLOGY.

Creates the Hawaii broadband commission and the Hawaii broadband commissioner to promote and maximize the availability of broadband services in the state. Appropriates funds. Effective July 1, 2112.

SB 506, SD1, HD2 (HSCR864-10)

Status

RELATING TO PROCUREMENT.

In procurements contracts payable by the State or a county and a utility, provides that the utility's share of contract costs is subject to certification as to sufficiency of funds, and certification is to be based on amounts to be paid by a utility under a legal agreement with the

State or county.

SB 2840, SD2, HD1 (HSCR866-10)

Status

RELATING TO PUBLIC PROCUREMENT.

Requires at least eighty per cent of workers on construction procurements to be Hawaii residents; provides sanctions for noncompliance including temporary suspension of contract work, payment withholding, disqualification from the project, recovery of

contract payments, and disbarment or suspension.

residences program.

Reduces the membership of the environmental council from 15 to 9

and establishes the environmental review special fund.
