Amends the appropriations allocated to the workforce investment boards on the islands of Oahu, Maui, Kauai, and Hawaii; amends the appropriation to be used by the workforce development council; repeals the appropriation allocated to the department of labor and industrial relations for administrative expenses. HB 2823 Status	RELATING TO WAGES, HOURS, AND WORKING CONDITIONS OF EMPLOYEES OF CONTRACTORS PERFORMING SERVICES. Requires that services to be rendered shall be performed by employees paid at wages or salaries not less than the wages paid to public officers and employees for similar work in the State of Hawaii. HB 2855 Status	RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM. Requires the board of trustees of the employees' retirement system to study and recommend a plan to fully amortize the unfunded actuarial accrued liability of the system over a 30-year period.	LAB, FIN
HB 2937 Status	RELATING TO COLLECTIVE BARGAINING. Includes benefits in collective bargaining.	LAB, FIN
