<u>SB 2849</u> <u>Testimony</u> <u>Status</u>	RELATING TO THE HAWAII EMPLOYER-UNION HEALTH BENEFITS TRUST FUND. Adds three new sections on selection of benefit plan carriers, fiduciary duties, and liability for breach of fiduciary duty; exempts the Hawaii employer-union health benefits trust fund from the requirement to use the attorney general; increases the members of the board of trustees from ten to twelve and changes membership and terms; authorizes the board to retain an attorney who is independent of the attorney general as legal advisor; transfers the fund from the department of budget and finance to the department of human resources development. <u>SB 2384</u> <u>Testimony</u> <u>Status</u>	RELATING TO WAGES AND HOURS OF EMPLOYEES ON SERVICE CONTRACTS. Extends little Davis-Bacon rights regarding prevailing wages to employees on service contracts with governmental contracting agencies.	LBR/JGO, WAM
