SB 2745 RELATING TO CONTROLLED SUBSTANCES. PSM, JGO

Testimony Makes Hawaii's controlled substance laws consistent with that of federal law and clarifies sections of chapter 329 relating to controlled

Status substances.

SB 2911 RELATING TO THE POWER OF ARREST. PSM, JGO

Testimony

Updates references to customs and border protection service, and citizenship and immigration services to reflect current names of agencies within the federal department of homeland security. Adds the federal bureau of investigations to the list of federal agencies whose

officers may make arrests for certain offenses under State law.
