SB 2807 PROPOSING AN AMENDMENT TO ARTICLE VII, SECTION 6, WAM, JGO
OF THE HAWAII CONSTITUTION, RELATING TO THE TAX

Testimony REBATE REQUIREMENT.

Status Proposes a constitutional amendment to article VII, section 6 of the

state constitution to authorize the legislature to determine whether excess funds should be used as tax refunds or tax credits to taxpayers of the state or diverted to the state's emergency and budget reserve

fund.

SB 2825 RELATING TO STATE FUNDS. WAM

Testimony Clarifies that the 5-year limitation for short-term investments also

applies to the underlying securities of those investments.

<u>Status</u>

SB 2866 RELATING TO SPECIAL PURPOSE REVENUE BONDS. WAM

Requires an applicant for a special purpose revenue bond to apply for a pre-authorization certification from the department of budget and finance 3 months prior to the legislative session in which the applicant

seeks the bond authorization. Sets out requirements for the pre-

authorization certification for each type of bond.
