"Thank you, Mr. Speaker. I rise in opposition to H.B. 1961—Relating to the Kaho'olawe Rehabilitation Fund. As founder of the Heritage Caucus whose mission is to preserve the unique locations of Hawaii, and as a past President of Life of Land, I recall supporting the rehabilitation of Kaho'olawe and strategies to implement a successful plan for rehabilitation. However, while I see the good intention of the bill, I still have some concerns.

"The Ocean Tourism Coalition (OTC) states in their testimony that businesses are "fighting for their very survival in this difficult economic climate. Tourists already are not spending as much to take tours like the ones we offer. Our passenger counts are down significantly in spite of heavy discounting in the marketplace." I think the OTC brings up some real concerns, but I feel that this bill is the wrong vehicle at the wrong time. Thank you."

Representative Shimabukuro rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Shimabukuro's written remarks are as follows:

"Mr. Speaker, I rise to speak with reservations concerning House Bill 745 HD2 – which eliminates the requirement to send a ten-day pending notice requesting additional medical evidence when it is determined by DHS eligibility workers that an applicant does not have certain disabilities that would qualify him or her for General Assistance.

"During the Human Services Committee hearing, the DHS Director spoke in favor of the bill, citing the need for increasing efficiency and timeliness in the process. Citing a ten-percent increase in volume of GA applications, the Director tried to make a case for cutting out a critical step in the process which currently enables an applicant to supply additional medical evidence to back up their claim.

"I do sympathize with the Department's need to keep up with an increasing workload during this time of budget cutbacks and restrictions, not only in DHS but in all departments. However, I cannot support legislation which I believe will unfairly impact people with disabilities. This bill will remove current protections and take away an applicant's right to a second medical opinion when they have been denied certification by a physician hired by DHS. Under the existing process, an applicant is asked to complete a form which does not allow for the inclusion of any medical evidence. The disability determination is then made after a cursory examination by the DHS doctor.

"I believe that the availability of a second opinion is a basic human and legal right. This bill takes away that right. Since the bill in its HD2 version now contains an appropriation to provide general assistance to households without minor dependents, I am hesitant to vote no. However, I do ask that my strong reservations to HB 745 HD2 be noted."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I rise with serious reservations on Stand. Com. No. 305, HB 1905 that would create two new separate accounts in our general fund. Mr. Speaker, we've already got 40% of our budget squirreled away in special funds. This bill is going to squirrel away \$338 million more by separate accounts in the general fund. This is a bill that is not necessary at this time. I repeat, not necessary. We've got \$275 million that we have by a tax refund lag. We have no need to put back in at this point just the same way that Cayetano's payroll lag is never showing up on our books and as you know, there is, someone said this morning, \$1.2 to \$1.8 billion possibly being as a deficit.

"So to do this and then put the funds into the ERS at this time, which is also not necessary, I think as we make fun of pushing the can down the road as being insufficient, I think it's the way that small businesses survive at a burden of \$338 million onto the budget that's already in the red doesn't make good fiscal sense, Mr. Speaker. So I have very serious reservations on why we're doing this and I hope the Chair of Finance seriously looks at this as he looks at this cash flow statement. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1905, entitled: "A BILL FOR AN ACT RELATING TO STATE PAYMENTS," passed Second Reading and was referred to the Committee on Finance.

Representative Souki rose to speak in support of the measure with reservations, stating:

"Yes, with reservations and a short statement that I believe that the county is negligent in providing the kind of facilities that are needed in that respective area. For that reason, I am with reservations."

Representative Hanohano rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Thielen rose in opposition to the measure and asked that the remarks of Representative Souki be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Berg rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Brower rose to speak in support of the measure, stating:

"Mr. Speaker, in support. And briefly, many urban areas should have a *shishi* bill like this. This should be expanded."

Representative Carroll rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Cabanilla rose to speak in support of the measure, stating:

"In strong support, Mr. Speaker. And I would also like this extended, especially in my district of Waipahu."

Representative Wooley rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and H.B. No. 1862, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PUBLIC ORDER," passed Third Reading by a vote of 50 ayes to 1 no, with Representative Thielen voting no.

H.B. No. 2397, HD 1:

Representative B. Oshiro moved that H.B. No. 2397, HD 1, pass Third Reading, seconded by Representative Evans.

Representative C. Lee rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative C. Lee's written remarks are as follows:

"Mr. Speaker, moving the primary election date forward will encourage better participation in our democracy. It will give new candidates a better chance to get their message out in the short time between the primary election and the general election, and level the playing field that currently gives incumbents a much greater advantage."

Representative Finnegan rose in support of the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Finnegan's written remarks are as follows:

"I rise in support of this measure. HB 2397 moves the date of the primary election to the second Saturday of August and requires nomination papers to be filed not later than 4:30 p.m. on the first Tuesday in June. Our troops have served our country honorably by defending democracy around the world. This measure ensures that our veterans and their opinions are represented in our democracy, here at home."

Representative Takai rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Takai's written remarks are as follows:

"Mr. Speaker, I speak in support of this bill. The purpose of this bill is to ensure compliance with the Federal National Defense Authorization Act that requires states to mail absentee ballots to uniformed and overseas voters no later than 45 days prior to federal elections.

"This bill will move Hawaii's Primary Election date to the second Saturday in August and move the deadline for filing nomination papers to the first Tuesday in June. Deployed military personnel still want to be a part of the democratic process, expanding these deadlines is an important way of giving them an opportunity to do so.

"This bill addresses many concerns that the Office of Elections had raised about timing. This will allot more time for our troops to fill out and submit their absentee ballots. If a person is deployed we should not disregard the fact that they are a citizen of the United States and therefore still have the right to vote in any given election.

"For these reasons, I support this measure and urge my colleagues to do the same. Thank you."

The motion was put to vote by the Chair and carried, and H.B. No. 2397, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PRIMARY ELECTIONS," passed Third Reading by a vote of 51 ayes.
