No. 2690, entitled: "A BILL FOR AN ACT RELATING TO GOVERNMENT," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Bertram, Souki, Thielen and Tokioka being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 509-10) recommending that H.B. No. 2874, pass Second Reading and be placed on the calendar for Third Reading.

Representative B. Oshiro moved that the report of the Committee be adopted, and that H.B. No. 2874, pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Evans.

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, I rise in opposition with brief comments. Mr. Speaker, you know when people ask you for a donation, and you say, 'I gave at the office'? This is the tax increase for the hotel industry where in the Finance Committee they said, 'Hey, we gave last year.'

"We bumped them two percentage points and this year, we are going to raise the TAT again. I think if anybody saw yesterday or today's paper, they have a percentage of increase of visitors this month over last year. They have a percentage of increase of expenditures, which is great news. And it looks like we're finally getting out of the doldrums. We're turning the corner. This is the engine of the economy. Why do we even want to play with this small amount of taxation to possibly, 'gum up' the works, which is in a turnaround position. So I think is 'pennywise, pound foolish.' Thank you."

Representative Pine rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ching rose to speak in opposition to the measure, stating:

"In opposition. I just feel that again, to reiterate what the Representative from Hawaii Kai is saying, this is not the time to raise taxes on tourism because we're still not out of the bad economy. We just don't want to raise taxes at this time. May I also submit additional written comments?"

Representative Ching's written remarks are as follows:

"Thank you, Mr. Speaker. I rise in opposition to House Bill 2874, which temporarily increases the Transient Accommodations Tax rate on timeshare units from 7/1/2010 to 6/30/2015, and adds an additional 2% on fair market value.

"Hawaii cannot afford to target tourism with tax burdens beyond those the industry already suffers. Still struggling from last year's hefty impositions, the tourism industry is not yet out of the woods with its recovery. Visitor arrivals have declined by 1.1 million over the last two years, and visitor spending has decreased by \$2.8 billion. Tourism competition is now fiercer than ever, and price has become the main factor in attracting or deterring potential tourists, so we must not repel yet another sector of our State's valued tourism influx. Furthermore, we must retain as much money as possible within our economy, in order to boost economic performance, or at least to prevent it from slowing further than it already has.

"More specifically, timeshares often gravitate toward a particularly valuable population of Hawaii's visitors. Rooms provided through timeshare arrangements are often used to attract meeting planners, travel agents, travel journalists, and film crews to the Islands. Visiting for work related purposes, these crucial groups make decisions that are highly price-dependent, as the agencies, publishers, companies and producers will quickly select another destination if Hawaii proves uneconomical. Not only will price hikes sacrifice the funds gained directly through the timeshare deals, but they will also lose all those subsequent revenues from the many meeting attendees, travelers gained through agencies, readers of travel journals, and those celebrities contingent to filming shoots. Echoing repercussions will resound long after these losses, in the lost opportunity for Hawaii's media publicity to overseas audiences.

"Private owners of timeshare units are fundamental components of tourism in Hawaii, too. With their rent already paid, these visitors have more discretionary funds to spend on restaurants, shops, souvenirs and tourist activities, which hotel guests must budget more carefully. Timeshare owners also are more specifically committed to Hawaii as opposed to alternative vacation locales, and offer one of the State's most stable visitor sources in the event of natural or national disaster. Timeshare owners and their guests have also been shown to stay an average of 10.3 nights, significantly longer than most hotel guests. Subject to yearly maintenance fees and real property taxes, timeshare owners are indeed property owners.

"If Hawaii institutes this proposed tax, it will become the only State in the US which will ask owners to pay transit occupancy taxes for their own real property. Although timeshare owners offer economic stability to Hawaii which few other visitor classes can rival, their loyalty has still become fragile in these difficult times. In 2009 alone, for instance, over 300 owners decided to relinquish their timeshares simply because of cost issues. We must put a plug in these losses before they get out of hand, and alienate one of Hawaii's most loyal and lucrative visitor populations. Thank you."

Representative Finnegan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Brower rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Marumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2874, entitled: "A BILL FOR AN ACT RELATING TO THE TRANSIENT ACCOMMODATIONS TAX," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Ching and Ward voting no, and with Representatives Bertram, Souki, Thielen and Tokioka being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 510-10) recommending that H.B. No. 2963, pass Second Reading and be placed on the calendar for Third Reading.

Representative B. Oshiro moved that the report of the Committee be adopted, and that H.B. No. 2963, pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Evans.

Representative Finnegan rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I'm in opposition and have short comments. Mr. Speaker, this is making an emergency appropriation from the Emergency and Budget Reserve Fund for education. This is the Rainy Day Fund. Basically, I'm not for just using this for education. I'll reserve the rest of my comments for Third Reading."

Representative Pine rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ching rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Takai rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I rise in support. Thank you, Mr. Speaker. You know, there's very little we can do right now in the Legislature to get our students, our kids back to school and to eliminate furlough days. The best we can do is to position a bill based on the recommendations set forth by the Governor and a few other people, in terms of how they're going to address, or how they're trying to address the furlough situation. This is what we heard is the proposal on the table; to utilize some or all of the Rainy Day Fund to get the kids back in school.

"So I appreciate Leadership's and the Finance Committee's efforts to get this measure through our process. The goal is once, and we hope that once they decide to get this agreement through, that we will be ready within a few days to get this up to the Governor. I also ask to submit additional written comments in support, Mr. Speaker. Thank you."

Representative Takai's written remarks are as follows:

"Mr. Speaker, I speak in support of this bill. The purpose of this bill is to make an emergency appropriation of \$50 million from the Emergency and Budget Reserve Fund to the general fund. This would restore instructional days that have been turned into furlough days because of the State's shortfall in revenues for Fiscal Year 2009-2010.

"I realize that there are tremendous needs facing our communities in this very difficult economic crisis. We created the "rainy day fund" in 1999 for times like we're experiencing now. However, today it's not raining, it's actually pouring buckets of rain.

"I understand the concerns of the social service agencies, especially regarding the needs of the elderly and medically fragile. My vote in support of this bill to utilize \$50 million for teacher furloughs is not a position against providing the funding to the elderly and needy, but more a statement against the current furloughs in education. I do support funding for the elderly, for the needy and for the medically fragile. However, when Hawaii becomes the laughing stock of the Nation or when the U.S. Secretary of Education makes hurtful comments against the education system in Hawaii in the Washington Post and the New York Times, I'm terribly concerned.

"I have spent my entire legislative career focused on the education of children in Hawaii. From 1994 until last year, I was extremely proud of what we have accomplished. 'Education is our Top Priority' is not a slogan for me. Rather, it's a mission. Nearly each waking hour of my life as a State Representative, I've tried to live for this mission.

"My wife and I have both greatly benefited from our own public school education. She graduated from Moanalua High School, and I graduated from Pearl City High School. In hindsight, we wouldn't have it any other way. We are proud graduates of Hawaii public schools. Even our two young children are educated at an elementary school in Aiea. They were both receiving the best education that money can buy until this past fall.

"Furloughs are a disgrace. We build schools so that children can learn in a safe environment. Schools are where dreams are developed. When schools are closed due to furloughs and children are left at home because we can't afford paying our teachers, they lose. And when children lose, we all lose.

"A few years ago, I spent a few years volunteering in our public schools. A good friend of mine Mark Hunter, who is a retired banker from Tampa, Florida, and I spent a few years working together on an econometrics model for public schools in Hawaii. This econometrics model took into consideration a few factors that some teachers say are beyond their control. I call these, "uncontrollables." These "uncontrollables" include things like the percentage of students who are on free and reduced lunch, the percentage of students in special education, the size of the school, the percentage of teachers with less than five years of experience, the teacher attendance rate, the student attendance rate, to name a few.

"We used eight of these "so-called" uncontrollables. With these data, we could determine scores of the Hawaii State Assessment within three percentage points before the test is even taken – before the test is taken. Before the test is taken, we know with some certainty that a certain school will hit a certain score on the state assessment.

"So how is this relevant to furloughs and to today's challenges? Here's why.

"The most important factor influencing performance on the State assessment is not whether a student gets free or reduced lunch or whether the teachers are just out of college. The most important factor impacting scores on the state assessment is student attendance. How well a student does in school is based on attendance. This makes perfect sense to me. If a student is not in school, she will not learn. And if she doesn't learn, she will not perform well on the state assessment.

"Again, if a student is not in school because his school is closed to furloughs, he will not learn. And if he doesn't learn, he will not perform well on the State assessment.

"Furloughs keep students at home. Furloughs keep students out of school. Not being in school means our children are not learning. Children who are not learning will not do well in school and will not do well on the State assessments. Our actions or lack thereof are hurting students, are hurting our children.

"Furloughs must end. They must end not only because we closed the schools and not only because they are an embarrassment to the nation. We must end furloughs because we're hurting our children and we are hurting our future.

"I urge our colleagues to support this bill. Thank you, Mr. Speaker."

Representative Pine rose to respond, stating:

"I'm sorry. May I just give a couple of comments? My reservations weren't against ending furlough days. I just want to make that clear. That is our Caucus' our number one priority. I think there was just a concern for using all of the Fund, instead of using it for the safety net which is what we're all worried about as well."

Representative Yamane rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I'm standing up in support with reservations. I want to just highlight again, that the Rainy Day Fund was designed to help with the issues of healthcare and human services. Mr. Speaker, as we all know, it's definitely pouring, even at the point of flooding. There are programs that currently need this money. So I hope that something can be worked out in which we not only address our instructional days, but also protect our most vital services and healthcare. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2963, entitled: "A BILL FOR AN ACT MAKING AN EMERGENCY APPROPRIATION FROM THE EMERGENCY AND BUDGET RESERVE FUND FOR EDUCATION," passed Second Reading and was placed on the calendar for Third Reading, with Representative Finnegan voting no, and with Representatives Bertram, Souki, Thielen and Tokioka being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 511-10) recommending that H.B. No. 2505, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative B. Oshiro, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 2505, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE ACCESS HAWAII COMMITTEE," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Bertram, Souki, Thielen and Tokioka being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 512-10) recommending that H.B. No. 2532, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative B. Oshiro, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 2532, HD 1, entitled: "A BILL FOR AN ACT RELATING TO UNCLAIMED PROPERTY," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Bertram, Souki, Thielen and Tokioka being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 513-10) recommending that H.B. No. 2875, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative B. Oshiro, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 2875, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAII HURRICANE RESERVE TRUST FUND," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Bertram, Souki, Thielen and Tokioka being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 514-10) recommending that H.B. No. 2595,

as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative Pine rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Marumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Finnegan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, on Stand. Com. Rep. No. 514, with strong reservations. Mr. Speaker, in legal parlance, in a court of law we're all innocent until proven guilty. This bill for the GE tax says, 'You owe GE tax to the State of Hawaii, until you prove that you're exempt.' This is kind of rounding up more than the usual suspects. It's taking everybody, whether you sell Kool-Aid on the corner or you do anything for any amount of money.

"I think even though Mr. Kawafuchi and the Department of Taxation need as much help as they can get, and there's a big underground economy, and all of that, some of these things I think, they're too far reaching. They're too Machiavellian. This bill goes a little bit too far because you have to show that you are exempt and you've got physical paper.

"It's like the tax police that we've heard have been walking down Fort Street Mall. 'Can I see your GE tax? Can I see proof that you're being able to do this?' Some in the farmers' markets also felt intimidated. They didn't have a cash register. So we have got to be serious about citizens paying what they have to pay, but we also know that this is not Russia. We also know this is not a way, where we strong-arm people. We all pay our taxes on April 15th on a voluntary basis, but this is getting a little bit very close to the edge. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2595, HD 1, entitled: "A BILL FOR AN ACT RELATING TO GENERAL EXCISE TAX," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Bertram, Souki, Thielen and Tokioka being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 515-10) recommending that H.B. No. 1922, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

On motion by Representative B. Oshiro, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 1922, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TAXATION," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Bertram, Souki, Thielen and Tokioka being excused.

Representative Ching's written remarks are as follows:

"Thank you, Mr. Speaker. I rise in opposition of H.B. 2313 H.D. 1 which repeals the income tax provision to require the reporting of gambling winnings, but not losses.

"We must always be cognizant of the messages we are sending as the Legislature, and this Session, the Legislature is moving forward a plethora of measures which either attach fees or moreover, rescind tax exemptions that individuals and businesses have relied upon for decades. We count approximately 30 bills that do this. These measures take away the ability to write off certain expenditures, and yet the one bill we repeal and give back the ability to report is one for gambling. It just seems wrong.

"As I have not served on the Committees that this was vetted through, my first time I have seen this bill was on the Floor of the House today. It just seems wrong with all the cries for help from business, individuals, and those that rely on healthcare that we can restore this provision and not others. We must be aware of the appearance we portray. My no vote is a reflection of the fact that I question the priorities of this Legislature trend. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2313, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TAXATION," passed Second Reading and was placed on the calendar for Third Reading, with Representative Ching voting no, and with Representatives Bertram, Souki, Thielen and Tokioka being excused.

"Mr. Speaker I am voting no and have brief comments. Mr. Speaker, this is probably the same thing as paying our fair share of taxes, except this one goes to the extent that if you are a legitimate business and you do your best to make money, and you actually lose money, this bill says that your carryover is not going to be deductible for the following year.

"Case in point. If I'm a farmer and I have to go for maybe an 18-month cycle before I get my fruit or my vegetables or my trees to harvest. This says that you're not going to be able to deduct that amount of itemized deduction. That is not fair. It, unfortunately, is what we're doing as a

country. There's too much intervention of government into what otherwise is a private sector matter that has allowed us to prosper up until this point. We're getting too greedy and too interventionist into our economy. This is one of those bills that really doesn't pass the 'smell test.' Thank you."

Representative Marumoto rose to speak in opposition to the measure, stating:

"Thank you. Likewise, Mr. Speaker, I am in opposition to House Bill 1907, House Draft 1. It would not allow your carryback deduction for losses for certain years, 2009 and 2010. Many businesses have not been doing well recently. If we collapse their carry-back provisions, it could be a real business killer. I hope that this bill does not survive this Session. Thank you."

Representative Finnegan rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I would like a no vote and I'll save my comments for Third Reading."

Representative Pine rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ching rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. Representative Finnegan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ching rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Pine rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2850, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE LIQUOR TAX," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Ching and Ward voting no, and with Representatives Bertram, Souki, Thielen and Tokioka being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 525-10) recommending that H.B. No. 2851, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, I am rising in opposition with a brief comment. Mr. Speaker, people on the Floor had recently lamented the fact that we have a safety net and that we're supposed to be helping those who are not able to help themselves. Yet at the same time, and on the other hand, and the same breath, we turn around and raise the cost of living with taxes such as this, and the ability to buy insurance. With the next bill, we're going to tax the banks more for their participation in the economy.

"Mr. Speaker, we can't have it both ways. If we want the people of Hawaii to survive, and we already have a quarter million of people who are dependent upon the government for their healthcare, their sustenance and survival. A quarter million people. We only have 1.3 million people.

"If we don't stop these cost of living increases by causing all these fees and these taxes to increase, we're going to wonder why have we pushed all these people to the side and wonder why there's not enough funds for the social services. Because this is what takes away from that, Mr. Speaker.

"Domestic violence is on the rise. The first thing that families fight for is money. We're taking more money out and I think we've got to know when the limit is the limit. Thank you, Mr. Speaker."

Representative B. Oshiro rose to speak in support of the measure, stating:

"Mr. Speaker, in support, very briefly. I must object to some of those characterizations. Unfortunately in the current status that we're in, we have a deferral of all of our Medicaid and QUEST payments going on and on for months and months. We're talking millions of dollars that are not being paid. We want to talk about the 'safety net,' and then we don't want to actually pay for it.

"The Administration is refusing to pay for it. The Department of Human Services is saying that we don't need to pay for it. The federal law doesn't require us to pay for it. So you know what? We'll just kick the can down the road and let somebody else pay for it at a later time.

"We can't do that. It needs to get paid if these people are going to get services. So I don't see how the Representative from Hawaii Kai can say, 'Let's save the 'safety net',' but not find a way for us to pay for it. Unfortunately our current Administration has not accounted for that and we need to account for that if we're going to have that 'safety net.' Thank you."

Representative Ward rose to respond, stating:

"Thank you, Mr. Speaker. Just a brief retort to the learned Majority Leader. If we look at the source of where government gets its funding, it's half personal income taxes, half GE Taxes, generally speaking. Those private sector entities such as those that we are, with this bill, going to tax. They are the ones, if they decrease their revenue generation, they decrease in their employee, they decrease their taxation paid. The assumption is if we just raise their tax we'll get more money versus, if we make them weak, the tax and the money we're going to get is going to be weak.

"The correlation between helping the business community or hindering them is really the stagnation that we're now economically experiencing. We've got to be able to get the businesses healthy because let's face it, 80% of all the jobs come out of the private sector. Not everybody works for government. Not everybody is so secure as to have government payment. And the unemployment lines, 95% of the people come out of the private

sector. Less than 5% are from the public sector. So we depend upon the private sector. We depend upon those businesses. We should give them a break because they're the ones who feed us, who fund us, and make us have government as it is today.

"So the learned gentleman who doesn't see the correlation between those who feed us and the hand that feeds us, this is the fundamental thing of private enterprise in a capitalistic society, which has been the richest in the world heretofore, has never experienced. Thank you."

Representative Finnegan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ching rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

There are many things and many decisions that we're going to make this year that may delay or minimize prevention so that we can provide the service to the person in the ER room, or in the hospital who actually may die if we don't. These are the tough decisions that we have.

"Secondly, I would also like for Members to keep in mind that the Trust Fund money that this money is being diverted from which, if I'm not mistaken, lies outside the State Treasury, has a balance of over \$50 million. That's fifty, 5-0, not 1-5, at a time when we can't even make Medicaid payments and provide child protective services and other things that are critical for the 'safety net.' Thank you."

"Thank you, Mr. Speaker. I stand in opposition of H.B. 2849 H.D. 1, which imposes a retroactive reserved housing requirement for residential and commercial planned development permit projects greater than 45 feet in height or containing a floor area ratio greater than 1 1/2 on a lot 20,000 square feet or greater in size in the Kakaako community development district, mauka area, and repeals the use of in-lieu cash payments and substituted housing not located within the Kakaako district.

"I do believe that the Kaakaako community should be composed of residential housing for all income level families, however this particular measure is not the proper way to encourage the creation of low and moderate income housing in this area. According to the Land Use Research of Hawaii Foundation, there is no evidence that proves there is legal justification that these percentages allotted are justified or constitutional. I agree with both this Foundation and the Hawaii Community Development Authority that there needs to be some discussion before a measure is passed with stakeholders, landowners and agencies to develop a consensus of goals, incentives and implementations.

"We must take into consideration the ideas of the HCDA and its opposition for reasons such as the unreasonable ties associated with commercial development and the confusion in actual results as a result of this measure. We must also look at incentives that should be included in the programs. Thank you."

Representative Brower rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations on Stand. Com. Report No. 535. Thank you, Mr. Speaker. And I will reserve more detailed comments for the future, but passing this bill may undo some of what this Body has done previously to the waterfront area in Kakaako. Thank you."

Representative C. Lee rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative B. Oshiro's written remarks are as follows:

"This measure places a small, but formidable requirement upon mortgage lenders to notify their mortgagors about appropriate foreclosure counseling services that may be available to them at least forty-five days prior to initiating foreclosure proceedings. Similar measures have been introduced and passed in other states and have been shown to have success in assisting homeowners facing foreclosure.

"Hawaii has not been immune to the effects the financial calamity wreaking havoc around the globe. Predatory lending, unregulated financial markets, and poor legislative oversight all contributed in part to the economic environment we find ourselves in now. Unfortunately, many people were lured into buying homes, apartments, etc. that ended up being out of their price range, or became out of their price range following the loss of a job.

"Keep in mind, in January, Hawaii's foreclosure rate rose 286%, from a year ago, and nearly 25% of all mortgages nationwide are currently underwater (meaning borrowers owe more on their loans than their homes are worth). The foreclosure crisis *is* hitting close to home. We owe it to those in our communities who have lost a job, or are furloughed, to make every effort to keep them in their homes.

"Sometimes our government has an opportunity to extend a helping hand to those struggling to stay fiscally afloat – this is one of those times.

"This bill provides some protection to homeowners by providing them valuable tools and information to prevent the loss of their homes. I urge my colleagues to support this measure."

Representative Pine rose in support of the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Pine's written remarks are as follows:

"Mr. Speaker, the Ewa area is the hardest hit area on Oahu when it comes to foreclosures. In 2009 there were over 630 foreclosures in the Ewa Beach area. Currently more than 42 percent of Ewa Beach's active listings are short sales or foreclosures, and prices have dropped about 30 percent from the height of the last up cycle.

"The real tragedy here is that Ewa Beach is primarily a working-class neighborhood, and real people are the ones that have been damaged by this turn of events. Ewa Beach's reputation as an affordable place for new homes attracted a lot of young couples, who could only afford the payments by working more than two jobs between them. The reality is that this economy has decimated the job market, and this Legislature is exasperating the problem with increased taxes on the good people of Hawaii.

"This bill offers some relief, possibly a ray of sunshine. It does not guarantee that these people will get to keep their houses, but it will give them a fighting chance, and that is what they want, a chance. This bill asks that they be given 45 days notice. The funny thing is you would hope that this was already a requirement. The bill also requires that this notice include information for the mortgagor to get mortgage counseling. Who knows, maybe, just maybe, this may give one of my hard working constituents the insight they need to save their house. Maybe it doesn't, but we gave them a fighting chance. We didn't let them sink without throwing them a lifeline. We did all that we could to help them out.

"I am passionate about this, because this problem of foreclosures is going on every day in my backyard. These peoples are my neighbors and friends, and someone has to stick up for them. So I rise in support not only for this measure, but for my friends and neighbors in Ewa Beach who deserve this help."

Representative Brower: "Thank you, Mr. Speaker. A constituent has asked me to remind this Body that today is an important day for Azerbaijani-Americans. It commemorates the Khojaly Massacre, which took place on February 26 in 1992.

"The Armenian government's effort to ethnically cleanse the Azeri population resulted in the death, wounding and hostage taking of almost 2,000 innocents civilians, mostly women, children and elderly. The crime against these peaceful residents of Khojaly was condemned worldwide and broadly covered by national newspapers and magazines, as well as in our country's Congressional Record.

"This memorial day for Azeries will always be remembered, and I would like to join with Azeri-Americans and the US Azeries Network in encouraging our country to properly recognize and commemorate this tragedy. Thank you, Mr. Speaker."

Representative Ward: "Mr. Speaker, two brief announcements. One. On this day in history, in 1961, Kuwait gained independence from Britain and immediately was occupied by Iraq, and we know the rest is history with the Iraqi War and other things that some of us have served in.

"Secondly, if appropriate I would call for a moment of silence for the death of the two-newspaper Hawaii. We don't know which one's going to die, but I think it's a sad day when there's not going to be two voices in the newsprint business any longer. Thank you, Mr. Speaker."
