The House of Representatives of the Twenty-Fifth Legislature of the State of Hawaii, Regular Session of 2010, convened at 12:06 o'clock p.m., with the Speaker presiding.

The invocation was delivered in song by former Representative Michael Puamamo Kahikina, after which the Roll was called showing all Members present with the exception of Representative Bertram and Cabanilla, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Twenty-Fourth Day was deferred.
