"The concern that I have is, years ago when I was a student at the University and the University Administration proposed these types of measures. I think it was incumbent upon the Administration to work with the students. Student leaders throughout the UH System testified *en masse* against this particular measure, and it's clear to me that the Administration has not yet convinced the student leaders throughout the System that there are assurances written in this bill, as well as the UH Administrative Rules that will allows for student input prior to any increase.

"I think without the support of the students, we do, I believe, have some serious issues in regards to this particular proposal. So I urge my colleagues to take a look at this, and I oppose this measure. Thank you."

Representative Berg rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

It's the companion of the, 'get Pearl Iboshi' bill that we have. This is the Senate's version of that. It basically puts a black list out on anybody who's received a political appointment, and puts a stigma and a reporting to the political body. If you're a political appointee. It's basically anti-American, McCarthyistic, promotes dumbing down of our civil service to

make sure we got a watch on who these guys are who took political appointments. It makes a mockery of really the civil service system.

"A lot of people come out of it, they go into it and they're going to be marked individuals. I think that's very divisive for a place that calls itself the Aloha State. If we put this sign and signal into government, which heretofore for all the generations of all the governments in statehood, we've never needed it before, and now have this. This is bad public policy, Mr. Speaker. Sorry I took up your time, but it's so bad it needs to be spoken on, on First, Second, Third, Fourth, Fifth, and all the Readings that this will ever be lasting. Thank you."

Representative Evan rose, stating:

"Mr. Speaker, can the previous speaker yield to a question?"

Representative Ward: "With pleasure."

Representative Evans: "Thank you. When I read the bill and the Standing Committee Report, I don't see how you got to where it applies to elected officials. How did you come to that conclusion?"

Representative Ward: "It says the political appointees have to report to the elected officials. That is us, the Legislature. We want to keep a count and a list of everybody who's been appointed to the government so we know who they are, and where they are. And if there's a probationary period, which as I said is in the sister bill, the Pearl Iboshi bill, we want to make sure they don't get back into civil service until at least, in the bill the House has, for one year. Or for whatever the other gymnastics we are forcing them to go through."

Representative Evans: "Thank you, Mr. Speaker."

Representative Ward: "Thank you, for that question."

Representative Marumoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Thielen rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Finnegan rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Pine rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Rhoads rose to speak in support of the measure, stating:

"Mr. Speaker. In support. I just want to say that I don't see how this bill rises to the level of McCarthyism. That seems like kind of overheated rhetoric to me. I do think there's a legitimate question about not just in this Administration, but in any Administration that takes political appointees and tries to, what is commonly referred to as 'burrowing.' And this is an anti-burrowing bill. We'll see how it turns out. It goes on to another Committee after this. Mahalo"

Representative Souki rose to speak in support of the measure with reservations, stating:

"Yes, Mr. Speaker, with strong reservations. I believe this bill sets a precedent that we don't need. Thank you."

Representative McKelvey rose in support of the measure with reservations and asked that the remarks of Representative Souki be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Pine rose to respond, stating:

"I just want to explain my no vote. Based on what this bill does, it requires every State agency to report to the Legislature all non-civil service temporary employees employed by the agency for each quarterly period of the fiscal year not later than the 15th day following the end of each quarterly period.

"On that particular point, Mr. Speaker, if this Legislature is willing to publicly disclose all of our political appointees in every single department that we have placed them in, then I would be much more in favor of that section of the bill. I think that's my biggest opposition."

Representative Belatti rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

"Mr. Speaker, I am presenting written comments in support of HCR 123, relating to recognizing aerospace as a strategic and timely growth industry for Hawaii and requesting the state administration to take proactive, coordinated and sustained action to fully realize the significant, educational, and commercial benefits the aerospace industry can bring to the state.

"The aerospace industry can serve as a catalyst for innovation in Hawaii, bringing more scientific research and high tech jobs to the state. Not only would aerospace diversify our economy, it would support our existing tourism industry with new activities and faster flights to and from other spaceports in the world.

"Aerospace provides Hawaii with a lot of potential for economic and scientific advancement. But we have to work for it. We've already taken steps, like spending \$500,000 for our space port license's environmental impact statement. But we need to aggressively follow through. For these reasons, Mr. Speaker, I support HCR 123."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.C.R. No. 123, entitled: "HOUSE CONCURRENT RESOLUTION RECOGNIZING AEROSPACE AS A STRATEGIC AND TIMELY GROWTH INDUSTRY FOR HAWAII AND REQUESTING THE STATE ADMINISTRATION TO TAKE PROACTIVE, COORDINATED, AND SUSTAINED ACTION TO FULLY REALIZE THE SIGNIFICANT SCIENTIFIC, EDUCATIONAL, AND COMMERCIAL BENEFITS THE AEROSPACE INDUSTRY CAN BRING TO THE STATE," was referred to the Committee on Finance, with Representatives Carroll, Ching, Manahan and Nishimoto being excused.
