Representative Karamatsu, for the Committee on Judiciary presented two reports:

(Stand. Com. Rep. No. 1101-10) recommending that H.R. No. 11, be adopted; and

Representative B. Oshiro moved that notwithstanding the recommendations contained in Standing Committee Report No. 1101-10 and Standing Committee Report No. 1102-10, that H.R. No. 11, and H.C.R. No. 49, be recommitted to the Committee on Judiciary, seconded by Representative Evans.

Representative Thielen rose to speak in support of the motion to recommit, stating:

"I strongly support the motion, Mr. Speaker. I think that's a very wise thing to do and I appreciate this step by the Majority Caucus. Thank you."

Representative Ward rose to speak in support of the motion to recommit, stating:

"Mr. Speaker, as the Chair of the Gender Equity Caucus of the Minority Caucus, we are fully in support of this motion. Thank you."

Representative Cabanilla rose to speak in opposition to the motion to recommit, stating:

"In opposition to recommital Mr. Speaker, and I would like to give a few comments. For the last 23 years of my life that I have served in the regular Army, as well as the Army Reserve, I have been a proponent of gender

equality and gender equity, Mr. Speaker. And I have always voiced that we women are just as capable as men.

"To recommit this bill will be to admit that men always have the upper hand on women, and although there are a lot of women who may not agree with me, I think this underlying measure is a step to say that we are just as capable, even in the field of aggression or otherwise.

"So I would like to state for the record that this is a step in the opposite direction, as far as obtaining gender equity for women. Thank you, Mr. Speaker."

Representative Thielen rose to respond, stating:

"Mr. Speaker, I just want to respond to the former speaker. I would like to just note that the Domestic Violence Action Center makes it very clear that the specialized domestic violence programs are dedicated to helping all victims, and stopping domestic violence whenever it occurs.

"It recognizes that domestic violence affects everyone: women, men and children. And while 85% of all victims are women, men are victims in 15% of the cases. So they're making it very clear that these services are available to male and female victims, and treatment is available to male and female offenders.

"I would also like to just briefly note that the Hawaii State Coalition Against Domestic Violence states that domestic violence services in the State of Hawaii are committed to helping victims and ending domestic violence regardless of the gender of the perpetrator. Programs are accessible and available to provide support to both male and female victims, and treat both male and female offenders.

"So our system is gender neutral, and it's operating well. Both of those domestic violence providers testified in opposition to these resolutions. Thank you."

The Chair then stated:

"Members, we are voting on the motion to recommit these two resolutions and not on the merit of the resolutions. But if you would like to enter your comments, that is fine."

Representative Belatti rose in support of the motion to recommit and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Belatti's written remarks are as follows:

"I stand in support of recommittal of House Resolution 11 and House Concurrent Resolution 49. The general intent of these resolutions, to study the causes and effects of domestic violence, is commendable. Unfortunately, last month noted the fifth death related to domestic violence in Hawaii for 2010. All but one of these individuals were female. The lone exception was a male who killed himself after attempting to murder his former girlfriend at a Kailua bowling alley. The problem of domestic violence is tragically prevalent in our State, and more attention being paid to it will help us address the root causes of these destructive social behaviors.

"However, the means with which these resolutions seek to study domestic violence are misdirected at a time when budget constraints call for more well-defined measures if we hope to accomplish our goal of better understanding and fighting domestic violence. Ordering an already cut and crippled Department of Human Services to perform another study while the department is experiencing massive layoffs and restructuring is legislative micro-management at the worst possible time. In addition to budget and staff cuts already sustained in 2009, DHS is presently facing cuts which will result in the loss of 228 full-time positions. The appropriate agencies that may be better suited for the study being called for are the Department of the Attorney General and the Prosecutor's Offices of the various counties. Finally, at a time when services to victims of domestic violence are diminishing because of state budget cuts and declining donations, it would also be inappropriate to demand these non-

profit services to perform statistical analyses above and beyond what they are already doing.

"Much has been done in the last decade in Hawaii to bring attention to domestic violence. I believe everyone in this Chamber is committed to addressing this terrible social problem afflicting all of our communities. However, these legislative measures as drafted now would not accomplish our goals at this time and these resolutions should be recommitted."

The motion was put to vote by the Chair and carried, and H.R. No. 11, entitled: "HOUSE RESOLUTION REQUESTING THE DEPARTMENT OF HUMAN SERVICES TO INVESTIGATE THE INCIDENCE OF DOMESTIC ABUSE PERPETRATED BY WOMEN AGAINST MEN IN HAWAII," was recommitted to the Committee on Judiciary, with Representative Cabanilla voting no, and with Representatives Chang, Herkes and Luke being excused; and

H.C.R. No. 49, entitled: "HOUSE CONCURRENT RESOLUTION REQUESTING THE DEPARTMENT OF HUMAN SERVICES TO INVESTIGATE THE INCIDENCE OF DOMESTIC ABUSE PERPETRATED BY WOMEN AGAINST MEN IN HAWAII," was recommitted to the Committee on Judiciary, with Representative Cabanilla voting no, and with Representatives Chang, Herkes and Luke being excused.

STANDING COMMITTEE REPORTS

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 1111-10) recommending that S.B. No. 2834, SD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative B. Oshiro moved that the report of the Committee be adopted, and that S.B. No. 2834, SD 1, pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Evans.

Representative Thielen rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Marumoto rose to speak in opposition to the measure, stating:

"I would also cast a no vote. I do not believe we should offer deductions for gambling which is an illegal activity. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 2834, SD 1, entitled: "A BILL FOR AN ACT RELATING TO TAXATION," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Marumoto and Thielen voting no, and with Representatives Chang, Herkes and McKelvey being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 1112-10) recommending that S.B. No. 2395, SD 2, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative B. Oshiro moved that the report of the Committee be adopted, and that S.B. No. 2395, SD 2, HD 1, pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Evans.

Representative B. Oshiro rose to disclose a potential conflict of interest, stating:

"Mr. Speaker, I'd like to ask for a ruling on potential conflict on SB 2395. At my law firm, I do believe we represent HSTA on ERISA issues, but I don't work on that case. Thank you," and the Chair ruled, "no conflict."

Representative Takai rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I'd like the clerk to register a with reservations vote for me on this one.

"Thank you. I just wanted to mention a couple things since we're on Second Reading. Just for the Members to contemplate. This bill basically extends the VEBA program, the VEBA Trust for the teachers by six months until December 2010. And the reason for that is, as we all know, there are some issues concerning the current operations of the Employee Union Trust Fund. And those concerns really are in terms of the amount of staffing and ability for the Trust to adequately address the concerns of the current members.

"You may not know, but I believe and still trust that come July 1st, I think open enrollment for the next year should begin shortly, and we're going to go through this whole thing all over again.

"The last one that we did was in my eyes, poorly implemented. It was a challenge for everybody, not to mention a challenge for all our personnel officials throughout the State and counties. And I just can't imagine us doing another open enrollment for a new year which will be a full year, July 1st to June 30th of next year, but also to deal with the teachers.

"Having said that, I don't think the EUTF is even going to be ready this December to take on the additional teachers even if we decide to do that. So my reservations are twofold. Number one, is I still continue to support the continuation of the EUTF. And number two, if we do decide that it's no longer beneficial to the State and we decide to consolidate the teacher's into the EUTF, I do believe that the December deadline is still going to be very difficult for the EUTF to meet. Thank you, Mr. Speaker."

Representative Ward rose to speak in support of the measure with reservations, stating:

"I also rise on this which is the correct bill this time, with reservations which are as the other speaker indicated, except I wanted to note one foot note that in the Finance Committee, we had the auditor's report and then we had HSTA's consultant who was there. And many of us, and I take partial guilt for that, were probably partially 'brain dead,' because we had been doing so much Finance work. During that hearing, there was a lot on the agenda so we never heard the full other side of the story. But I know we're hearing the other full side of the story from the EUTF, in that it is near insolvent. And if not insolvent, losing a million per year. The point is, it's in serious trouble. It makes VEBA look all the better. So as we cut this one out in favor of something, that which may be stronger, in effect, it may be weaker. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 2395, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE BUDGET," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Chang, Herkes and McKelvey being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 1113-10) recommending that S.B. No. 2405, SD 2, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative B. Oshiro moved that the report of the Committee be adopted, and that S.B. No. 2405, SD 2, HD 1, pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Evans.

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, I rise in opposition with a couple of brief comments. Mr. Speaker, just a brief reminder that this is job killer bill number 7, and to be mindful of the context that in the three quarters of the last year, we lost 46,000 jobs. When these rules of the business change, the employees are going to suffer because they're the ones that are going to be cut.

"So we're trying to make the budget balance, but at the same time, the cost that it's going to take to clean up the mess when the businesses that

hire 80% of all our employees can't make their payroll. They're going to cut employees. So is it 'penny wise and pound foolish'? That's why it's a job killer. Thank you."

Representative Marumoto rose to speak in opposition to the measure, stating:

"Thank you. I seem to be very contrary this morning. I am in opposition to this bill. I think mainly because I have a real aversion to the Senate Bill which institutes the streamline sales tax and raises the general excise tax. I think those are big job killers.

"But also, the House Draft 1 will cap itemized deductions and I think an unintended consequence of capping these deductions may reduce contributions to charities and other worthwhile causes because a taxpayer's contribution deductions will be limited. So I caution the Conference Committee to please consider this very carefully. Thank you."

Representative Thielen rose to speak in opposition to the measure, stating:

"A no vote for me please, for the same reason that was just mentioned."

Representative Ching rose to speak in opposition to the measure, stating:

"Thank you. Also a no vote for the same reasons."

Representative Pine rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Finnegan rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 2405, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TAXATION," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Ching, Finnegan, Marumoto, Pine, Thielen and Ward voting no, and with Representatives Chang, Herkes and McKelvey being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 1114-10) recommending that S.B. No. 2493, SD 2, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative B. Oshiro moved that the report of the Committee be adopted, and that S.B. No. 2493, SD 2, HD 1, pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Evans

Representative Rhoads rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative C. Lee rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Thielen rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Pine rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Carroll rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Takai rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. A no vote. Thank you. And just two comments as we ponder this measure for Third Reading next week. In 2007, the University of Hawaii Medical School made a commitment to us all of us and said that they needed additional general fund support for two years. So we actually wrote a proviso into the budget and provided them

with that increase. We also gave them this bill and they said they only needed it for four years and they'll figure things out. Everything will work out. Well today, we see this bill and it extends the lapse date from 2011, to 2015. It basically doubles the amount of time that they're requesting that from us. That's number one.

"Number two, I do know that we have a critical shortage of physicians in Hawaii. But you know, supporting the Medical School does not, I repeat does not guarantee that we will increase the amount of doctors in Hawaii.

"I made this statement numerous times, and I'll make it again today. That if we want to ensure that our tax dollars, hard earned tax dollars from the taxpayers of this State goes to support the increase of doctors, we're going to need to require that any and all students that choose to go to the UH Medical School must, must stay in Hawaii to practice after they're done. After they're done with their residency and other requirements like that. There's no requirement. So if you take a look at the number of students that graduate from the UH Med School and then take their residency on the mainland, take a look at how many people come back.

"I talked to the Dean and he said that when they go away to, let's say, Los Angeles for their residency, they fall in love, etc. I say, that's fine, but there's a price to pay. If you fall in love in LA and you decide not to come back to Hawaii, there should be a price. Because it costs us a tremendous amount of money to educate these medical school students, and we are hoping that they stay in Hawaii. I think we have to go beyond hope. So I would hope that over the next few days that our colleagues take a look at those two concerns. Thank you, Mr. Speaker."

Representative Thielen rose to disclose a potential conflict of interest, stating:

"Thank you, Mr. Speaker. I did want to disclose that my grandson is at the med school," and the Chair ruled, "no conflict."

Representative Thielen continued in opposition to the measure, stating:

"Thank you. I still oppose the bill."

Representative Marumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Finnegan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Belatti rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Yamane rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I'm standing in support. I would like to make a brief comment regarding the extension of funds for the School of Medicine. Mr. Speaker, our predecessors before us made the decision, and supported the decision to develop the John A. Burns School of Medicine. Mr. Speaker, some of the previous speakers have highlighted that in the past, some promises were made and were unfortunately never followed through.

"However Mr. Speaker, the times that we're facing currently require us to look past that, and look at the issues before us. We do have a physician shortage, especially on the Neighbor Islands Mr. Speaker. Also, if we want our physicians to be homegrown Mr. Speaker, we have to make that investment into a school.

"Mr. Speaker, there are programs currently, where the School of Public Health, the School of Social Work, and other schools are not required or not pushed by members of my Caucus or any Caucus, to require that the graduates of University of Hawaii or any University within the UH System be required to remain here. If we're going to make that a policy, then we should make that statewide.

"It negates the fact just like other universities, major universities, both nationally internationally, in which they want their students to move abroad and be part of the greater community because it enhances the knowledge and expertise of the university that they graduated from. Thank you, Mr. Speaker."

Representative Berg rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I rise in opposition to this bill for a number of different reasons. And I would like our colleagues to just remember the quote that, 'our past is not our potential.' If we're looking at continuing to utilize the Tobacco Settlement Fund money for this particular endeavor, then I think we need to ask different questions. Thank you."

Representative Hanohano rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 2493, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO USE OF TOBACCO SETTLEMENT FUNDS," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Berg, Hanohano, Rhoads, Takai and Thielen voting no, and with Representatives Chang, Herkes and McKelvey being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 1115-10) recommending that S.B. No. 2578, SD 1, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative B. Oshiro moved that the report of the Committee be adopted, and that S.B. No. 2578, SD 1, HD 1, pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Evans

Representative Marumoto rose to speak in support of the measure with reservations, stating:

"Mr. Speaker. On Stand. Com. Rep. No. 1115, I would like to vote with reservations on this measure mainly because it's a new tax credit that we're establishing, and because it is a blank percentage. I don't know how much it will amount to, and I think hopefully we will have a better idea how much it will cost us before the final passage. Thank you."

Representative Finnegan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Pine rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 2578, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TAXATION," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Chang, Herkes and McKelvey being excused.

The welcome mat's no longer there. And granted, some of these things may have been generous, but ratcheting it down rather than precipitously closing would have been preferential. So this one does it rather abruptly, and I'm sure the repercussions from the high-tech community will be not fast, but they'll be severe and long lasting. Thank you."

Representative Keith-Agaran rose to disclose a potential conflict of interest, stating:

"I would request a ruling on a possible conflict. This is for both Stand. Com. Rep. Nos. 1118 and 1119. I'm associated with an entity that has invested in qualified high-tech businesses. Thank you," and the Chair ruled, "no conflict."

Representative Ching rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Pine rose to speak in support of the measure with reservations, stating:

"Yes reservations, and just a quick comment. As the speaker from Hawaii Kai had mentioned, we're ending the repeal of this Act six months earlier than we did earlier. While I was very supportive of many of the controversial changes we made to Act 221 and 215, this just gives the very businesses that have invested based on the previous version of the law that gave them a lot of incentives to invest in Hawaii. It really gives them very little time to adjust their investments and recapture their investments."

Representative Thielen rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Finnegan rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 2001, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TAXATION," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Finnegan, Thielen and Ward voting no, and with Representatives Chang, Herkes and McKelvey being excused.

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker. I would like a no vote for the same reasons as the previous bill. Thank you."

Representative Pine rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Finnegan rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

It's going to be a CPA's dream because it's going to take a CPA to know how to do your taxes. How to get your everyday books together. And what it's going to do Mr. Speaker, is that there's so many job killers, I forget which number this is, but this is still a job killer. Thank you."

Representative Pine rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Thielen rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

"Mr. Speaker, in strong support and may I request permission to enter written comments into the Journal?"

Representative Har's written remarks are as follows:

"Mr. Speaker, I rise in strong support of S.B. 2109, S.D. 2, H.D. 1. This bill authorizes the Hawaii Housing Finance and Development Corporation (HHFDC) to grant no-interest, low-income housing tax credit loans to replace State low-income housing tax credits that have been devalued because of the economic crisis.

"HHFDC is the primary agency charged with overseeing affordable housing finance and development in Hawaii. The lack of affordable housing remains a significant problem affecting our State. Working families are finding it harder to purchase or rent a home. HHFDC works with the State's residents, housing developers, and financiers to make the dream of home ownership come true for Hawaii's residents.

"However, the current recession and turmoil in the financial markets has made the financing and development of low-income housing very difficult, if not impossible. S.B. 2109, S.D. 2, H.D. 1 will provide needed flexibility to jump-start the development and construction of stalled affordable rental housing projects for families at or below 60 percent of the area median

income. Turning tax credits into a monetized resource for affordable housing developers will result in more affordable housing being built, without increasing costs to the State.

"Passage of S.B. 2109, S.D. 2, H.D. 1 will be a win-win for our depressed economy. It will increase the supply of new, affordable housing. It will also help our local economy by using our existing resources more effectively and allow many stalled affordable housing projects to commence construction, putting hundreds of people back to work and stimulating our local economy. For these reasons, I stand in strong support of this measure. Thank you, Mr. Speaker."

Representative Pine rose in support of the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Pine's written remarks are as follows:

"Mr. Speaker, I rise in support for Senate Bill 2109, SD2, HD1, Relating to Low-Income Housing. This bill would establish a program for granting a no-interest low-income housing tax credit loan by the HHFDC.

"This program would result in more affordable housing units being built without increasing costs to the State. Such a program could also help boost our economy by providing jobs to those who would build affordable housing units. Therefore, Mr. Speaker I support Senate Bill 2109, SD2, HD1."
