STANDING COMMITTEE REPORTS

Representative Herkes, for the Committee on Consumer Protection & Commerce presented a report (Stand. Com. Rep. No. 1381-10) recommending that H.R. No. 136, as amended in HD 1, be adopted.

Representative B. Oshiro moved that the report of the Committee be adopted, and that H.R. No. 136, HD 1, be adopted, seconded by Representative Evans.

Representative Herkes rose to speak in support of the measure, stating:

"Mr. Speaker, in very strong support. This deals with Hawaiian Ocean View Estates which is in the Kahuku district of Hawaii Island and in my district. About 6,000 people live in Ocean View. They are in the middle of a 30 mile stretch with no potable water, no pipe water, and it's about a 27 mile round trip to the nearest water spigot.

"About 12 to 14 years ago there was money in the budget to develop a water well and system for Ocean View, but then-Governor Cayetano would not release the money. During the 2005 Session, \$6 million was put in the budget for a water well and system for Ocean View. Governor Lingle released the money in April of 2006. So Mr. Speaker, that was four years ago.

"First, they had to do a test well. USGS was charged with that and they drilled about two or three times a week. They finally completed it, but you can't use a test well for a production well. So we had to start all over and the decision was made to drill *mauka* of the highway. The well was completed about two years ago and it just sits there.

"Since then the Hawaii County Department of Water Supply has hired a company to design, build and complete the system. This company, Bolton Inc., has made significant changes to the design, much of which is contrary to the original design and the EA that the community supported. The changes are significant and the community was not advised or given an opportunity to comment on the changes. The community is very angry and very frustrated. So am I.

"Our job as elected officials is to support and protect the community and the taxpayers; not the Department of Water Supply. I thank all of the 11 of you that voted for this resolution in Committee the other day and I hope that this will be adopted on the Floor. And then a demand letter will be sent to the Mayor of Hawaii County because that's where the money went. The decision was made to hire the Department of Water Supply and there will be some very pertinent questions and we will ask for a response in writing. Then we'll investigate after that if we have to. I support this resolution."

Representative McKelvey rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support. I would just like to support the words of the colleague from Ka'u and I'd like to adopt them as if they were my own."

Representative Thielen rose to speak in support of the measure, stating:

"Also in strong support, Mr. Speaker. And I would like to support the words of the Chair of CPC. And I was present at that hearing."
