Nomination to the Board of Directors of the Hawaii Housing Finance and Development Corporation (HHFDC)

(a) Why do you wish to be a member of the Hawaii Housing Finance and Development Corporation (HHFDC)?

One of the major missions of HHFDC is to increase the supply of workforce and affordable housing this is why the State Legislature created it. Home prices and rental rates have increased faster than personal income and I feel this creates a need for more affordable housing throughout the state. There is a shortage of affordable housing which results in high housing prices and multiple generations living under one roof. An affordable home is the foundation that families and individuals build their lives upon. Health, education and quality of life are also built upon the same foundation. An affordable home in a healthy community with good schools and economic opportunity for all it the American Dream.

I believe in the HHFDC's mission and I want to do my part in this solution. Housing development helps spark the economy by providing jobs. I am a child of the 60s so as John Kennedy said in 1962 his speech:

"And so, my fellow Americans: ask not what your country can do for you - ask what you can do for your country. My fellow citizens of the world: ask not what America will do for you, but what together we can do for the freedom of man."

(b) What do you perceive are the role and responsibilities of a member of this Board?

The HHFDC Board focuses on the mission and purpose by establishing pertinent policies and sets priorities for the agency. Each individual board member should fully understand and support the mission. The board should ensure that the Executive Director has the moral and professional support she needs to further the goals of the HHFDC and participate with the staff in an overall planning process and assist in implementing the plan's goals.

As a Board member I have the responsibility to:

- Attend board meetings and functions
- Be informed about the organization's mission, services, policies and programs
- Review agenda and supporting materials prior to board meetings
- Keep up-to-date on developments in the organization's field

(c) Given your understanding of the role and responsibilities of a member of the HHFDC why do you believe that you are qualified for this position? Please include a brief statement of your skills, expertise or knowledge that would aid in your decision-making ability as a member of this Council.

I represent the workforce and their families in the pursuit of affordable homes. I am from the construction industry and I know the construction process and what it takes from planning to the construction of a building. With this knowledge and my daily contact with the hard working workers and their pursuit of the American dream, I feel I can be a responsible board member.

(d) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Board?

I firmly believe in the HHFDC's mission. My personal characteristics that I live be include:

I have the ability to listen, analyze, think clearly and creatively and work well with people individually and in a group. I believe that our role in providing affordable and workforce housing makes a difference in the community and I'm committed to fulfilling HHFDC.s goals.

I have knowledge of construction and the industry. The Board is comprised of members with diverse backgrounds. Our decisions are made with full discussion and understanding of the issues. We draw upon out areas of expertise to ensure we serve the public interest.

I am objective and sensitive to and tolerant of differing views. I like to see all sides of an issue and engage in objective, constructive discussion with the state's housing mission in mind.

(e) Can you foresee any possible conflicts of interests that could arise during your service on the Board? How would you overcome any possible conflicts of interest?

I do not forsee any conflicts of interest. However, if I perceive any conflict of interest, I would advise the Board and recuse myself from discussion and decision-making.

- (f) What are three ways that the Hawaii Housing Finance and Development Corporation should/must help meet the housing need in Hawaii?
  - 1. HHFDC must stay on mission. We must continue to provide development incentives and financing tools to support for-profit and nonprofit developers to increase or preserve the supply of workforce and affordable housing.
  - 2. HHFDC should aggressively leverage out limited State resources. We must seize opportunities to go after federal grants such as those under the American Recover and Reinvestment Act, as well as partner with developers, housing coalitions, lending institutions and unions.
  - 3. HHFDC must ensure that its resources are well invested in quality housing. Housing projects should be located in areas that are in proximity to jobs, schools and services.

Homes should be affordable to out workforce, built by reputable developers and well constructed.

(g) What goals should the HHFDC Board set and how would you propose to measure them?

Hawaii definitely faces an affordable housing shortage. The basic goal is to increase the affordable housing supply. The HHFDC Board holds annual strategic planning session where we review our progress in meeting out goals, confirm existing or develop new goals and identify strategies to reach them. We also identify measurable outcomes which include the number of newly constructed or preserved housing units, number and amount of loans made, number and amount of tax credit awards and types and amounts of new resources.

(h) What is your vision of "finishing the job" regarding government's role in helping to supply affordable housing?

Government can help supply affordable housing by providing tools and resources that support private sector efforts. HHFDC expedites housing development using its Chapter 201H development powers and provides tax credits, loans and land to developers. That's an appropriate and important role for government. But to "finish the job" in today's economic environment, we need to commit more resources to get stalled projects moving. Government should not become a developer. However, government needs to invest more resources into a project to make it financially feasible to proceed.

(i) What are your thoughts on Transit Oriented Development as related to housing?

I fully support Transit Oriented Development. It is practical and makes a lot of good sense. By locating housing close to transit nodes, transportation costs and traffic congestion are significantly reduced and residents can more easily access jobs, schools and services. It also encourages more compact housing development which reduces housing development costs.

(j) There are/were four bills concerning HHFDC's handling of GET exemptions. Please comment on them.

I understand that three of the GET bills add new eligibility criteria for rental housing projects that qualify under (4) above. The bills require tenants in these projects to be Hawaii residents and/or require HHFDC, in determining gross income, to utilize the HUD income calculations for the Section 8 housing choice voucher program. These bills create different standards for only projects that qualify under (4) above. This makes the GET exemption program more difficult to administer and discriminates against military personnel that reside in rental projects that were not developed under chapter 201H, a government assistance program approved by HHFDC, or under the sponsorship of a nonprofit entity. I believe we should treat everyone fairly. I agree with HHFDC's position that if the basic allowance for housing must be included as income, then all housing allowances should be included as income. This would include HUD section 8 rent

subsidies; HPHA rent supplement payments and homeless stipends; and HHFDC rental assistance payments.

The fourth GET bill requires HHFDC to conduct periodic review of housing projects that were certified for GET exemption. I believe this places a tremendous and impossible burden on HHFDC. I have been informed an Advice Letter from the Attorney General's Office which states that taxpayer information is confidential. Therefore, HHFDC will not be able to obtain taxpayer information for housing projects that the counties have certified for GET exemption. Snce HHFDC and the counties provide information to the Department of Taxation, I think it is more appropriate for the tax office to conduct the periodic reviews.
