Dear Senator Fukunaga,

Thank you for your consideration of my continued membership on the Hawaii Historic Places Review Board. I have pursued a career in archaeology and historic preservation because it is my passion. As such, I feel a professional obligation to contribute as I am able beyond my job to historic preservation endeavors. This is the foundation for my interest in continuing to serve on the Hawaii Historic Places Review Board, as well as my membership on the Society for Hawaiian Archaeology Board.

My perception of the role and responsibilities of a member of the Hawaii Historic Places Review Board is influenced by my experience as a former employee of the American Samoa Historic Preservation Office. Our review board in American Samoa provided guidance and advice in overseeing the functioning of the Historic Preservation Office, including reviewing nominations to the National Register of Historic Places. In Hawai'i the board's role has been cast solely to review nominations to the State and National Registers of Historic Places. I am willing to participate in all of these roles, and have indicated my willingness to assist to my colleagues in the State Historic Preservation Division.

My academic background forms the foundation of my qualifications for membership on the Hawaii Historic Places Review Board. I have a Ph.D. in archaeology; my dissertation used archaeological and oral history data to discuss pre-contact social organization on Mangaia Island, Cook Islands, another Polynesian society. I subsequently spent eight years as an archaeologist at the American Samoa Historic Preservation Office, where my responsibilities included managing the National Register program. I have written, reviewed and submitted numerous nominations to the National Register. (American Samoa does not have a Territorial Register, therefore we could not nominate historic properties to such an entity.) In this capacity I also became familiar with the larger historic preservation discipline, including the consideration of more recent historic properties and their eligibility for nomination to the National Register. Since that time I have held several positions in historic preservation, including owner and principal investigator of a contract archaeology firm in American Samoa, Hawaii Island Archaeologist for SHPD, and most recently working in the Cultural Resources program at Pohakuloa Training Area for the US Army. I am very familiar with the National Register program and criteria as well as State and Federal historic preservation laws, regulations and rules. My qualifications for the Board are primarily as an archaeologist and historic preservation professional. In addition, I have become familiar with historic era properties and their significance. Personally, I married a Polynesian and have spent a significant part of my adult life living and working in Polynesia.

I have learned a great deal during my tenure on the Hawaii Historic Places Review Board. I think that I have brought a foundational background in the National Register program to the Board, and my greatest accomplishment has been application of that knowledge to the cases that we have reviewed. I would like to continue to contribute in this way, as well as continuing to educate members of the public on the Historic Places register programs. I would also like to work with other board members to provide assistance and oversight to the State Historic Preservation Division, as possible and appropriate.

I am always eager to learn more, which makes me both interested in learning about the properties that are nominated and to investigate the contexts in which they fit. This provides a background to evaluate the properties. I am persistent in pursuing knowledge and issues, and this can contribute to a better evaluation of the items before the board. I have had an exacting past year which drew me away from close attention to board business, but that situation has resolved itself and I am now able to devote appropriate time and attention to board business. Archaeology, historic preservation and Polynesia are deeply seated passions for me, and I consider this endeavor to be a contribution to the quality of life in our State and an investment in our future. My children are of Polynesian ancestry, and their knowledge of their ancestors is important to me. This drives my dedication to historic preservation and to contribute in the best way I can to the endeavor in this State.

My experience as an historic preservation professional who has actively engaged in many aspects of the endeavor for over fourteen years makes me an asset to the Hawaii Historic Places Review Board.

Possible conflicts of interest that I can forsee would be if Army property were nominated. I would consult with appropriate authorities to determine if there was a conflict, and if there was deemed to be a conflict I would recuse myself from discussion and vote on the matter.

# In consideration of **GOVERNOR'S MESSAGE 197** SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE HAWAII HISTORIC PLACES REVIEW BOARD, GUBERNATORIAL NOMINEE, JULIE M.E. TAOMIA, FOR A TERM TO EXPIRE 6-30-2014

The Department of Land and Natural Resources strongly supports the gubernatorial appointment of Dr. Julie Taomia to the Hawaii Historic Places Review Board for a term to expire 6-30-2014.

The Hawaii Historic Places Review Board was established under Section 6E-5.5, Hawaii Revised Statutes, to: (1) Order and enter historic properties into the Hawaii Register of Historic Places on the basis of their value to Hawaii's heritage; (2) Evaluate and, when appropriate, recommend the nomination of historic properties to the National Register of Historic Places; (3) Review the State Survey of Historic Properties; (4) Review the content of the State Historic Preservation Plan; and (5) Maintain the Hawaii Register of Historic Places (including all those listed on the National Register of Historic Places).

State law requires that the Hawaii Historic Places Review Board include at least one professionally qualified member of each of the following disciplines: archaeology, architecture, history, and sociology. In addition, there shall be one person knowledgeable in traditional Hawaiian society and culture.

Dr. Taomia was born in Boston, Massachusetts and grew up in Detroit, Michigan. She received her undergraduate degree from the University of Michigan at Ann Arbor, master's degree in Anthropology at the University of California at Berkeley, and doctorate also at the University of California at Berkeley. Her PhD dissertation was entitled Archaeological and Ethnohistoric Evidence for Protohistoric Social Relations on Mangaia Island, Cook Islands.
