# Testimony of Chiyome Leinaala Fukino, M.D. Director of Health March 5, 2010

- 1 Department's Position: The Department of Health strongly supports confirmation of Gordon M.
- 2 Durant (6/30/204) to serve on the State Council on Mental Health (SCMH).
- 3 **Fiscal Implications:** Not applicable.
- 4 Purpose and Justification: To confirm the appointment of Gordon M. Durant to serve on the SCMH
- as the O'ahu Service Area Board on Mental Health and Substance Abuse representative.
- 6 Chapter 334-11, Hawaii Revised Statutes, requires that the governor in making appointments to
- 7 the council shall ensure that all service area boards of the State are represented.
- 8 Gordon M. Durant, family representative, is being recommended to continue his tenure on the
- 9 SCMH as the O'ahu Service Area Board on Mental Health and Substance Abuse representative. A
- lifelong resident of Hawai'i, Mr. Durant attended Punahou School and the University of Hawai'i. He
- held management positions at Jorgensen Steel until his retirement in 1994. He also served as the
- director and treasurer of Malama o Manoa from 1998 to 2004 and the Hawai'i Historic Association from
- 2003 to 2007. Mr. Durant's interest in the field of mental health was prompted by his son being
- diagnosed in 1996 with serious and persistent mental illness. This led him to join the National Alliance
- for Mental Illness (NAMI) in 2000, where he served for eight years as its president. Since that time,

- both Mr. Durant and his wife have continued to be actively involved with NAMI's Journey of Hope,
- 2 providing education and support to other families.
- 3 We respectfully request your favorable consideration in confirming the appointment of Gordon
- 4 M. Durant to the SCMH.
