#### Chair Taniguchi and Committee Members:

It has been an honor to be part of Hawaii's Uniform Law Commission team, and I hope the Committee will allow me to continue with this work. Hawaii's commissioners come from diverse backgrounds and experiences, and I have the utmost respect for each of them and the work that they do. Together, I think we are able to collaboratively and efficiently work on different bills that benefit the State of Hawaii.

Two bills I recently worked on stand out as particularly satisfying and are examples of the kind of work that I hope to continue if my nomination is confirmed. The Revised Uniform Anatomical Gifts Act was passed approximately two years ago. This Act offers the prospect of helping to save lives and improve the quality of life for transplant beneficiaries.

The Uniform Prudent Management of Institutional Funds Act (UPMIFA) was drafted to address fiscal matters for charitable institutions. UPMIFA was enacted last year, and the timing could not have been better given the current fiscal situation. I like to think that it has helped charities in Hawaii stay afloat by allowing more flexibility within an acceptable fiscal range of options.

One of the most interesting aspects of work on each of these bills was working with the different communities that would be affected by passage of the bills. I met with proponents and concerned parties for each act well before the session started so that we could work through differences prior to the opening of the session. It was rewarding to see the support for each bill.

Thank you for your consideration of my nomination.

Chair Taniguchi and Members of the Committee:

The Attorney General supports the reappointment of Elizabeth Kent to the Commission to Promote Uniform Legislation ("Commission") of the Department of the Attorney General.

The Commission is advisory to the Attorney General and to the Legislature on matters pertaining to uniform legislation. Members of the state Commission are Hawaii's representatives to the National Conference of Commissioners on Uniform State Laws. The National Conference requires that each appointed commissioner be a lawyer licensed to practice law and that each commissioner personally attend and participate in its annual meeting.

Commissioner Kent is a lawyer licensed to practice law in She has served as the Deputy Director of Human Services in the Executive Branch and is currently the Director of the Center for Alternative Dispute Resolution in the Judiciary. Commissioner Kent is committed to promoting uniform legislation and has actively participated in the meetings of the Commission and of the National Conference. Since her last appointment in

2006, Commissioner Kent helped plan the forum "What Mediation Users Have to Say About Mediation and What Mediators Should Do About it" sponsored by the University of Hawaii Program for Conflict Resolution and the Mediation Center of the Pacific, Inc. She has also spent a significant amount of time working with parties who may be interested in various uniform laws, such as the Revised Uniform Anatomical Gifts Act enacted in Hawaii in 2008 and the Uniform Prudent Management of Institutional Funds Act enacted in Hawaii in 2009.

Commissioner Kent has served as a member of the National Conference's Drafting Committee on a Uniform Collaborative Law Act and attended drafting committee meetings on April 20-21, 2007, in Salt Lake City, Utah, on October 5-6, 2007, in Boise, Idaho, on January 19-20, 2008, in Chicago, Illinois, and on November 22-23, 2008, in Portland, Oregon. During the National Conference's annual meeting held in July 2009 in Santa Fe, New Mexico, Commissioner Kent participated in presentations of the Uniform Collaborative Law Act by the drafting committee on Thursday, July 9, on Saturday, July 11, and on Sunday, July 12, as well as in meetings of the drafting committee held during the annual meeting. Because the Governor did not approve the expenditure of state funds for Hawaii commissioners to attend the annual meeting, due to our State's poor fiscal condition, Commissioner Kent attended the National Conference's annual meeting at her own expense.

In view of her demonstrated commitment to the promotion of uniform legislation and her continuing participation in the activities of the National Conference and of the Commission, Elizabeth Kent's continued service as a member of the Commission and of the National Conference will be beneficial to the State of Hawaii and the National Conference. Consequently, the

It gives me great pleasure to submit this testimony in support of the nomination of ELIZABETH KENT to serve another term on Hawaii's Commission to Promote Uniform Legislation ("CPUL").

All of the commissioners on the CPUL serve as commissioners to the Uniform Law Commission ("ULC"), also known as the National Conference of Commissioners on Uniform State Laws, which is a body of attorneys from all States who spend countless hours, without pay, to develop proposed laws to be enacted in all States. ULC's goal is to provide uniformity in the laws among the States without sacrificing control to the federal government. The best known products of ULC include the Uniform Commercial Code, the Uniform Probate Code, the Uniform Transfers to Minors Act and the Uniform Partnership Act, all of which have been adopted in Hawaii; these and other uniform laws affect the lives of residents of Hawaii and other States every single day.

A commissioner's duties are two-fold: First, the commissioner needs to participate in the drafting of uniform laws, including the careful review and consideration of their provisions on a line-by-line, and sometimes, word-by-word, basis. Secondly, the commissioner needs to work with the legislature of his or her State to get uniform laws enacted.

As a fellow commissioner on the CPUL, I have observed firsthand how well Elizabeth has fulfilled those duties. She studiously reviews the drafts of the various acts that are considered at the annual summer meetings of ULC and raises excellent questions

and suggestions for the drafting committees during the floor sessions. She is well known among the ULC commissioners for her thoughtful and helpful comments.

Elizabeth has also been appointed by the Executive Committee of ULC to serve on several drafting committees, including the committees which worked on the Uniform Mediation Act and the Uniform Collaborative Law Act. Members of a drafting committee attend additional meetings during the year to discuss and draft new acts for presentation to all the commissioners at the annual summer meetings.

Elizabeth has been a key member of CPUL for contacting groups and individuals who may be interested in new uniform acts in order to get their input, not only during the drafting process, but also prior to CPUL's decision to ask for the introduction of a uniform act in the Hawaii Legislature. She always makes herself available to provide background information to those interested parties. In addition, Elizabeth has prepared testimony in support of uniform acts and taken time off from her regular job in order to testify at hearings.

I have no reservation in supporting the nomination of Elizabeth Kent for an additional term on the CPUL. Elizabeth has been and will continue to be an outstanding commissioner on the CPUL and an outstanding representative of Hawaii to the ULC. I urge you to recommend that the Senate confirm her nomination.
