In consideration of GOVERNOR'S MESSAGE 232- SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE ISLAND BURIAL COUNCIL, ISLAND OF OAHU, GUBERNATORIAL NOMINEE, JOHN S. K. HOAG ESQ., FOR A TERM TO EXPIRE 6-30-2013

The Department of Land and Natural Resources (Department) strongly supports the gubernatorial appointment of John S.K. Hoag, Esq. to the O'ahu Island Burial Council for a term to expire 6-30-2013.

The Island Burial Councils were established under Section 6E-43.5, Hawai'i Revised Statues, to determine the preservation in place or relocation of previously identified native Hawaiian burial sites and to determine Hawaiian cultural and lineal descendent claims for specific burials.

State law requires that Island Burial Councils be established for Hawai'i, Maui/Lanai, Molokai, Oahu and Kaua'i/Ni'ihau islands, and be comprised of representatives from specific geographic regions and representatives of developer/large property owners. Mr. Hoag will serve as one of the three landowner-developer representatives on the O'ahu Island Burial Council. The Department notes that Mr. Hoag is currently serving as an interim burial council member on the O'ahu Island Burial Council.

Mr. Hoag is employed by Hawaii Reserves Incorporated as the Director of Administration and Assistant to the President. He is a member of good standing in his community and active in professional and community-based organizations. Further, Mr. Hoag brings a professional legal insight and understanding to the burial council's process and follows in the footsteps of the former Chair, Mr. Jace McQuivey who recommended him for this seat.
