I am submitting this testimony in strong support of the nomination of Lisa M. Ginoza to the Intermediate Court of Appeals. Over the past three years I have worked very closely with Ms. Ginoza In my former position as the Executive Director of the Office of Youth Services and found her to be a strong and supportive ally.

Since 2006, the Hawaii Youth Correctional Facility (HYCF) has been operating under a Memorandum of Agreement (MOA) with the US Department of Justice (DOJ) concerning conditions of confinement. After being in an adversarial position prior to the signing of the MOA, Ms Ginoza forged a collaborative relationship with DOJ attorneys based on mutual trust while not abandoning her responsibility to represent the State's interests. Potential conflicts were identified as they emerged and immediately dealt with before they became impediments to achieving compliance with the MOA provisions. This relationship was certainly tested at times, but with Ms. Ginoza seemed to always resolve any disputes in a fair and cooperative manner.

Working towards compliance with the MOA involved many State agencies beyond OYS, such as the Departments of Human Resource Development, Budge and Finance, and Accounting and General Services. She would make herself available to accompany me in meetings with leadership as we asked for their cooperation and assistance in addressing the myriad of bureaucratic problems that would sometimes impede progress at HYCF, identifying solutions that were acceptable to all.

Such solutions would not be feasible without the legal knowledge, understanding and diligence she exhibited in her actions on OYS's behalf. Clearly, Ms. Ginoza was well acquainted with the constitutional issues that resulted in the DOJ lawsuit and represented the State of Hawaii well. But what struck me was her ability to grasp how those issues impacted the daily operations of the HYCF and understanding what was required by all involved to resolve them. Well respected by facility staff, she aptly conveved how complying with the terms of the MOA would not only benefit the

incarcerated youth but also improve working conditions. This tact helped win over staff and garner their willingness to be part of the solution, not the problem.

Perhaps her best attribute is Ms. Ginoza's even temper and ability to maintain calm under tremendous pressure. She listens carefully to what is being said, logically and intelligently presents the State's position and works towards an outcome that satisfies all involved. Solutions are realistic and achievable, addressing the needs of both parties.

I cannot express what Ms. Ginoza's support has meant to me personally. I am, though, confident that she is the best candidate for the position of Associate Judge with the Intermediate Court of Appeals.
