Chair Taniguchi and members of the Senate Judiciary and Government Operations Committee, I am Debbie Shimizu, Executive Director of the National Association of Social Workers, Hawaii Chapter. I am testifying in strong support of GM 243, Consideration and Confirmation of Aaron Fujioka as Administrator of the State Procurement Office.

In the past, procurement for health and human services was done on a random basis and occasionally through state grants. During the Reagan-Bush administration and the passage of the Ominbus Budget Reconciliation Act of 1980, states were forced to develop procurement procedures to deal with block grants from the Federal government. In 1982, the Hawaii state Legislature established HRS Chapter 42 to create a system that would legitimize agencies who received state contracts.

I have worked with Mr. Fujioka since 1993 when he was active with the Advisory Council for Chapter 42D. The Advisory Council was an appointed group of Executive Directors from the health and human service agencies who received purchase of service contracts from the state and advised the state departments on issues regarding the purchase of service process. With his social work background, Mr. Fujioka was knowledgeable about the health and human services sector as well as the state Chapter 42D contracting process. He was an excellent liaison between the state and the non-profit executive directors.

In 1998 HRS 103F established a separate statute to govern the Purchases of Health and Human Services. The Advisory Council became the Community Council on Health and Human Services. Mr. Fujioka was hired in the Procurement Office to implement HRS 103F and to staff the Community Council on Health and Human Services. Again, his experience and knowledge in the process of purchasing health and human services was invaluable. Mr. Fujioka is well organized and is able to address all aspects of an issue fairly. He was able to work well with all members of the Community Council as well as with Department Directors, fiscal officers, the private sector.

Thank you for the privilege of providing testimony in strong support of the confirmation of Aaron Fujioka as the administrator of the State Procurement Office.

Over the past 20 years, my experience of Aaron Fujioka has been one of integrity, honesty, a desire to serve and genuine caring. At the Office of Community Services, he went far beyond his duties providing leadership and assistance to fellow state procurement personnel in developing a fair, open, clear and consistent process for procuring health and human services. When HRS Chapter 103F, became law, Aaron joined the State Procurement Office and developed administrative rules that made sense in an all inclusive process, later written up in the ABA Administrative Law Review as a model for consensus-seeking rulemaking. He also embraced the use of the web and facilitated the creation of a central site for health and human service solicitation and award information. Lastly, even with the lack of resources, Aaron has moved eProcurement forward by assessing feasibility and taking measured steps.

As a member of the Procurement Policy Board from 2000-2008, Chairman from 2005-2008, and the Central Purchasing Agent for the County of Maui since 1995, I have worked with Aaron for years. Following are several reasons why I strongly believe that Aaron should be confirmed to another term:

He has maintained his independence - Aaron has been nominated and confirmed by both major political parties, and yet he has maintained his independence which is critical to the effective administration of the procurement law. This independence is evidenced by his decisions, and by his testimony on bills, which often differ from opinions or testimony from the administration that he is attached to.

My name is Ruth Yamaguchi, and I have been the Assistant Administrator of the State Procurement Office (SPO) since 2004. I've been with the State Procurement Office since its inception in 1994 as a Purchasing Specialist and Purchasing Analyst; and even prior to the SPO being established, when the office was the Purchasing and Supply Division under DAGS.
