SUBJECT: GM 259- State Council on Developmental Disabilities Gubernatorial Nominee Joshua Smalley-Bower

The State Council on Developmental Disabilities (DD) **STRONGLY SUPPORTS GM 259** to confirm the nomination of Joshua Smalley-Bower for a term to expire June 30, 2012.

The Council's Federal mandate (P.L.106-402) is clear in determining the composition of this body to ensure that all the players involved in the development, implementation, and use of DD supports are represented. The law specifically requires that 60 percent of the membership of the Council be comprised of individuals with DD, their parents, or family members. Additionally, the following agencies are required to be on the Council: Department of Health; the agencies that administer funds provided under the Rehabilitation Act of 1973; the Individuals with Disabilities Education Act; the Older Americans Act of 1965; Titles V and XIX of the Social Security Act; the Protection and Advocacy Agency; the Centers for Excellence in DD Education, Research, and Service; agencies and private non-profit organizations concerned with services to individuals with DD. The Governor's nominee meets all the Federal requirements for Council membership.

Mr. Smalley-Bower is a young man with DD who lives at home with his parents. He was appointed by Governor Lingle on October 30, 2009, on an interim basis. As a person with medically fragile conditions, he knows the importance of accessible comprehensive medical care for persons with DD. His experience in receiving personal care through the Medicaid Home and Community Based Waiver program would contribute to the Council's advocacy efforts to assure that the program provides an

array of services to support individuals with DD to live in the community in a flexible and individualized manner.

He is a member of the Council's Community Supports Committee that addresses the Waiver program; affordable, and equitable transportation options; and staffing, financial, and technological supports to live in the community. Mr. Smalley-Bower is also a member of the Self-Advocacy Advisory Council who is working on establishing a statewide self-advocacy network that includes and governed by individuals with DD. He is a true self-advocate who articulates his desires and exercises his rights and self-determination.

Mr. Smalley-Bower is a remarkable young man who maintains a positive attitude despite his daily health challenges. He is a mentor for others to live life to the fullest.

The Council would greatly benefit from Mr. Smalley-Bower's experience and perspective in carrying out its mission, "... to support people with developmental disabilities to control their own destiny and determine the quality of life they desire."
