

I was born in Kailua-Kona, graduated from Kailua High School and the University of Hawai'i, majoring in Political Science-International Relations and earned an Army commission through the UHROTC program. I also earned my private pilot license through the ROTC program. My military service, of 26 years, primarily involved aviation assignments requiring operational, intelligence, counter-terrorism and operational research/systems analyst skills. Since my retirement and return to Hawai'i, I've been involved in aviation management, an aviation consultant and a director of aviation flight and aircraft mechanic training. My aviation experience will compliment the current COT expertise.

Commerce traveling though the state transportation nodes is the essential life blood of Hawai'i and must remain efficient and effective. My name is Owen Miyamoto and I am a member of the Commission on Transportation and a registered civil engineer in the State of Hawaii.

Ralph Hiatt has been on an interim appointment to fill a vacancy for the Oahu representative and GM 269 will confirm his appointment to serve for the remainder of the fiscal year ending June 30, 2010. GM 270 will confirm his appointment for a full three-year term to end June 30, 2014

I have personally known Ralph Hiatt ever since he was an analyst for the Honolulu office of ARINC, the communications provider for airlines. When he was appointed as Director, Pacific Aerospace Training Center for Honolulu Community College, I was lecturer with the faculty for the Center.
