Thank you for your letter of February 24, 2010, regarding the scheduling of the public hearing on my nomination to the Hawaii Teacher Standards Board. As requested, responses are provided to the following questions that you posed to me:

- (a) Why do you wish to be a member of the Hawaii Teacher Standards Board?
 Response: As my nomination is for a public position on the Board, I hope to share my professional experience and expertise as it similarly relates to regulating and licensing of a profession. From a personal perspective, I have been a public servant for almost the entire extent of my adult life and I wish to continue giving back in whatever ways that I can if in some small way it can make a difference.
- (b) How do you perceive the role and responsibilities of a member of the Hawaii Teacher Standards Board?

Response: The simple answer is to fulfill the mandates in the law relating to regulating and licensing teachers. The how to's to get there involve clearly understanding its regulatory mission, to make sound decisions towards that end, to know that the licensing program is being carried out correctly, consistently, effectively, and efficiently and to take correct action when it is not, and to communicate with its constituency and other affected stakeholders to improve the regulation and licensing of teachers.

(c) Given your understanding of the role and responsibilities of a member of the Hawaii Teacher Standards Board, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Hawaii Teacher Standards Board.

Response: Through my prior employment, I have had the pleasure of working cooperatively with regulatory licensing boards and commissions by being part of the support agency to ensure they were able to do their job and do it well. This required knowing what is expected of a board, providing them the tools to do their job, ensuring they made informed decisions and carried out their regulatory mission. While not members of the boards, we clearly had an appreciation for the entire regulatory process and how collectively we all had to do our part to make things function.

(d) Name three qualities that best describe you and that would you make you stand out. How would these qualities benefit the Hawaii Teacher Standards Board?

Response: Big picture/detailed oriented, can be counted on to facilitate and problem solve, diplomatic (and firm when needed)

(e) Can you foresee any possible conflicts of interests that could arise during your service on the Hawaii Teacher Standards Board? How would you overcome any possible conflicts of interest?

Noe Noe Tom

Response: I do not foresee any possible conflicts. However, if any might arise in the future, I will certainly remove myself from the situation to ensure there is no appearance of impropriety or violation of the State Ethics Law.

(f) What are three ways the Hawaii Teacher Standards Board should/must help meet the education needs in Hawaii?

Response: The HTSB is one component to addressing the education needs of Hawaii. For its part, it should (1) do its job and do it well, (2) match expectations with resources, and (3) improve communications (in print/web site, networking and outreach). I also believe the HTSB is an important aspect to the RTTT application and we should do our part.

(g) What goals should the Hawaii Teacher Standards Board set and how would you propose to measure them?

Response: In light of the Auditor's 2009 report and the Legislative Reference Bureau 2010 report, numerous goals have been identified to improve its regulatory charge and operations. Essentially like an action plan, it's delivering on the goals that the Board supports, that will be its measure of success.

(h) In your limited time with the Hawaii Teacher Standards Board, what do you see as the Hawaii Teacher Standards Board most pressing issues and what are your thoughts about how they can be resolved?

Response: Incorporate IT into its operational processes, review renewal standards and implement renewal of licenses, staffing the Board's office with sufficient resources to do the job needed, improve operational efficiency, and review initial licensing standards. The Board is already focusing its efforts in these areas as we have contracted with the State's internet portal vendor (HIC) for IT services that will benefit processing, have reviewed other states renewal standards and implementation processes (with a focus on the RTTT states) to improve our renewal process and will be rolling out the renewal process and ensuring adequate communication with licensees so they are informed and understand the process, we are very supportive of filling vacant positions in the HTSB Office and will be seeking the necessary approvals to fill, we will be executing operational improvements and continue to look for other ways for the HTSB to be more functional, user friendly, and streamlined including continuing to improve communications with the DOE for partnerships to avoid duplicity, and we will be undertaking a review of other states licensing standards and implementation processes. It's been a process where everyone has contributed to solutions.

(i) The Hawaii Teacher Standards Board has rapidly undertaken major changes in the past year precipitated by a scathing auditor's report. How should HTSB function differently than it did in the past to avoid the creation of the situation that led to the audit?

Response: I can only speak to what I've experienced since my recent interim appointment to the Board, from which I've worked with committed board members and an interim Executive Director who are very accountable and where business as usual is not acceptable.
