Dear Senator Sakamoto:

In response to your letter of February 24, 2010 the following answers are related to your list of requested information:

- (1) Resume and references attached
- (2) Questions
 - (a) I would like to be a member of the Hawaii Public Housing Authority (HPHA) board because it will afford me the opportunity to serve the State of Hawaii in an area of continuing concern. The situation for our citizens who need assistance to live in decent housing conditions will be a continuing challenge, and I hope to be able to assist this group by participating on the HPHA board.
 - (b) I perceive my responsibilities as a HPHA board member to include regular attendance at Board meetings; review of all documents and material sent from the HPHA office; periodic visits to the various public housing facilities; as requested, review financial matters as a member of the financial task force; interface with other Board members to help develop good HPHA policies and procedures; respond to the individual needs of the tenants whenever appropriate.
 - (c) I have been a member of the Hawaii business community for over 35 years, and some of the knowledge I have gained of Hawaii during this time can be applied to the functions and responsibilities of the Board. I was a member of the Hawaii Health Systems Corporation Board and I am a member of the Oahu Workforce Investment Board, so I have gained some knowledge of the working of our government systems. My areas of expertise are in fiscal responsibility including budgeting, cost control, capital expenditures, over sight of daily operations and development of a responsible team concept.

- (d) I would stand out as a HPHA board member because I take my Board responsibilities seriously; I have high ethics standards; I am a good team player. These three traits will lead to my contributing to the HPHA Board functions and benefit the HPHA because any responsibility I take on leads me to make a maximum effort to help develop Board goals, execute effectively the Board plans and use my vision of the future to help guide the overall functions of the Authority.
- (e) I do not see any possible conflicts because I am only doing consulting in the grocery industry at this time. If a conflict would arise I would discuss the matter with Chairman Travis Thompson and not vote on any item related to the conflict.
- (f) HPHA needs to revise and improve the plan to keep more housing units in livable shape and occupied. A plan should be developed for greater involvement of the tenants in all aspects of maintaining the facilities and improving general living conditions. A new or better plan should be developed to help tenants improve their personal situation so they can leave public housing. Please keep in mind that I have been involved in HPHA for less than two months, so my scope of knowledge to answer this question is limited.
- (g) One goal should be to develop a plan to narrow the HPHA losses and make progress to ultimately get the HPHA to a breakeven position. Line by line analysis of expenses and revenues will lead to ideas to stimulate changes that will decrease expenses and increase revenues.
- (h) Staffing of the accounting department management is one challenge for HPHA. This will lead to timely and accurate accounting reports. This should be one of the first initiatives for the new Executive Director, and with the proper staff she can make better and timely decisions. Increased occupancy through the reduction of units that cannot be occupied due to repairs is another challenge. Tenant involvement to help maintain occupied units and preventative maintenance programs will help keep units from falling into being closed for new occupancy. A third challenge is to complete the Michaels' development package for Kuhio Park Terrace and Kuhio Homes. This will require close coordination and communication between the Executive Director, the Board and Michaels.
- (i) Due to my very short tenure with the HPHA Board I have limited knowledge about SB 2276, 2277, 2278. It is my understanding that the Board looks favorably at these three measures in their current form.
