### RESPONSE TO THE QUESTIONS PRESENTED BY THE SENATE COMMITTEE ON PUBLIC SAFETY and MILITARY AFFAIRS

#### JAMES D. LACLAIR

Why do you wish to be a member of the Wireless Enhanced 911 Board?

I am keenly interested in serving on the Wireless Enhanced E911 Board because feel I have much to offer, not only in the way of experience, knowledge and skills, but also enthusiasm. I have been very fortunate throughout my career to experience first hand the incredible developments, capabilities and applications technology brings into people's lives. I have been an active participant in the Wireless enhanced E911 board meetings for nearly two years as a visitor, interim Board member and a confirmed Board member.

I would like to apply this experience through the Wireless Enhanced 911

Board to improve public safety by advising the Board in matters of technology

and communications to enhance the tools and capabilities available to

emergency services agencies.

As a senior technology executive at Hawaiian Telcom and formerly Verizon, I would like to make the most of my 30 years of industry experience, including 16 years of E911 responsibilities, by being an active member of the Wireless Enhanced 911 Board.

How do you perceive the role and responsibility of a member of the Wireless Enhanced 911 Board?

I perceive the role of the Wireless Enhanced 911 Board to be one that provides direction and guidance to the various entities responsible for maintaining, using, and improving Wireless Enhanced 911 with the ongoing goal to improve public safety. The role of the Board is to provide a balanced view on issues and to foster open discussion to insure the actions and directions of the Board are responsible, prudent, and in the best interest of the community and the State of Hawaii.

Given your understanding of the role and responsibilities of a member of the Wireless Enhanced 911 Board, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Wireless Enhanced 911 Board.

As a senior technology executive at Hawaiian Telcom, I have 30 years of experience in telecommunications including voice and data networking, wireless operations and management, 16 years of experience operating 911 networks in Hawaii, and deploying and operating new technologies such as Voice over Internet Protocol (VoIP) networks. In addition to the 16 years of experience operating E911 networks in Hawaii, I have 5 years experience operating E911 networks in the States of Oregon and Washington.

I have been actively involved in the Wireless Enhanced E911 Board as a visitor and interim Board member since June 2008 and during this time I have provided guidance, recommendations, and insight for complex technology issues

at Board meetings, sub-committee meetings and in one-on-one with the police departments.

#### What do you hope to accomplish during your term of service?

My role at Hawaiian Telcom has been solution orientated. We regularly work with technology to develop cost effective telecommunication solutions. I would convey this "solution" based approach as part of my Board involvement.

During my term of service I would plan to accomplish the near term advancement of the Board's goals to improve the quality, performance and accuracy of Enhanced Wireless 911 capabilities. Location based services for wireless, such as GPS and triangulation, are very complex with many variables that create opportunities for improvement. The near term goal is the continuous improvement of location services. In addition I would like the Board to develop a long term technology roadmap to insure the State of Hawaii's public safety agencies have the tools necessary to accomplish their mission into the future.

Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Wireless Enhanced 911 Board?

My three qualities that best describe me would be that I'm an involved and engaged individual, I manage by facts and not comments and hearsay, and I am a problem solver – a person that searches for solutions to address problems.

These qualities will benefit the Wireless Enhanced 911 Board by insuring I clearly diagnose, understand and communicate the challenges facing the Board

and that I inform and brief the Board on our options and technology solutions to advance the capabilities of Wireless Enhanced 911. Lastly, I have been engaged and involved with Wireless Enhanced 911 work not only at the Board meetings but also in between actively meeting or corresponding with the police departments and other entities (following appropriate Sunshine laws) to insure timely progress.

# Name one previous experience that would make you stand out. How would this benefit the Wireless Enhanced 911 Board?

In 2005 I was fortunate enough for the Senate to approve my nomination to the High Technology Development Corporation (HTDC) Board of Directors. As an active Board member I assisted HTDC in achieving their MAIM scores which is a Federal measure to determine the effectiveness of the Manufacturing Extension Program (MEP). HTDC's MEP program was on probation for not meeting these objectives. With full cooperation and support from the Executive Director, I worked directly with the operations manager to develop and implement a plan to meet and maintain their MAIM scores. HTDC has successfully meet MAIM objectives for the last two-plus years.

I will use my business and operations experience along with my knowledge of technology and telecommunications to advise and assist the Wireless Enhanced 911 Board and emergency service agencies to improve their use of technology and any associated business process that may be involved.

Can you foresee any possible conflicts of interests that could arise during your service on the Wireless Enhanced 911 Board? How would you overcome any possible conflicts of interest?

Since Hawaiian Telcom does provide services for wireless E911, a conflict of interest does exist. Current statute for the Wireless Enhanced 911 Board requires one seat for the incumbent wire-line E911 provider which is Hawaiian Telcom. Hawaiian Telcom also provides call completion services for wireless callers reaching the E911 PSAPs across all counties.

This potential conflict of interest is managed by full disclosure that I am a Hawaiian Telcom employee publicly, to all Wireless Enhanced 911 Board members and associated parties. Even though Hawaiian Telcom does not directly apply for Wireless Enhanced 911 funds, I will abstain from voting, or if necessary recuse myself, on any Board resolution that may directly or indirectly benefit Hawaiian Telcom.
