The State Council on Developmental Disabilities (DD) **STRONGLY SUPPORTS GM 349** to confirm the nomination of Barbara A. loli for a terrm to expire June 30, 2014.

The Council's Federal mandate (P.L.106-402) is clear in determining the composition of this body to ensure that all the players involved in the development, implementation, and use of DD supports are represented. The Governor's nominee meets all the Federal requirements for Council membership.

Ms. Ioli's appointment would fulfill the Federal law requirement of having parents represented on the Council. She is a mother, grandmother, and caregiver for her son and grandson with special needs. She is an active member of the Leeward Community Children's Council, Special Education Advisory Council, Special Olympics Hawaii, Hawaii Association of Parents of the Visually Impaired, and Hawaii Down's Syndrome Congress. Her advocacy in the community has benefited other families, and she was recognized as Parent of the Year a few years ago by the Special Parent Information Network at their Annual Conference.
