To Senator Hee:

I am grateful for the opportunity to provide additional information regarding my interest in serving on the Board of Directors of the Agribusiness Development Corporation (ADC). With regard to the seven questions that were given to me, I have answered them below:

1) Why do you wish to be a member of the Board of Directors of the ADC?

I wish to serve on the Agribusiness Development Corporation's Board because I feel that I will bring a new perspective to the existing council. While I certainly appreciate the views of others, I feel that my knowledge of current best practices in promotion, marketing, ag project coordination, and other related fields will allow me to share such information in the best interest of the subject at hand. I am aware that ADC manages thousands of acres of state-owned ag land and water systems on Kauai. The success of ADC and various private landowners' projects will help to shape agriculture on Kauai and set models for other projects around the state. I feel that it is important to hear all sides of the issue in a respectful manner and I feel that I can help contribute to furthering this goal.

2) How do you perceive the role and responsibilities of a member of the Board of Directors of the ADC?

I support ADC's role in protecting the future of agriculture and I understand the need to transition former plantation lands and water systems to diversified long-term agricultural use. I believe that a very important duty of being an ADC Director is trying to find innovative solutions for some of the challenges facing local agriculture. I also believe that fostering the growth of agricultural enterprises across the state is of utmost importance.

3) Given your understanding of the role and responsibilities of a member of the Board of Directors of the ADC, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Board of Directors of the ADC.

I received my Bachelor's degree in Business Administration and Master of Business Administration – International Business from Hawaii Pacific University of Hawaii. I also graduated in the inaugural class of Leadership Kauai in 2005.

I have nine years of experience from my time spent accumulating knowledge within the banking industry and non-profit sector and I have spent the last five years utilizing my promotion, marketing and management skills while at Grove Farm Company, Inc.

Grove Farm has undertaken a number of agricultural projects, ranging from our Ecological Restoration Project at Iliahi to our Nene Habitat and I have coordinated and managed both projects for the Company. We are in the midst of embarking on a Maile Restoration initiative as well. Grove Farm understands the important of active agriculture and is also working on a plan for an Agricultural Park in Mahaulepu Valley in an effort to reduce reliance on imported foods and to grow what Kauai eats. I feel that my skill and expertise make me a qualified candidate for the ADC Board.

4) What do you hope to accomplish during your term of service?

As Grove Farm's Vice President, I am responsible for the Company's philanthropy and charitable giving as well as for overseeing community outreach initiatives. As Grove Farm's liaison between community organizations and other businesses, I have been able to expand and maximize positive exposure for Grove Farm and our partner organizations within the non-profit sector and throughout the general community. I would hope to be able to accomplish similar results for the agricultural sector during my term of service.

If selected to serve, I will do my best to fulfill my responsibilities as an ADC Director and I will welcome the opportunity to better serve Hawaii's agricultural community.

5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Board of Directors of the ADC?

I believe that three qualities that best describe me are: 1) diplomatic, 2) fair, and 3) works well with others. I pride myself on my ability to view both sides of an issue and believe that this will benefit the ADC Board.

6) Name one previous experience that would make you stand out. How would this benefit the Board of Directors of the ADC?

I firmly believe in the strength of community service and I feel strongly that my experience will benefit and strengthen the Board of Directors of the ADC. During my years of service on a number of non-profit boards, I have learned the importance of fostering and strengthening partnerships across business and industry sectors.

Grove Farm is interested in finding viable ways to promote local agriculture and to make agricultural operations successful. While I do not foresee any possible conflicts of interest as Grove Farm's management team's view of agriculture is similar to those of the ADC, if any instance of a possible conflict of interest should arise, I would recuse myself from the issue.

While I have not had the pleasure of working on a similar focused commission in the past, I am confident that my experience towards learning new skills and my ability to keep things in perspective will allow me to quickly engross myself with the commission's current challenges.
