I, Leslie P. Milnes, a rancher, fellow Kaua'i County Farm Bureau member and sitting board member of the East Kaua'i Water Users Cooperative humbly provide testimony in support of appointment of Jerry L. Ornellas to the Board of Agriculture.

My experience with Jerry L. Ornellas, most recently, involves his serving as President of the East Kauai Water User's Cooperative, Viçe President of the Kauai County Farm Bureau and as Chair of the Mayor's Agricultural Advisory Committee.

In 2001, the exodus of Lihue Plantation from sugar production, leading to the loss of oversight management of the East Kaua'i Irrigation System, a State owned water delivery system serving east Kaua'i agricultural lands from Hanamā'ulu to Kapahi, brought forth an urgent call from the Kaua'i County Farm Bureau for community members to step forth to find consensus whether to abandon or carry on this jewel of an infrastructure to agriculture.

Jerry, along with twenty of the eighty plus community members present forged ahead to form a committee, consequently the current East Kauai Water User's Cooperative. Jerry' leadership heading this committee gave fruit, after sixteen months of weekly meetings, to an application for a Revocable Permit from the Department of Land and Natural Resources, Land Division, for EKWUC to take responsibility and management of the East Kaua'i water system. To date, Jerry continues in the capacity as President and continually champions the maintenance and improvement of the East Kaua'i water system.

As a Farm Bureau officer, Jerry has worked on a wide variety of policy issues concerning the needs, challenges and opportunities faced by farmers and ranchers on Kauai and I have seen him exude a personal dedication to preserve agricultural lands and water systems. He continues to look for opportunities to help and improve the situation of farmers here on Kaua'i and statewide.
