Please find my answers to the Center for Nursing Advisory Board statements below and my current CV attached as you requested.

1. What skill, qualifications, and experiences do you have that will be an asset to the nursing advisory board?

I have been a nurse for over 45 years. As a nurse, I have been a public health nurse, an educator, a staff nurse, a manager, and a nurse practitioner. I am acutely aware of the issues in health care that affect all areas of nursing and health care management and education. I am currently serving on the Center for Nursing Board and would be honored to continue to assist in transforming nursing in the State of Hawai'i.

2. What are the main challenges facing nursing as a profession in Hawaii, and what strategies and recommendations do you have for improving recruitment and retention of nurses in the state?

As an educator in the largest nursing program in the State of Hawai`i, I see the recruitment of qualified men and women into the nursing profession, educating them, and transitioning them into nursing jobs as a top priority. The strategy that would be most helpful is creating internships in the local hospitals and health care institutions (Primary Health Care Centers and Nursing Homes and Care facilities) throughout their education that will translate into professional registered nurse jobs upon completion of their education.

3. What short and long term goals do you have for the board?

My short term goal is to assist in developing educational strategies that will ensure registered nurses jobs at the completion of their basic education. My long term goal is to assist registered nurses to become life-long learners and to pursue advanced practice nursing careers in practice and as educators of future nurses.

4. During these difficult economic times, what challenges will nursing face, and what recommendations do you have for overcoming these obstacles?

Health care under the new National Health Care legislation will require nurses to practice at their best through interdisciplinary teams and coordinated health care systems and patient awareness to ensure best practice outcomes. Nurses at the administrative level, at the bedside and in the community will need to understand, participate in and be a team member in ensuring a seamless transition from community to hospital and returning to the community (home) for the best possible health outcomes. Understanding and participating is this new paradigm will take education, understanding and cooperation. As a board member for the Center for Nursing and educator, I can assist in making this initiative a smoother transition.
