Re: GM 427 Nominee to the Board of Land and Natural Resources Reponses by Robert J. Pacheco to questions posed by Senator Clayton Hee in preparation for the confirmation hearing GM427.

(1) What do you see as the top three problems that must be resolved by the Land Board? How would you recommend that the Land Board address these problems?

There are many seemingly intractable problems facing the Department. The breadth of responsibility charged to the Department is enormous and diverse. In several instances the Department has conflicting mandates. The biggest problems I believe facing the Department are not resolvable by the Land Board alone. However, to address your question, I believe that three issues deserve the upmost attention and effort. First, I think the Department's greatest challenge is the continued degradation and loss of native ecosystems and species. The native communities of our islands are our most valuable resources and by far the most threatened. Second, the overall poor condition and maintenance of the State's recreational infrastructure such as boating facilities, parks, and trails is really unacceptable. Hawaii nei and the residents of Hawaii deserve world-class facilities. And finally, I would say the management and stewardship of our cultural resources and historic properties really need continued attention. This is especially pressing with the recent notice by the NPS over Hawaii's deficiency with NHPA compliance.

Honestly, I don't have any brilliant solutions to these problems. More funding...yes, it's desperately needed. Could the Department be more efficient, better managed, more effective? Certainly. But how do I as a Land Board member deal with issues of funding priorities, departmental inefficiencies that deal with, in some cases, long-standing personnel issues, and competing values, each valid, over uses of our limited resources. These are very challenging problems. As a Land Board member most of our input into the Department deals with making specific decisions concerning matters brought by staff to be acted upon. One of the frustrations I have as a Board member is the limited amount of time to focus on more long-term problems faced by the Department. One thing I think would be helpful is that the Land Board needs to schedule discussion time during meetings that are not related to decision making agenda items so that there can be more open and free-wheeling discussion about departmental issues. These types of discussions could be focused around issues where board policy could direct departmental change. For example, the Department has the conflicting mandates concerning the protection of native ecosystems and species and the mandate to promote game mammal hunting. I think open Board discussions on issues like this could help develop policy that would help the Department deal more effectively with this inherent conflict.

Also, another way I think the Board could help move issues forward is to create two person teams made up of Board members that attend specific staff meetings concerning

long-standing problems and other identified issues to bring Board perspective to planning and strategy and also to educate Board members in-depth on these issues.

(2) How would you improve the coordination between the Department, the Department of Agriculture, the Department of Health, and the Department of Transportation with regard to the control and elimination of invasive species?

I believe that Invasive Species are a top-tier threat to the health of Hawaii's ecosystems, economy, and quality of life. I believe the battle against IS should be a fundamental strategic and budgetary priority for the Administration and Legislature. In order for this battle to be successful, coordination of the various State Departments must happen at the highest level. I would create a cabinet level position charged with the inter-departmental mission of preventing, controlling, and eradicating IS. And I would also then charge each department to assign a Deputy Director who reports directly to the Cabinet member and this team of Deputies and Cabinet official work towards the legislative mandates concerning IS. I would also like to add that I believe, even in this time of fiscal crisis, the commitment of the government to properly fund the fight against IS is an essential and prudent investment in our future—one we cannot afford not to do.

(3) What would you recommend to make the Department more efficient? Please give three examples.

One way the Department could improve efficiency is to create more transparency, coordination and alignment of rules, permitting, and management between divisions. This is something the Department, under the current Chair's leadership, has begun to do and needs to continue in that direction. As examples, I can focus on issues at Honokohau Harbor.

Currently, there are three divisions in Kona who need water transport to fulfill their responsibilities: DAR, DOBOR, and DOCARE. Ideally, each division would have their own craft suited for their specific needs each needing either a slip or trailer and dry dock area. Currently, I believe, only DAR has a working vessel. The other divisions either don't have a vessel or they are inoperable. Why couldn't the three divisions work together and create a plan to share one or two boats? The way the department operates now, sharing vessels creates all sorts of issues such as budgeting operational and maintenance expenses. However, these divisions are part of the same family and should operate that way. It would save money for taxpayers, reduce redundancy of capital assets, open up more space at the Harbor for the public, and very likely result in a greater availability of water transport for the State workers.

Another example from Honokohau as to problems created by these separate operating silos among the Divisions is a recent item that came before the Land Board. The State has a tenant leasing acreage in the ocean for an aquaculture operation. This lease is administered by Land Division. The same tenant also has a revocable permit for fast lands for base yard needs and slip permits administered by DOBOR. The tenant for business reasons needed to reassign the lease to a new entity for appropriate and approved reasons. This is an operation that has a long-term lease with the State fulfilling legislative mandates to promote aqua-culture and food sovereignty. To operate this business they need not only the ocean lease but the slips and the fast lands. This is one

company doing business with one Department, however, because of the different Divisions with different rules, processes and personnel, the transfer was handled completely separate resulting in the need for the transfer to happen only after two separate Land Board meetings and a flurry of bureaucratic wrangling. It was a perfect example of unneeded complexity, a waste of time, and added expense to both the State and the Tenant.

My last example on creating more efficiency within the Department has to do with using the best expertise to accomplish tasks across the Department versus within a Division. Currently there are vacant lands at Honokohau that could be leased or encumbered by revocable permit. There is both a demand for these lands and a need by the State to maximize revenue, however, these lands under DOBOR management still sit vacant. DOBOR's primary function is towards boating and recreation, yet because of the fast lands and the need for facilities they also must administer leases and revocable permits for land use, but this is not their expertise. The Department has a whole Division, Land Division, who's primary charge is the administration of leases on State Lands. This Division is full of professional Land Managers proficient in the execution of land agreements. Certainly, the Department could be more efficient by allowing those who are best at the specific skills or tasks to do those jobs. Land Division should be administering all the leases and RP's for the Department regardless of what Division the land is assigned to.

(4) How much experience, as a private citizen, do you have regarding the enforcement capabilities of the Department? What would you recommend to improve on the capabilities?

I have had several interactions with DOCARE as a private citizen. In most cases, I've found the officers courteous and professional. Once, several years ago, a complaint was made against my company Hawaii Forest & Trail concerning the use of a State trail. The complaint was determined to be baseless and the responding officer was prompt and thorough in his investigation. I've also reported activity I've seen on State Conservation land. One, in recent times, there was illegal rock gathering which was promptly followed up by officers who I believed issued summons. Another, years ago, was to report an open campfire in the Mauna Kea Forest Reserve. This complaint was not acted upon, because the personnel who answered the phone said that they didn't have the staff to "get up there." That was very frustrating.

I hope that the new Civil Penalties process will facilitate the work of DOCARE officers. I also think that the Strategic Plan 2009-2014 for the Division will help it move forward and improve. I know that on Hawaii Island, the large territory each officer needs to cover is challenging. I do believe that more officers are needed on all counties. DOCARE should also have the same technological support similar to County Police Departments. I think it would be interesting to study the feasibility of some strategic partnership with the State Sheriffs Department in helping DOCARE with enforcement. The public is the best guardian of our resources. A single state-wide three-digit number that was heavily publicized (i.e. 911) to report violations would help in the public's ability to report violations and DOCARE to respond in a more timely manner.
