As the Director of Programs for Winners at Work dba Abilities Unlimited, I have had the privilege to work with Pina Lemusu. She has been a vital resource of information and support for our participants with disabilities seeking competitive employment. Abilities Unlimited (AU) provides employment and training services for clients referred by the State Department of Vocational Rehabilitation and Services for the Blind Division.
