GM459 Statement for Board of Agriculture Nomination Michelle Galimba April 3, 2010

(1) Why do you wish to be a member of the Board of Agriculture?

I would like to serve on the Board of Agriculture because I believe in the importance of nurturing smart, innovative agriculture in our state. Also I am able to offer the perspective of a young agricultural producer, as well as the perspective of a Ka'u rancher, all of which are important perspectives to include on the board.

(2) How do you perceive the role and responsibilities of a member of the Board of Agriculture? (3) Given your understanding of the role and responsibilities of a member of the Board of Agriculture, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Board of Agriculture.

I perceive the roles and responsibilities of a member of the Board of Agriculture as providing guidance and community input to the various programs of the Department of Agriculture, being a "ear to the ground" that keeps track of changing conditions and needs in the agricultural community and bringing this awareness to the board's considerations. I feel that I am qualified for the position because, in addition to my involvement in the cattle industry, I have been involved in both the papaya and coffee industries and therefore have also been exposed to the key issues for these industries. This exposure to a broad spectrum of agricultural industries, as well as my network of friends in other agricultural industries will help me to serve effectively on the Board of Agriculture.

(4) What do you hope to accomplish during your term of service?

As a member of the Board of Agriculture I would like to support increased public awareness of the critical role that agriculture plays in increasing our economic and environmental sustainability. I would also like to decrease the barriers to entry for young people who would like to work in agriculture, especially those who wish to start innovative agricultural enterprises.

(5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Board of Agriculture?

Three qualities that describe me are: pragmatist, collaborator, listener/learner. Being a pragmatist means being open to a range of ideas but always working with current conditions, so that actions are congruent with the needs of the agricultural community as much as possible. Being a collaborator, I like to maximize the potential of the entire group of which I am a part. Being a calm listener will benefit the Board of Agriculture because careful listening often leads to solutions and consensual decision-making.

(6) Name one previous experience that would make you stand out. How would this benefit the Board of Agriculture?

An experience that makes me stand out has been my family's decision to hold cattle in Hawaii for local consumption, rather than shipping them to the mainland as has been the common practice in the cattle industry for the past few decades. This has led all of us in my family to become engaged with issues of food security and the shortcomings in our current agricultural infrastructure to meet the needs of increased food self-sufficiency. In particular I have learnt a great deal about the marketing aspect of agriculture in the past few years, and how important it is to making agriculture a vital part of our future. Not just marketing my particular product, but marketing agriculture as a whole. I have been involved in everything from media campaign, creating or reviving agricultural festivals (Taste of the Hawaiian Range, the Ka'u Coffee Festival), to industry self-organization.

(7) Can you foresee any possible conflicts of interests that could arise during your service on the Board of Agriculture? How would you overcome any possible conflicts of interest?

I can foresee one potential conflict of interest. This would occur if land that our ranch currently leases from the DLNR is transferred to DOA and approval of this lease comes before the board. In this case I would abstain from discussion and decision-making on this item.
