The Office of Hawaiian Affairs (OHA) **SUPPORTS** HB1116, which seeks to establish two exempt positions, both of which are entitled Total Maximum Daily Load Coordinator.

OHA understands that the United States Environmental Protection Agency (EPA) via the State of Hawai'i Department of Health Clean Water Branch conducts monitoring, assessment, and watershed planning activities to track water quality, identify polluted waters and develop pollution control plans with the total maximum daily loads (TMDLs) program.

We see that the solo, current contracted position has been struggling to identify these water quality trends, prioritize polluted waters, and target waters for TMDL development. OHA notes that the streams in this state are suffering as a result of our lack of compliance with federal requirements in this area. The EPA has the ability to retract funding directed to Hawai'i's Department of Health through this TMDL program, because of our current lack of compliance. Therefore, this bill would be a step toward meeting our Clean Water Act obligations, as well as fulfilling our Constitutional obligations of protecting and better managing our precious water resources.

OHA notes that the funding for these two positions is proposed to come from federal monies derived from the Clean Water Act. We suggest that the longevity of the TMDL program and associated funding should be verified before these positions are created.
