I am writing on behalf of the Naval Air Museum Barbers Point, with support for HB-1407. This bill identifies the former MCAS Ewa Field, and will get the process rolling for preservation of this worthy site. IT does NOT ask for money, or burden on the tax payers. It asks for getting it on the National register and will voice support of the people of Hawaii to preserve this very historic and tangible portion of Ewa. We feel, as the resident experts of NAS Barbers and MCAS Ewa's history, and our extensive knowledge and documentation of structures and historic sites, that this bill should be passed and that a formal survey can be done by a collaboration of local heritage partners and professionals and gvt entities. The area defined as MCAS EWA should serve as the identified area to be saved. It is our expert opinion that the former base boundaries should be appropriate for the designation of the areas to be preserved. While Dec 7, 41 is the more well known of the histories of this MCAS.
