TO CHAIRPERSON JOHN MIZUNO AND MEMBERS OF THE COMMITTEE:

The purpose of H.B. No. 1435 is to establish the Hawaii State Giving Campaign as the only authorized solicitation of employees in the State workplace on behalf of charitable organizations.

The Department of Human Resources Development (DHRD) acknowledges that this measure has merit; however, because it has budget implications we must **OPPOSE** its enactment this year.

The bill would require DHRD to carry out various responsibilities in administering the Hawaii State Giving Campaign, such as implementing administrative rules and procedures, overseeing a coordinating committee, maintaining minutes of meetings, and determining the eligibility of potentially thousands of charitable organizations wishing to participate in the campaign. To administer this new program, we would need funds for additional staff and operating expenses. Unfortunately, since the State is already having difficulty in addressing the current fiscal situation, it would not be prudent to pursue this bill at this time.

H.B. 1435

Mr. Chair and Members of the Committee, my name is Linda Chu Takayama, and I am the Chair of the Hawaii Foodbank. The Foodbank serves 131,862 different individuals every year, distributing nearly 9 million pounds through 250 charitable agencies, including feeding programs for children and the elderly, homeless and abuse shelters, rehabilitation centers and soup kitchens.

Nineteen years ago we began conducting an annual community food drive to supplement the food we were able to salvage from grocery stores and manufacturers. State departments were among the first to step up to participate in helping to feed the needy in our community. They continue to be our largest and most enthusiastic coalition and represent about 20% of our food drive goal.

The food collected from the state departments during the food drive are of the best quality we have in our warehouse. We distribute it through our member agencies throughout the year. The monies collected are used to buy food in bulk and fund operations.

Except for a modest amount from the Office of Community Services, which we use to pay for shipping food to the neighbor island foodbanks, the Hawaii Foodbank does not request nor receive any other state funds.

This organization is a prime example of the community coming together to take care of its own. We are almost entirely supported by the individuals and businesses in the community. Programs (food collection and distribution) account for 95% of all our spending. Administration and fundraising expenses account for only 5%.

This bill would ban our annual food drive efforts in state agencies. Our operations would be severely impacted if we were unable to count on our long-standing partnership with the state. We respectfully request that this bill be held.
