**PURPOSE:** The purpose of this bill is to make an appropriation of \$762,500 from general revenues for emergency domestic violence shelters.

DEPARTMENT'S POSITION: The Department of Human Services acknowledges that this measure has merit; however, given the current fiscal difficulties, it would not be prudent to pursue enactment at this time. The Department will try to maintain level funding for its domestic violence services including shelters.

Aloha, my name is Carol Lee. HSCADV is a private non-profit agency which serves as a touchstone agency for the majority of domestic violence programs throughout the state. For many years HSCADV has worked with the Hawaii Legislature by serving as an educational resource and representing the many voices of domestic violence programs and survivors of domestic violence.

HSCADV strongly supports HB1498.

As you know, Hawaii has eight domestic violence shelters located throughout the islands; three on Oahu, and one each on Kauai, Maui, Molokai and in Hilo and Kona. Domestic violence emergency shelters provide valuable services and can be the difference between life and death for a battered woman and her children.

Leaving home to seek safe shelter is a terrifying prospect. However, as our communities become more aware of the problem of domestic violence and the protections available to victims, the number of women and children seeking shelter increases. Unfortunately, the costs of running a shelter and providing necessary services have increased as well.

An emergency shelter, like any residence, must contend with basic facility costs from paying the light bill to getting a plumber to fix a clogged toilet. All of these, and other expenses, have increased significantly during recent years. The cost of health insurance for employees of the shelters is another example of how the cost of doing business has escalated.

Many of the shelters statewide are experiencing a financial crisis, operating at a deficit and are in desperate need of increased funding. Without additional funding shelters will have limit services, including the number of people they can serve.

Shelters are the first line of defense for a victim attempting to leave a home where there is domestic violence and they are a key component in a coordinated community response to domestic violence.

Aloha Chair Mizuno and Members of the House Committee on Human Services:

Thank you very much for your years of support for victims and survivors of domestic violence. I know that many of you have supported past legislation for the important role that emergency shelters hold in the continuum of services needed to keep victims and their children safe when they flee domestic violence. On behalf of the Board of Directors, Staff, women and children at Women Helping Women, I thank you for your time and efforts to support the life-saving work we do each day.

I strongly support the Bill appropriating funds for the eight emergency shelters statewide. Funding for the shelters was contracted six years ago at flat funding for the entire six year contract. Escalating costs, inflation, and increased utilization at shelters created a need for all shelters to increase the funding. Each shelter submitted the specific needs for their program in each of the geographical locations contained within your bill. These are actual expenses and needs of the programs. Shelters were also receiving TANF monies which have been cut out of our budgets for next year, making this legislative funding even more critical.

Women Helping Women provided safe shelter to over 325 women and children in our emergency shelter on Maui last year for over 5000 bed nights. We served over 12,000 meals, answered 11,000 calls to our hotline, including 2200 from people who were in actual crisis. We provide support services in West Maui and also on Lanai which includes referrals to our emergency shelter when needed.

Funding cuts initiated the layoff of four shelter employees last year, fully one third of the shelter staff. The impact on my staff has been that they are working harder and needing more time to recuperate. Staff illness has risen, requiring us to pay relief staff to cover regular staffs' shifts. The long term impact of the funding cuts may continue to affect the staff and their morale and could ultimately affect the level of services being provided to the women and children we wish to help.

During this "economic downturn," with families losing one or both incomes, fighting within the family increases, people's desperation intensifies and limits are stretched beyond a family's comfort zone. The demand for our services continues to increase and the levels of abuse we are seeing in our shelter and other programs has gotten visibly and tangibly worse. The support we provide to these families is priceless and is happening at shelters throughout the state.

I humbly ask for your support of this bill, request that it be fully funded, and encourage you to contact me should you have any questions or need more information about the kinds of services we are providing.
