RE: H.B. 1513: Relating To Offenses Against Public Order.

Chair Karamatsu and Members of the Committee:

This measure would prohibit gaffs or slashers which are intended to be used for cockfighting. We oppose H. B. 1513.

Gaffs or slashers are already prohibited by section 7-1.2 of the Honolulu Revised Ordinances. The language from subsection (1) of this measure is taken word for word from section 7-1.2. Each island has its own county codes or ordinances which address illegal cockfighting, making the need for a state law unnecessary. While the other counties do not have ordinances specifically prohibiting the possession of gaffs or slashers, the possession of such devices are prohibited, and prosecuted under ordinances prohibiting the possession of gambling devices.

We also believe that the more stringent penalties proposed in this legislation would run afoul of current caselaw. <u>State v. Modica</u>, 58 Hawaii 249, 567 P.2d 420 (1977) would require any prosecution for gaffs or slashers prohibited on the island of Oahu to be conducted utilizing the city ordinance (section 7-1.2) instead of this measure.

Under <u>Modica</u>, whenever facts support the charging of more than one offense, the state must proceed against a defendant with the lesser charge. Although the language proposed in this measure is identical to section 7-1.2, the penalty is more severe than the city ordinance, and thus could not be used against a defendant on this island.

Individuals prosecuted under section 7-1.2 are typically sentenced to a fine, and are not sentenced to jail and/or court supervision. This measure will place an additional financial burden on the Judiciary, who will have to allocate probation officers to supervise these defendants. We doubt that the Judiciary has an animal cruelty education or prevention program in place. This measure does not give the Judiciary any time in which to implement such a program.

We propose that subsection (2) of this measure be amended to read as follows: "Any person violating any provision of this section shall be punished by a fine of not less than \$250 and not exceeding \$1,000 and/or by imprisonment not exceeding thirty days." This language was taken from §7-1.3, Revised Ordinances of Honolulu.

For the reasons stated above, we oppose H. B. 1513. Thank you for the opportunity to comment on this bill.

#### **RE: H.B. 1513; RELATING TO OFFENSES AGAINST PUBLIC ORDER.**

Chair Taniguchi, and members of the Senate Committee on Judiciary and Government Operations Committee, the Department of the Prosecuting Attorney submits the following testimony in support of HB 1513.

The purpose of HB 1513 is to create a new section in Hawaii Revised Statutes (HRS) chapter 711 which makes it a petty misdemeanor offense for a person to manufacture, buy, sell, barter or exchange, or have in the person's possession gaffs or slashers. Under HB 1513, persons convicted of this offense shall have the following included in their sentence: 1) completion of an animal cruelty education or prevention program; and 2) mandated fines of \$400 for a first offense, \$750 for a second offense; and \$1,000 for a third offense. The bill also permits the defendant to request that the fine be converted to community service.

We strongly support this bill. Gaffs and slashers are sharp instruments designed to be attached to the leg of a gamecock when the bird is fighting; they have no other uses other than in cockfighting which is illegal in state of Hawaii. Despite having no other uses, not all of the counties in the state have an ordinance outlawing the possession of gaffs and slashers; this bill would rectify that deficiency. We further note that in 2007, Congress passed amendments to the Animal Welfare Act which made it illegal to sell, buy, transport or deliver gaffs in interstate or foreign commerce; however the federal law does not cover the possession of gaffs that cannot be demonstrated to be involved in interstate or foreign commerce. We believe that this law will be useful when federal law cannot be applied when it cannot be proven or shown that the gaff was sold, bought, transported or delivered in interstate or foreign commerce.

For these reasons, we respectfully request your favorable consideration of HB. 1513 and thank you for this opportunity to testify.

Subject: House Bill No. 1513, Relating to Offenses Against Public Order

I am Louis Kealoha, captain of the Narcotics/Vice Division of the Honolulu Police Department, City and County of Honolulu.

The Honolulu Police Department strongly supports House Bill No. 1513, Relating to Offenses Against Public Order.

In 1983, the City and County of Honolulu enacted an ordinance prohibiting the possession of gaffs or slashers that are commonly used in cockfighting. However, the other counties in this state still do not have any laws specific to the possession of gaffs or slashers. They currently arrest individuals in possession of gaffs or slashers under "possession of a gambling device."

Passage of this bill will bring continuity to the charging criteria regarding gaffs or slashers. It will also assist law enforcement by streamlining the identification of repeat offenders.

In Hawaii, it is not illegal to attend a cockfighting event, and it is not illegal to possess a fighting bird. According to the Humane Society of the United States, Hawaii ranks 46 out of 50 in the nation regarding cockfighting laws.

In 2007, the federal government enacted an animal fighting prohibition law that makes it a felony to illegally sell, purchase, or transport any knives, gaffs, or sharp objects between states that are designed and intended to be attached to the leg of a bird for use in an animal fighting venture. Passage of this bill will ensure consistency in the regulation of gaffs and slashers in the four counties.

Lastly, the proposed penalties include animal cruelty education or a prevention program. We support this as a means to prevent future violations.

The Honolulu Police Department urges you to support House Bill No. 1513, Relating to Offenses Against Public Order.

The Honorable Chairpersons and Committee Members:

The Department of the Prosecuting Attorney for the County of Maui supports H.B. 1513 Relating to Offenses Against Public Order.

This proposed bill seeks to prohibit the manufacture, sale, distribution, or possession of implements commonly known as gaffs or slashers, which are typically used cockfighting. These sharp instruments are attached to the gamecock in order to specifically kill or inflict serious injury on the opposing fowl.

Presently, there is no <u>state law</u> that specifically prohibits the possession, sale, or distribution of these types of paraphernalia associated with cockfighting. As such, current prosecution of these cases are usually based upon some other law or ordinance.

We fully support this proposal as it will send a clear message to individuals involved cockfighting that the possession, sale, or distribution of these types of instruments are prohibited. In addition, the proposal seeks to educate offenders by requiring the completion of animal cruelty education or prevention programs as part of their sentence.

Accordingly, for the reasons discussed above, our Department supports H.B. 1513. Thank you for the opportunity to testify.

#### Re: House Bill 1513, Relating to offenses against public order

Dear Representative Karamatsu and members of the committee:

The Hawai'i Police Department supports the passage of H.B. 1513, which adds a new section to be appropriately designated as Gaffs or slashers prohibited. This bill seeks to prohibit the possession, manufacturing, buy, sell, barter, and exchange of gaffs or any sharp instrument designed to be attached to a gamecock or other fighting fowl.

Cockfighting is a cruel blood sport that pits two roosters against each other. Spectators place bets, and the fight ends after one or both roosters die. The birds, even those who do not die, suffer in cockfights. The birds cannot escape from the fight, regardless of how exhausted or injured they become. Common injuries include punctured lungs, broken bones, and pierced eyes.

Such severe injuries occur because the birds' legs are usually fitted with razor-sharp steel blades or with gaffs, which resemble three-inch-long, curved ice picks or knives. These custom made artificial spurs are specially designed to puncture and mutilate and have no known legitimate use other than for cockfighting.

As it stands now, cockfighters are well aware that our current laws fail to address gaffs that are solely intended and designed to be attached to a gamecock or fighting fowl. The Hawai'i Police Department, for years now, has encountered participants at these large gatherings who are in possession these devices but know very well that if they separate the gaff from the fighting cock, they would avoid arrest.

This bill would definitely address that loophole and would act as a deterrent to some. But more importantly, this bill provides law enforcement officers the tools they need to enforce these laws and to have a positive impact on Cruelty to Animals investigations.

For these reasons, we urge this committee to support this legislation. Thank you for allowing the Hawai'i Police Department to testify on H.B. 1513.



Dear Honorable Chair Karamatsu and Committee Members:

On behalf of our 47,704 members and supporters of the Humane Society of the United States in Hawaii, I would like to thank you for this opportunity to speak in favor of H.B. 1513; to prohibit the possession of gaffs/slashers. The HSUS is in strong support of this bill and we thank Chair Karamatsu for his introduction of this measure.

#### Need for prohibition on possession of implements:

There is currently no statewide law that explicitly prohibits the possession of cockfighting implements, commonly known as gaffs, knives or slashers. These implements serve only one purpose- to be strapped to the legs of a fighting rooster in an illegal cockfighting match. We believe the increased penalties for possessing such implements would be a deterrent for such illegal activity and its associated crimes.

This law would also put Hawaii in line with the language under the recently upgraded Animal Fighting Prohibition Enforcement Act, which prohibits knowingly selling, buying, transporting, or delivering, in interstate or foreign commerce, a knife, a gaff, or any other sharp instrument for attachment to the leg of a bird for use in an animal fighting venture.

#### **Reduce associated criminal activity:**

Law enforcement raids across the country have revealed several disturbing facets of cockfighting. Illegal gambling is the norm at cockfights. Thousands of dollars can exchange hands as spectators and animal owners wager large sums on their favorite birds. The owners of birds who win the most fights in a derby (a series of cockfights) may win tens of thousands of dollars of presumably unreported income. Firearms and other weapons are common at cockfights, mainly because of the large amounts of cash present. In addition, cockfighting has been connected to other kinds of violence—even homicide, according to newspaper reports.

Law enforcement officials have also documented a strong connection between cockfighting and the distribution of illegal drugs. Drug enforcement agents often learn about animal fighting operations as a result of narcotics investigations.

The presence of young children at cockfights is an especially disturbing element. Exposure to such brutality can promote insensitivity toward animal suffering and enthusiasm for violence.

While it is true that birds will fight over food, territory, or mates, such fights are only to establish dominance within a group (the pecking order) and seldom result in serious injury. This natural

behavior is quite different from what happens in staged cockfights, where pairs of birds, bred for maximum aggressiveness (and sometimes given steroids or other drugs to make them more successful fighters) are forced to fight until a winner is declared.

#### **Unnecessary Cruelty**

A cockfight usually results in the death of one of the birds; sometimes it ends in the death of both. A typical cockfight can last anywhere from several minutes to more than half an hour. The birds, even those who do not die, suffer in cockfights. The birds cannot escape from the fight, regardless of how exhausted or injured they become. Common injuries include punctured lungs, broken bones, and pierced eyes. Such severe injuries occur because the birds' legs are fitted with razor-sharp steel blades or with gaffs, which resemble three-inch-long, curved ice picks. These artificial spurs are designed to puncture and mutilate.

#### Recent Animal Fighting Cases in Hawaii demonstrate need for stronger penalties:

Aug. 4, 2008 — A Louisiana man was sentenced to 2 months in federal prison for attempting to smuggle more than 200 cockfighting gaffs into the United States through Hawaii.

March 1, 2008 — Hilo Police arrested ten people for gambling and cruelty to animals, seized 36 birds, more than \$27,000 in cash, multiple firearms and extensive cockfighting implements.

Jan. 20, 2008 — Four Molokai men were arrested and charged with gambling and animal cruelty. 150 people were said to be at the cockfighting site.

March 25, 2007 — One man was shot to death, one man arrested and several others fled the scene from what police said appeared to be a botched robbery of a cockfighting operation.

Sept. 27, 2006 — An official from Aloha Stadium pled guilty to extortion. The investigation was part of a massive FBI bust involving an alleged drug-trafficking and cockfighting ring that led to the arrests of an FBI worker and 29 others.

Nov. 21, 2001 — Police arrested 3 men in Kalihi in connection with a death after a post-cockfight argument.

On behalf of the Hawaiian Humane Society and its 20,000+ supporters, we ask that the House Judiciary Committee SUPPORT HB1513, which provides for a statewide prohibition on the possession of gaffs and slashers, knife-like instruments used in cockfighting.

Hawaii continues to be under national scrutiny as ranking 48th out of 50 states in relation to our laws relating to cockfighting. In fact, Honolulu is the only county that has an ordinance in place that outlaws the possession of gaffs. With the federal Animal Fighting Prohibition Act in place, Hawaii needs to strengthen its laws at the statewide level to provide our law enforcement officials with the tools they need to put these people behind bars and work to end cockfighting in Hawaii once and for all.

Let us not forget that cockfighting is already an illegal activity and often these derbies serve to draw other illegal activities such as: gambling; drug and narcotics possession; illegal fire arms possession, and in some instances, homicide. Our public officials can no longer turn a blind eye to this barbaric bloodsport. Earlier this year, U.S. Attorney Ed Kubo expressed these thoughts when asked about the Toralba case, which was tried and convicted under the federal Animal Fighting Prohibition Act, "we hope that this case will send a clear message to Hawaii's animal fighting community that the times have changed and the community will no longer stand for these illegal and heinous activities. There can be nothing honorable about people who are making thousands of illegal dollars off of the suffering of animals."

This legislative body has the opportunity be a part of this change and we ask that you support HB1513.

You just as well start shutting down museums and anyone that chooses to preserve history and historical events forever. For that reason I oppose HB 1413.
