> Re: Testimony on House Bill 1725 Relating Hawaii Employee-Union Health Benefits Trust Fund

My name is Tenari Ma'afala and I am the President of The State of Hawaii Organization of Police Officers ("SHOPO"). We represent over 2700 police officers in the State of Hawaii. SHOPO opposes House Bill 1725 which from 07/01/2009 to 06/30/2015: (1) prohibits health benefits plan of the employer-union health benefits trust fund from providing prescription drug coverage; and (2)allows board of trustees to make prescription drug benefits available through drug coverage plans that are paid for entirely by employee-beneficiaries.

When the legislature adopted the Hawaii Employer-Union Benefit Trust Fund ("EUTF") in 2001, it eliminated the option of obtaining health coverage through unionsponsored plans. The premise of the EUTF was to provide a single health benefit program for public employees to strengthen the bargaining power which the Health Fund lacked.

Furthermore the amount of contributions which the States and Counties are required to make under Section 87a-32 through 87a-37, HRS, toward the payment of cost for health benefits plan is subject to collective bargaining. This measure is in direct conflict with collective bargaining rights.

Finally, drug coverage is an important component of health benefits. Therefore, placing the total cost of drug benefits on the workers is in direct conflict with the intent of the EUTF and collective bargaining.

SHOPO strongly opposes HB 1725.

### H.B. No. 1725 Relating to Hawaii Employer-Union Health Benefits Trust Fund

My name is Robert H. Lee and I am the President of the Hawaii Fire Fighters Association, Local 1463, IAFF, AFL-CIO and also an active-duty fire captain with the Honolulu Fire Department. On behalf of the 1,800 active and 1,000 retired professional fire fighters throughout the State, the Hawaii Fire Fighters Association strongly opposes H.B. No. 1725.

H.B. No. 1725 removes the requirement that prescription drug benefit plans be afforded to public employees and if available, the cost of the entire premium shall be borne by the public employee. This bill could result in the entire public employee workforce without access to drug coverage. Furthermore, as this bill also requires the public employee to pay for the entire cost of the premium, the uncertainty of enrollment would most likely increase the premium cost. This measure is bad public policy.

The Kaiser Family Foundation's September 2008 report says "[P]prescription drugs are vital to preventing and treating illness and in helping avoid more costly medical problems." An April 2008 survey revealed alarming statistics on the adverse effect of not having prescription drug insurance coverage. That survey "found that uninsured nonelderly adults (ages 18-64) are more than twice as likely as insured nonelderly adults to say that they or a family member did not fill a prescription (45% vs. 22%) or cut pills or skipped doses of medicine (38% vs. 18%) in the past year because of the cost."

HFFA vehemently opposes H.B. No. 1725, as this bill compromises the welfare of the public employees and will have far reaching negative effects on Hawaii's entire health care system.

> H.B. 1725 – RELATING TO THE HAWAII EMPLOYER – UNION HEALTH BENEFITS TRUST FUND

The Hawaii Government Employees Association opposes H.B. 1725. This bill prohibits the health benefits plan of the EUTF from providing prescription drug coverage at no cost to employers from July 1, 2009 - June 30, 2015

Under Chapter 87A-15, HRS, the EUTF Board of trustees has the authority to determine benefit plans "at a cost affordable to both the public employees and the public employees." As drafted, H.B. 1725 will adversely affect both active and retired employees by making prescription drug coverage unaffordable for many.

Many of our 3,167 retiree members are more than 75 years old and depend on a small pension to pay bills and make necessary purchases. Eliminating prescription drug coverage for retirees and active employees will mean that health care costs continue to eat away at their pension benefits and threaten the benefits of future retirees during this six-year period.

When the retirees and active employees came to work for the state and counties, they were promised medical, drug, dental and vision coverage while employed and during retirement. These benefits were a condition of employment and that is why, despite their lower pay, many stayed on and retired from public employment. State or county employees should not be asked to pay for their prescription drugs, especially during these difficult economic times when so many people are struggling to make ends meet.

Further, this proposal is extremely shortsighted as it will result in possibly thousands of employees and retirees forgoing their medications simply because it will cost too much. As a result, people with conditions that are manageable with the appropriate medications may deteriorate to the point where they will require expensive hospitalization or additional doctor visits further escalating health care costs. It will also

make recruiting and retaining new employees much harder. Benefits that attract and retain highly skilled employees to the public sector help build good government and good public policy.

## H.B. 1725 Relating to the Hawaii Employer-Union Health Benefits Trust Fund

The University of Hawaii Professional Assembly does not support this proposed legislation. Prohibiting the EUTF from incorporating prescription benefits into a health care fund is not a cost saving measure. Prescription drug benefits help keep costs down by preventing other costly measures such as surgical or hospital services. They are an essential element of sound health care practices and should be maintained as part of the EUTF health benefit program provided employees.

Allowing EUTF to provide a prescription program paid for by employees is problematic. It is unclear that any insurance company will provide a plan without assurances of significant participation. Further the cost to the employee may be prohibitive thus forcing families to go without essential health coverage.

UHPA requests the bill be filed.

Chair Rhoads, Vice Chair Yamashita, and members of the committee:

Thank you for the opportunity to submit testimony today. I speak both for myself and my husband, John W. Cater, who retired as an administrative hearings officer from the State Judiciary on Dec. 31, 2007, with over 16 years of service.

He is 77 years old, and I am 66. We live on a fixed income that includes his State pension and our Social Security payments only. We both take daily prescription medication to control several different chronic medical conditions, and, as we age, can anticipate more such needs. HB 1725 will eliminate the Trust Fund coverage of prescription drugs on a temporary basis. HB1725, which is planned for the next six years, will take us to the ages of 83 and 69, respectively. Six years at our ages is a lot longer than it might be for younger, stronger, healthier people. It is not expected that our medication needs will be less during that time, given the natural aging process.

Although John is an attorney, licensed to practice law in both Hawaii and California, he chose to work for less pay as a civil servant, in order to contribute to the community. We mutually chose this route after much discussion. Our expectation was that he would come to a safe retirement. He retired with the belief that we would be able to maintain our health and welfare, as long as we lived a simple, low-cost life.

The loss of prescription drug coverage at this stage of life is more than an unexpected burden. It is a life and death threat to our survival in today's economy, especially with the cost of prescription drugs escalating at an alarming rate. We very possibly may find ourselves unable to pay for life-saving or life-extending drugs, as we near the end of our lives. This bill deprives us of the quality of life that we were given to expect when entering public service. We are elderly and have no children to look after us, and deserve the protection we had carefully planned to have to live out our lives.

Please vote "NO" on this bill that will remove a planned-for safety net for older citizens and State retirees.

### Testimony re: Take away Bills

## PLEASE DO NOT PASS THE SIX YEAR RECESSION EXTENSION PACKAGE OF 2009

The proposed take away bills are counterproductive to the philosophy that the government should be doing everything in it's power to stimulate the economy, and not to drag it down. The numerous attacks that these bills have on government employees pay and benefits are short-sighted and foolhardy.

HB 1725

Let's look at just a few ways that these legislative proposals in question stimulate Hawaii's economy:

- 1) Drastically reduce the take home pay of the 40,000+ government employees in the range through furloughs that equal a 5% reduction in pay per day for each furlough day
- 2) Reduce the workers take home pay by an additional \$250+ monthly to cover an increase to proposed family plan medical insurance premiums. This would also cause a severe reduction in spending by the largest employee group in the state. These draconian reductions are GAURANTEED to further drag down the state's economy as nearly ALL 40,000 employees who are presently scrapping by will restrict their spending.
- 3) Force the workers who retire after 6-30-09 to incur huge increases in the cost of medical insurance premiums due to non-payment by the state. This will result in no spending (economic stimulus) by anyone retiring in the near future due to lack of affordability. This is also a great way to thank workers who have given decades of service to the State of Hawaii who will now be on fixed incomes.
- 4) The state will need to pay out millions of dollars in cash to buy out the exodus of employees that will retire before 6-30-09. The state still owes them their vacation pay, up to 112 days of wages for each forced retirement.

The state and county governments do not produce widgets and gadgets that we sell to the residents and visitors to Hawaii to generate revenue for the government. We provide critical services to the people of Hawaii by taking care of the less fortunate, protecting our food and water supplies, and saving people's lives from criminals and disasters alike. In other words, governments' role is to allow the people of Hawaii to live in a manner to which they have become accustomed. The HGEA had no role in creating any of the governments programs or personnel in State or City government, this was the role of our lawmakers who decided that the people of Hawaii needed some type of service in order to make life in Hawaii better for all our visitors and residents.

Therefore the product we sell is shared by all the people in Hawaii, and we should ALL share in the costs of this economic downturn. This means that all residents and visitors must share equally in the "pain" that the lawmakers speak of.

Thank you for the opportunity to submit testimony on behalf of HB 1725 and HB 1727. My name is Dr. Jared Yurow, and I am a Hawaii licensed psychologist. As a public employee for over fifteen years and a citizen of this state, I am deeply troubled by bills introduced by Speaker Calvin Say. Specifically: HB 1725 and HB 1727.

HB 1725 says that from July 1, 2009 to June 30, 2015, public employees will have to bear the entire burden of prescription drug coverage. HB 1727 prohibits vision and dental coverage. Both bills will place an undue hardship on my family and may prove injurious not only to me but to other public workers. Although HB 1725 is only temporary, it affects significantly the cost of prescription medications. This is especially important to me, as I have glaucoma, high blood pressure and acid reflux. With chronic diseases that require medication, these bills, coupled with talk of salary cuts and rises in our premiums is shameful for a state that prides itself on taking care of ohana and calling itself "The Health State." It may well prove catastrophic for our elderly, sick, or recovering public workers and retirees. Chair Rhoads, Vice Chair Yamashita, and members of the committee:

Thank you for the opportunity to submit testimony this morning. My name is Alison Cameron and my husband is Greg Cameron. I have been a public employee with the DOE for 8 years and Greg in the Hawai'i County Fire Dept for 14 years. Greg has recently been diagnosed with Stage 4 Metastatic Colon Cancer and is fighting for his life. He is only 49 and we have 2 children. We are deeply upset about the bills introduced by Speaker Say as they would deeply impact our family's ability to survive. Specifically the bills related to our medical, drug, dental and vision coverage, bills HB 1723, 1727, 1725.

HB 1719 is also of concern to us. As civil servants, we chose to work for less pay to be able to contribute to the community. On balance, I believed that I would be able to count on a safe retirement. Speaker Say's bill, which disregards my years of service and reduces medical benefits until the Medicare retirement age, is irresponsible. Instead of supporting public service, Speaker Say is telling us that public employees don't mean much and promises to us can be broken mid-stream. This bill is a thinly veiled attempt to force people into early retirement.

Speaker Say is backing us into a corner, and it's not irresponsible for him to suggest that this economic crisis should be resolved by sacrificing the health and well being of our family. Also, by forcing people into retirement before July 1, 2009, we are gambling with the future of state programs. The loss to institutional knowledge and expertise that we could experience is putting our families in Hawai'i at risk. State programs that protect Hawai'i's children, elderly and public will loose a wealth of knowledge that is not easy to recover when state hiring freezes are overburdening our already overburdened workforce. We strongly encourage this committee to vote "no" on HB 1719 and to send a strong message to Speaker Say, that he cannot punish civil servants for their dedication and commitment to the state of Hawai'i.

HB 1723, which limits the employer contribution to medical coverage to 55 % is of great concern for us. As stated, my husband Greg is currently undergoing treatment for Stage 4 cancer. We talk every day about how blessed we are to have such good medical coverage that we can afford to get treatment for him. If we had to pay more, we wouldn't be able to afford the treatment that he is getting and he would die, leaving a widow with young children to bring up on her own. Then I would really be in trouble trying to pay for my children's medical coverage as a single mother on a State salary. Please think about how these bills not only impact the greater health of our state workers and state as a whole, but also how it will impact individual families. Please vote NO for this bill and all the bills introduced that take away rights and benefits from public workers.

HB 1725 says that from July 1, 2009 to June 30, 2015, public employees will have to bear THE ENTIRE burden of prescription drug coverage. If this bill is passed, our family is down the tubes as Greg's cancer treatment involves many medications to help him with nausea, blood clots etc. He will not make it without these drugs, we cannot afford them on our own and we have two children to raise up. Without drug coverage, we are sunk.

Also HB 1727, taking away coverage for vision and dental. While not a lot is covered under dental plans, cleanings are and those are a preventative measure which is important to families, especially those with children. Dental benefits are very important for us, as are

vision benefits. Why not continue to provide this coverage to help with prevention of problems through allowing us to get teeth cleanings and dental exams and thus cut down on the amount of expense and problems that in happen if we don't get these preventative measures?

We understand that the state is in trouble and that things must change to pull us through. But don't cut out the benefits of those that really help to keep the State running and provide essential services to those in need. I work in school as a Behavioral Health Specialist, helping children with behavioral and emotional problems, thus helping to care for the future of our state. My husband Greg saves lives as a paramedic and rescue specialist. We have lived and worked here our whole lives. We struggle. We can't afford to struggle anymore as our medical benefits are taken away and our salaries cut or capped.

I strongly feel that these bills will cause more problems and economic hardship in the State of Hawai'i, not less. More families will be in trouble. Then what?

I beg you to vote "no" on all of these bills that take away benefits from public employees. Please!
