In consideration of HOUSE BILL 1778 RELATING TO WALKING TRAILS

House Bill 1778 request the Na Ala Hele Program under the Department of Land and Natural Resources (Department) to conduct a study on the feasibility of designating the Pi'ilani Trail from Kaupo to Kapalua as an important Hawaiian coastal cultural heritage corridor and opening the Trail to the public. This trail corridor from Pi'ilani Trail to Kapalua would go through numerous private lands, historical and archeological sites, and has not been determined and difficult and costly to establish. This bill also directs the Department to inventory public lands, incorporate public and private partnerships, and provide cost assessment to repair, acquire land for maintaining the Trail for public use, and designate it as a cultural heritage corridor. While the Department acknowledges the Pi'ilani Trail as an important Hawaiian coastal cultural heritage corridor, the Department nonetheless cannot support this unfunded mandate.

The Department's general fund appropriation has been cut 32% in less than three years, special fund revenues have dropped over 35% over the past three years, and the Department lost over 80 positions this past year. The Department does not have the staffing or the resources to support a new unfunded mandate and expansions of our workload beyond our current core mission.

The Department encourages respective private landowners and community groups to work together to pursue this corridor.

The Office of Hawaiian Affairs (OHA) SUPPORTS WITH RESERVATIONS HB 1778, which requests the Nä Ala Hele program under the Department of Land and Natural Resources to conduct a study on the feasibility of designating the Piÿilani trail from Kaupö to Kapalua as an important Hawaiian coastal cultural heritage corridor and opening the trail to the public.

While OHA is cognizant that increased access throughout the islands is directly correlated to an elevated enjoyment of the outdoors for residents and visitors alike, we do retain some concerns with regards to the opening of some areas of high natural and cultural sensitivity. The potential exposure of important components of the traditional cultural landscape and the increased likelihood of damage or desecration to these sacred and spiritual areas by unscrupulous individuals is an ongoing concern of the Native Hawaiian community.

OHA requests that hoa 'äina from lands surrounding the proposed trail alignment and the broader Native Hawaiian community be consulted during the investigation and study process. In addition, some form of archaeological surface reconnaissance should also be conducted to assess the absence or presence of cultural sites within or adjacent to the access corridor to assist in planning purposes to best maximize education opportunities while minimizing opportunities for intentional or negligent desecration of Native Hawaiian cultural sites.

WHEREAS, House Bill No. 1778 currently pending before the Hawaii State Legislature, requests the Na Ala Hele program under the Department of Land and Natural Resources, State of Hawaii, to conduct a study on the feasibility of designating the Pi'ilani trail from Kaupo to Kapalua as an important Hawaiian coastal cultural heritage corridor and opening the trail to the public; and

WHEREAS, designating the Pi'ilani trail as an important Hawaiian coastal cultural heritage corridor will allow the State of Hawaii and the County of Maui to protect and share this historic resource; and

WHEREAS, Edna Farden Bekeart, a Lahaina community member, has spent many years working to officially create this trail, in an attempt to protect this cultural resource and the history of the Hawaiian people; and

WHEREAS, designating the Pi'ilani trail is an important step toward the inclusion of the trail in the National Scenic Byways Program; and

WHEREAS, the National Scenic Byways Program is a voluntary, grassroots program that recognizes and supports outstanding roads, their stories and culture, and treasured places; and

WHEREAS, a National Scenic Byways Program designation will provide resources to help manage the intrinsic qualities within the corridor to be treasured and shared; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

- 1. That it hereby urges support of House Bill No. 1778, which will protect the Pi'ilani trail from irreparable harm; and
- That certified copies of this resolution be transmitted to the Honorable Charmaine Tavares, Mayor, County of Maui; the Honorable Linda Lingle, Governor, State of Hawaii; the State House of Representatives; the State Senate; and Ms. Edna Farden Bekeart.
