# Testimony of the Office of the Public Defender State of Hawaii to the House Committee on Judiciary

February 2, 2010

H.B. No. 1867: RELATING TO PROSTITUTION

Chair Karamatsu and Members of the Committee:

We oppose passage of H.B. No. 1867 which seeks to raise the penalty for solicitation of prostitution if it is committed with 750 feet of a school or public park. Currently, the offense of street solicitation of prostitution, H.R.S. § 712-1207, is a petty misdemeanor. This bill seeks to raise the offense to the misdemeanor level if it is committed within 750 feet of a school or public park.

We believe that the upgrade in penalty due to the proximity to a school or public park is arbitrary and would treat offenders of the same law different simply because of the location of the commission of the offense. 750 feet is the length of more than two football fields and several city blocks. In many urban Honolulu areas, there are no areas which are more than 750 feet from some type of school or public park. Thus, this measure would carry the unintended consequence of punishing urban offenders more heavily than rural ones.

Moreover, increasing this offense to a misdemeanor would entitle persons charged to jury trials. Assuming most persons charged with this offense would be arrested in police "sting" operations, many defendants would want to wage an entrapment defense which could potentially flood the circuit courts with jury trials for this offense. This would have the effect of diverting precious judicial as well as public defender and prosecution resources from more serious cases.

Chair Karamatsu, Vice Chair Ito and Members of the Committee:

The Downtown Neighborhood Board strongly supports HB 1863 that makes it a misdemeanor to solicit prostitution within 750 feet of a school or public park.

As we testified on the previous bill, any measures that can reduce the actions of patrons of prostitution will help reduce the incidence of these activities. A misdemeanor level offense certainly sends a strong message to all involved that the community will not tolerate this behavior.

As we have stated before, those who live and work, and visit, in the Downtown and Chinatown areas are greatly concerned with the impact of prostitution on themselves and their children. Prostitution is not a "victimless crime" and may well have a direct impact on us and our families.

We are certainly willing to restrict legal adult businesses from locations near schools. Surely we should be able to do the same for illegal activities. These activities often take place during daylight hours when children are either in school or traveling to and from school and are playing in designated parks.

This measure would continue the communities' efforts to balance the penalties between those who are prostitutes and those who seek their services.

SECTION 1. Section 712-1200, Hawaii Revised Statutes, is amended to read as follows:

"\$712-1200 Prostitution. (1) Prostitution is defined as \[ \bullet 77Aucs

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 712-1200, Hawaii Revised Statutes, is amended to read as follows:

"\$712-1200 Prostitution. (1) A person commits the offense of prostitution if the person engages in, or agrees or offers to engage in, sexual conduct with another person for a fee[-] in a public place that is likely to be observed by others who would be affronted or alarmed. For purposes of this section, a "public place" means any street, sidewalk, bridge, alley or alleyway, plaza, driveway, parking lot, or transportation facility, or the doorways and entrance ways to any building that fronts on any of these places, or a motor vehicle in or on any of these places except areas that are designated as exceptions to this section pursuant to subsection (6).

- (2) As used in subsection (1), "sexual conduct" means "sexual penetration," "deviate sexual intercourse," or "sexual contact," as those terms are defined in section 707-700.
- (3) Prostitution is a [petty misdemeanor.] violation, subject to a fine of up to \$500.
- [(4) A person convicted of committing the offense of prostitution shall be sentenced as follows:
  - (a) For the first offense, when the court has not deferred further proceedings pursuant to chapter 853, a mandatory fine of \$500

- and the person may be sentenced to a term of imprisonment of not more than thirty days or probation; provided that in the event the convicted person defaults in payment of the \$500 fine, and the default was not contumacious, the court may sentence the person to perform services for the community as authorized by section 706-605(1).
  - (b) For any subsequent offense, a mandatory fine of \$500 and a term of imprisonment of thirty days or probation, without possibility of deferral of further proceedings pursuant to chapter 853 and without possibility of suspension of sentence.
  - further proceedings pursuant to chapter 853, and notwithstanding any provision of chapter 853 to the contrary, the defendant shall not be eligible to apply for expungement pursuant to section 831 3.2 until four years following discharge. A plea previously entered by a defendant under section 853 1 for a violation of this section shall be considered a prior offense. When the court has ordered a sentence of probation, the court may impose as a condition of probation that the defendant complete a course of prostitution intervention classes; provided that the court may only impose such condition for one term of probation.]
- (4) There shall be no penalty for engaging in, or agreeing or offering to engage in, acts of prostitution except as described in subsection (1).
- (5) This section shall not apply to any member of a police department, a sheriff, or a law enforcement officer acting in the course and scope of duties.
- (6) The legislature and counties shall designate areas within their jurisdiction as exempt from the penalty provisions of subsection (3).

Designated areas shall include portions of geographic areas that have a history of this offense. The designated areas may be described both by geographic boundaries and by time of day limitations.

The counties shall establish the designated areas as outlined in this section within one hundred twenty days of the effective date of this Act.

If they are unable to meet this deadline, the governor may appoint a committee of community members and sex worker advocates to suggest an outline for these designated areas. The governor may then impose the designated areas until the legislature acts upon them at its next regular session. If no plan is adopted by the counties or the governor, the entire State of Hawaii shall be treated as a designated area."

SECTION 2. Section 712-1202, Hawaii Revised Statutes, is amended by amending its title and subsection (1) to read as follows:

"\$712-1202 Promoting prostitution [in the first degree]. (1) A person commits the offense of promoting prostitution [in the first degree] if the person knowingly:

- (a) Advances prostitution by compelling a person by force, threat, or intimidation to engage in prostitution, or profits from such coercive conduct by another; or
- (b) Advances or profits from prostitution of a person less than eighteen years old."

SECTION 3. Section 712-1203, Hawaii Revised Statutes, is repealed.

["\$712 1203 Promoting prostitution in the second degree. (1) A person commits the offense of promoting prostitution in the second degree if the person knowingly advances or profits from prostitution by managing, supervising, controlling, or owning, either alone or in association with others, a house of prostitution or a prostitution business or enterprise involving prostitution activity by two or more prostituted persons.

(2) Promoting prostitution in the second degree is a class C felony."

SECTION 4. Section 712-1204, Hawaii Revised Statutes, is repealed.

["\$712-1204 Promoting prostitution in the third degree. (1) A
person commits the offense of promoting prostitution in the third degree
if the person knowingly advances or profits from prostitution.

(2) Promoting prostitution in the third degree is a misdemeanor."]
SECTION 5. Section 712-1206, Hawaii Revised Statutes, is repealed.

["[§712-1206] Loitering for the purpose of engaging in or advancing prostitution. (1) For the purposes of this section, "public place" means any street, sidewalk, bridge, alley or alleyway, plaza, park, driveway, parking lot or transportation facility or the doorways and entrance ways to any building which fronts on any of the aforesaid places, or a motor vehicle in or on any such place.

(2) Any person who remains or wanders about in a public place and repeatedly beckons to or repeatedly stops, or repeatedly attempts to stop, or repeatedly attempts to engage passers by in conversation, or repeatedly stops or attempts to stop motor vehicles, or repeatedly interferes with the free passage of other persons for the purpose of committing the crime of prostitution as that term is defined in section 712 1200, shall be guilty of a violation.

(3) Any person who remains or wanders about in a public place and repeatedly beckons to, or repeatedly stops, or repeatedly attempts to engage passers by in conversation, or repeatedly stops or attempts to stop motor vehicles, or repeatedly interferes with the free passage of other persons for the purpose of committing the crime of advancing prostitution as that term is defined in section 712 1201(1) is guilty of a petty misdemeanor."

SECTION 6. Section 712-1207, Hawaii Revised Statutes, is repealed.

["\$712 1207 Street solicitation of prostitution; designated areas.

(1) It shall be unlawful for any person within the boundaries of Waikiki and while on any public property, to offer or agree to engage in sexual

conduct with another person in return for a fee.

(2) It shall be unlawful for any person within the boundaries of other areas in this State designated by county ordinance pursuant to subsection (3), and while on any public property, to offer or agree to engage in sexual conduct with another person in return for a fee.

- (3) Upon a recommendation of the chief of police of a county, that county may enact an ordinance that:
  - (a) Designates areas, each no larger than three square miles, as

    zones of significant prostitution related activity that is

    detrimental to the health, safety, or welfare of the general

    public; or
- (b) Alters the boundaries of any existing area under paragraph (a); provided that not more than four areas may be designated within the State.
- (4) Notwithstanding any law to the contrary, any person violating this section shall be guilty of a petty misdemeanor and shall be sentenced to a mandatory term of thirty days imprisonment. The term of imprisonment shall be imposed immediately, regardless of whether the defendant appeals the conviction, except as provided in subsection (5).
- (5) As an option to the mandatory term of thirty days imprisonment, if the court finds the option is warranted based upon the defendant's record, the court may place the defendant on probation for a period not to exceed six months, subject to the mandatory condition that the defendant observe geographic restrictions that prohibit the defendant from entering or remaining on public property, in Waikiki and other areas in the State designated by county ordinance during the hours from 6 p.m. to 6 a.m.

  Upon any violation of the geographic restrictions by the defendant, the court, after hearing, shall revoke the defendant's probation and immediately impose the mandatory thirty day term of imprisonment. Nothing contained in this subsection shall be construed as prohibiting the imposition of stricter geographic restrictions under section 706 624(2)

- (6) Any person charged under this section may be admitted to bail, pursuant to section 804 4, subject to the mandatory condition that the person observe geographic restrictions that prohibit the defendant from entering or remaining on public property, in Waikiki and other areas in the State designated by county ordinance during the hours from 6 p.m. to 6 a.m. Notwithstanding any other provision of law to the contrary, any person who violates these bail restrictions shall have the person's bail revoked after hearing and shall be imprisoned forthwith. Nothing contained in this subsection shall be construed as prohibiting the imposition of stricter geographic restrictions under section 804 7.1.
- (7) Notwithstanding any other law to the contrary, a police officer, without warrant, may arrest any person when the officer has probable cause to believe that the person has committed a violation of subsection (5) or (6), and the person shall be detained, without bail, until the hearing under the appropriate subsection can be held, which hearing shall be held as soon as reasonably practicable.
  - (8) For purposes of this section:

"Area" means any zone within a county that is defined with specific boundaries and designated as a zone of significant prostitution by this section or a county ordinance.

"Public property" includes any street, highway, road, sidewalk, alley, lane, bridge, parking lot, park, or other property owned or under the jurisdiction of any governmental entity or otherwise open to the public.

"Sexual conduct" has the same meaning as in section 712 1200(2).

"Waikiki" means that area of Oahu bounded by the Ala Wai canal, the ocean, and Kapahulu avenue.

(9) This section shall apply to all counties; provided that if a county enacts an ordinance to regulate street solicitation for

prostitution, other than an ordinance designating an area as a zone of significant prostitution related activity, the county ordinance shall supersede this section and no person shall be convicted under this section in that county."]

SECTION 7. Statutory material to be repealed is bracketed and stricken. New statutory material is underscored.

SECTION 8. This Act shall take effect upon its approval.

Dear Chair Karamatsu, Vice Chair Ito and Committee Members,

My name is Michael Lakey and I am the General Manager of Kukui Plaza, located on 1255 Nuuanu Street. Thank you for this opportunity to testify in strong support of HB 1863 and HB 1867 to do something about prostitution in our neighborhood.

For many years prostitution and its related criminal activity has posed a threat to families and individuals that live in the Kukui Plaza. As the general manager of Kukui Plaza, it is my job to help keep our residents safe. At this point, we are doing all we can, but the scope of the problem is larger than we alone can solve. We need legislators to step in and help make our community safer.

Many of our residents are afraid to walk on our block in the evening for fear of harassment and sexual solicitations from prostitutes walking on our streets. These incidents occur even in front of our residents' children. In July 2006, a related disagreement led to a person being murdered right outside of our facility, outside our residents' homes.

We have implemented numerous security measures to rid our area of prostitutes, including every recommendation made by the Honolulu Police Department. We increased exterior lighting and installed additional security cameras. We conduct special security patrols on an hourly basis to report criminal activity to police, and our residents perform weekly citizens' patrols in an attempt to take back our streets.

Unfortunately, these activities are not enough because when individuals are arrested for dealing in prostitution, the penalties are nothing to them. They come right back to our streets.

We need you to hear and pass HB1863 and HB1867. The passing of these bills will provide one more step to help deter this activity and remind everyone that prostitution is illegal in Hawaii.

Kukui Plaza was built over 30 years ago and some of our residents have lived here the entire time. I ask you to imagine that one day your neighborhood is filled with prostitutes on your streets. Then imagine a murder as a result.

Please take this issue seriously. Our management and residents have worked well with the Honolulu Police Department, but as we've seen with other tragedies in our state, sometimes it is the laws that need to be improved when everyone else is already doing all they can.

I am a resident of Kukui Plaza and I support House Bill 1863 and House Bill 1867. As you may be aware, prostitution is a serious problem in our neighborhood, specifically on Kukui Street extending from Pali Highway to River Street.

Within recent years, it appears that the problem has escalated and has brought more criminal activity including the selling and use of drugs, a person being shot and killed in July 2006 and shots being fired in December 2008. Fortunately, no one was hurt in this incident but it occurred at a time when children were walking to school and people were on their way to work.

In the past few months, HPD has increased their presence on Kukui Street and I appreciate their efforts. When there is a patrol car in the area, prostitution activity stops, however, the moment that they leave, the prostitutes return.

I appreciate the committee's time and attention on this. I hope that you will pass both bills.
