Chairperson Morita and Members of the Committee:

Thank you for the opportunity to testify on House Bill No. 1928. The purpose of this bill is to add language to Section 194-5 (HRS) to allow owners of adjoining property to enter their neighbor's property to control or eradicate an invasive species. The Department is opposed to this measure.

Chapter 194 (HRS) establishes the Hawaii Invasive Species Council, defines its members and establishes its mandates and responsibilities. The current language of this statute allows for HISC members to enter private property to control invasive species after proper notice is given to the landowner and, if refused by the landowner, may obtain a court order for entry. The department feels that the current language is adequate and ensures that entities conducting the eradication or control have the required expertise to ensure that the control of the pest is conducted in a safe and effective manner. The department feels that allowing any property owner to have access to a neighbor's property for pest control through a court order opens all parties to uncertain risks and is unwise.

Thank you for this opportunity to comment on this proposed bill.

I strongly oppose this terrible bill for the following reasons:

- 1. There are "invasive species" everywhere, on many residents' private property. This bill will encourage neighbors to trespass onto adjoining property in the search for "invasive species".
- 2. Who will pay for the control or eradication of a neighbor's invasive species, the person complaining, or the neighbor? This will increase the case load for our judicial system, as neighbors sue one another over property right violations and payment for invasive species control and eradication.
- 3. This bill will result in conflict, violence, and other negative social consequences, as neighbors fight one another. There could be fatalities, since the implications of someone coming onto a neighbor's property to demand the eradication of invasive species could dramatically alter and destroy that property. This is an invasion of property that many people will not tolerate from a neighbor.
- 4. It is one thing when the government is doing an integrated eradication or control program. It is another thing when invasive species are attacked at random with no overall plan. Having neighbors attacking each other over various invasive trees, plants, animals, insects, will not solve anything for the environment, since these invasives could return from other properties nearby but not adjoining. Therefore, this solves nothing environmentally, while creating animosity between neighbors.
- 5. This bill goes against numerous trespass and private property laws.
- 6. This bill assumes that control or eradication is possible for all invasive species. As worded, this bill will allow a property owner to try forcing a neighbor to control or eradicate species for which control or eradication is not feasible or practical. Government agencies will not attack invasive species for which there are no effective control or eradication measures. However, this bill does not distinguish between easily controlled or eradicated species and those that are not. This will result in nuisance complaints by agitated, irrational, and angry residents against their neighbors, when nothing can really be done about their complaint.
- 7. What right does a person have to come onto someone else's private property to control or eradicate invasive species if these are not entering that person's property? Is this Nazi
- 8. This bill is unnecessary, since the government already has the mechanism for entering private property to control or eradicate invasive species. Property owners who have a problem with adjoining property should contact the government for assistance.
- This bill effectively deputizes all property owners to act as proxies for the government in attacking invasive species, regardless of who these people being deputized are. They could be mentally disturbed, ignorant, criminals, or just mean, angry people who hate their neighbors for

something else unrelated to invasive species and wanting to use this law to punish their neighbors. This is a recipe for disaster, since most property owners will be acting out of emotion and anger and not necessarily fully understand the issues involved. This is best left to the government.

Chair Morita, Vice Chair Coffman, and members of the Committee. The Hawai'i Audubon Society was founded in 1939, and it is Hawai'i oldest conservation organization. The primary mission of the Society is to foster community values that result in the protection and restoration of native ecosystems and conservation of natural resources through education, science and advocacy. The Society strongly supports measures that protect our ecosystems from invasive species. Once established, invasive animals and plants crowd out endemic (native) native species. The sad fact is that Hawai'i has the highest number of listed threatened and endangered species in the nation. There are 394 threatened and endangered species in the State of Hawai'i, of which 294 are plants. Invasive plants have led to the extinction of 55 species of plants in the State with another 42 possibly extinct. This extinction, along with the introduction of nonendemic animals has lead to the extinction 24 bird species and is endangering another 32.

The key to controlling invasive species is prevention. However once detected robust eradication efforts should undertaking to eradicate the species, and should include entry onto adjacent land and property if entry is refused. The Hawai'i Audubon Society believes that providing designated state agencies with the authority to enter adjoining property if entry has been refused is an appropriate and necessary measure.

We urge the committee to move HB1928 onto the Judiciary Committee.

We appreciate the opportunity to offer testify here today.

My name is Richard Henderson and I submit this testimony in support of House Bill 1928, Relating to Invasive Species, the purpose of which is to authorize owners of adjoining property to enter private property to remove invasive species.

As a property owner in the Volcano Golf Course Subdivision I can attest to the need to control the growth of invasive species, which at the Volcano is the spread of Morella faya, more commonly called Faya bush.

Morella faya is found on all of the Islands in Hawaii with the exception of Lanai and Molokai and is considered very invasive and is on the Hawaii State Noxious Weed List. The Division of Forestry and Wildlife of the Hawaii Department of Land and Natural Resources has designated this species as one of **Hawaii's Most Invasive Horticultural Plants**.

Under the current law the DLNR may enter private property to control or eradicate an invasive species after reasonable notice is given to the owner of the property. The language in this bill gives those same rights to the owner of the adjoining property. This language will encourage all private property owners to participate in the control of invasive species and become an added force in the States efforts to control these unwanted plant pests.

I urge the Committee to pass HB 1928 and send it to the Judiciary Committee for further favorable consideration. Thank you for the opportunity to testify here today in support of HB 1928. As a REALTOR® in the County of Hawaii there is a need to control the growth of invasive species. More specifically, vacant land lots as well as improved residential lots located at the Volcano are infected with Morella faya, more commonly called Faya bush.

Faya bush, if left uncontrolled, generates a prolific seed bloom even before maturity and when consumed by birds (a favorite of the Myna bird) the seed is spread aerially with no respect to landowner or boundary. As an invasive species (noxious weed) Faya presents several negative aspects to land values and safety. Once established, Faya quickly crowds out any existing endemic species and renders the area impenetrable. As a landowner one is faced with containment/eradication costs that otherwise would not have to be spent if the original infestations were quickly removed. Additional, Faya is an extreme fire hazard and is classified as a "fire fuel" in the Hawaii Volcanoes National Park.


The Hawai'i Chapter of the Sierra Club supports HB 1928, which authorizes reasonable steps to ensure comprehensive eradication efforts of invasive species.

Hawai i is losing the war on invasive species. Some alien species, such as miconia, threaten to destroy watersheds and native ecosystems, jeopardizing freshwater supplies and pushing species to extinction. Other alien species, such as the coqui frog and dengue and its carriers, threaten our health, tourist industry, and our quality of life.

The cost—both economic and environmental—of introduced species in Hawai`i is astronomical. Estimates by one state biologist show that alien pests cost residents and the agriculture industry upwards of \$400 million annually. Hawaii's residents, businesses, and agricultural operations foot this bill. Tourism, agriculture, native species, and citizens' way of life are threatened with each new introduction. Unfortunately, experts tell us the next invasion is not a matter of "if," but rather a matter of "when."

Disturbingly, we've heard stories of a single property owner refusing to engage in eradication efforts of an invasive species (in this case, the coqui), which flouted the efforts of all neighboring property owners. Coqui frogs would simply spread from the noncompliant property, regardless of efforts by everyone else in the neighborhood. Plainly, efforts to eradicate invasive species require immediate action by everyone living near the origin point. This bill is a small step towards comprehensive eradication efforts.

Testimony of the ACLU of Hawaii in Opposition to H.B. 1928 Relating to

Invasive Species

Dear Chair Morita and Members of the Committee on Energy and Environmental Protection:

The American Civil Liberties Union of Hawaii ("ACLU of Hawaii") writes in opposition to H.B. 1928, which seeks to authorize owners of adjacent property to enter private property to remove invasive species.

While we understand that invasive species are proliferating and causing numerous problems in Hawaii, this bill is unnecessary in that we already have an experienced Hawaii Invasive Species Council and a Department of Land and Natural Resources to control invasive species on private property. Expanding this law to "deputize" adjacent property owners to enforce the law will needlessly erode private property rights and make every person's backyard subject to their neighbor's entry. Given that the Hawaii Invasive Species Council lists over 45 "high-profile" invasive species on their website (www.hawaiiinvasivespecies.org/pests/index.html.), including algae, strawberry guava, coqui, and miconia, and twice as many are listed on their invasive species list (www.hawaiiinvasivespecies.org/hisc/pdfs/hiscinvasivespecieslist.pdf), every private property owner in Hawaii could see her or his property rights reduced.

Deputizing adjacent property owners and giving them warrants to enter their neighbors' property will invite a host of problems for the State. For example, the State may be found liable for the destructive actions of these adjacent property owners when they enter their neighbor's private property and — without proper training or supervision — attempt to control and/or eradicate the invasive species.

The ACLU of Hawaii respectfully urges this Committee to defer this bill.

Dear Chair Morita, Vice-Chair Coffman and Committee Members,

On behalf of our more than 47,700 members and supporters in Hawaii, The Humane Society of the United States **STRONGLY OPPOSES HB 1928**; relating to the removal of invasive species.

While much of our work at the state, national and international level involves the protection of threatened and endangered species, including tremendous efforts to reduce and/or eliminate the introduction of new invasive and exotic species, we do not believe the proposed bill would in any way better protect our fragile environment or truly reduce the impact of invasive species. Furthermore, we have the below concerns;

- The majority of citizens do not know what particular species are legally and officially
 designated as "invasive"; decisions to control and/or eradicate invasive species on private
 property should be handled by trained, professional wildlife and humane animal control
 experts.
- Our utmost concern is for the humane and effective control of invasive animal species.
 This bill provides no reference as to what process or methods of control or eradication would be allowed. Inhumane or cruel methods used to eradicate such species may in fact be in violation of multiple, existing animal cruelty and protection laws.
- This bill would essentially allow adjoining property owners to violate private property laws and gain trespass when they believe a species may be invasive.
- Limited and critical law enforcement resources should instead be directed at criminal or other violations, not the removal or oversight of removal of invasive species on private property unless there is an animal cruelty or other criminal or civil violation.
- HRS 520A already limits landowner liability for access to control invasive species on their property.

Thank you for your consideration of this testimony. We again urge your opposition to HB 1928.
