TESTIMONY Nikki Love, Executive Director, Common Cause Hawaii

Chair Taniguchi, Vice Chair Takamine, and Committee Members:

I would like to submit comments regarding HB2003 HD3.

There have been several campaign finance bills so far this session, including HB2003, HB2004, SB 2251 and SB2252. Now, the only campaign finance measure still alive is this one, HB2003 HD3.

In collaboration with other citizen groups, we have pinpointed several priority topics in this session's campaign finance bills. We urge the Committee to address these important issues in HB2003, so that we can be sure to maintain good existing laws and incorporate much-needed clarifications. Our priority topics are as follows:

- Limit Corporate Donations to Candidates. Establish a ban or low aggregate limit on money transferred from a corporation's treasury to its noncandidate committee. Although the recent Supreme Court decision allows corporations and unions to spend freely on independent expenditures (e.g., advertising), the court did NOT overturn the federal ban on corporate donations given directly to candidates. Given these details, the Hawaii legislature can and should insert a ban or low limit on corporate contributions to candidates.
 - ➤ HB2003 HD3 includes an aggregate per-election limit of \$1,000 from a person to a noncandidate committee, but we ask that additional language be inserted to ensure corporate donations are subject to the limit.
- Ensure Transparency for Any Corporate Donations. If the legislature decides to permit
 corporations to make contributions to candidates, it must be done through a noncandidate
 committee and subject to proper reporting. It is essential to have thorough, transparent reporting
 of these political donations from business interests.
 - > In HB2003 HD3, this important provision is missing and we ask the Committee to reinsert it.
- Keep Our Pay-To-Play Law Intact. Back in 2005, in response to concerns about ties between lucrative contracts and political donations, the legislature enacted an important law that prohibited government contractors from donating to campaigns. This existing law is clear and simple, and should be maintained.
 - In HB2003 HD3, this language is included. We ask the Committee to keep this provision intact.

- Policy of Transparency and Integrity. The Campaign Spending Commission's original bill included language for a "Declaration of Policy" that specified the purpose of the law is to ensure the integrity and transparency, and that any ambiguity in the law shall be construed in favor of transparency.
 - In HB2003 HD3, this language is included. We ask the Committee to keep this provision intact.
- Mainland Contributions. The current law includes a 20% limit on out-of-state contributions. This law encourages candidates to focus on raising funds from their own districts and our own state. Increasing this cap would encourage the influx of campaign money from special interests on the mainland.
 - > In HB2003 HD3, this limit is raised to 30%. We ask that the language be reverted back to the existing law.
- Campaign Fund Uses/Donations to Schools & Libraries. Currently, candidates are allowed to donate a limited amount from their campaign funds to community groups. Limits on these donations to community groups were put in place in an attempt to level the playing field and in response to past abuses. These donations have been described as "seeding the community" with small, but highly visible, contributions. Now, proposed language would allow additional donations to schools and libraries. Funding for schools and libraries should be addressed through sound public policy or by philanthropy—not from campaign coffers.
 - ➤ HB2003 HD3 allows candidates to donate additional campaign funds to schools and libraries. We ask that the language be reverted back to the existing law.

We believe the items above are critical components to strengthen our campaign finance law, ensure transparency and disclosure for the public, and curb the mounting influence of money in politics.

Require corporations to make all donations through a PAC and subject to proper reporting, 3) Keep Our Pay-To-Play Law Intact. Campaign funds should not be used for seeding the community. The existing restrictions help prevent abuses and level the playing field for all candidates. Dear Chair Taniguchi, Vice Chair Takamine, and Committee Members:

Kanu Hawai'i is a movement for sustainable, compassionate, self-reliant island communities with members who start with a personal commitment to "be the change" they seek. We have nearly 10,000 members from every populated island and every zip code in Hawai'i with the exception of Ni'ihau.

Since the start of the 2010 Legislative Session, more than 400 of our members have been following a handful of bills together, including HB2003. These members come from across the islands, range in age from middle school students to senior citizens, and represent all walks of live. Members have actively discussed, and voted their opinion on HB2003 and the issues it addresses. We are writing to comment on HB2003. This testimony is based upon online and offline voting and discussion. The vast majority of votes cast by members on campaign finance issues have been in favor of the following position, however we do not claim to speak on behalf of all Kanu members

To effectively keep money out of politics, we believe the bill must include three important provisions:

- 1) Keep Our "Pay-To-Play" Law Intact. Back in 2005, in response to concerns about ties between contracts and political donations, the legislature passed a law prohibiting government contractors from donating to campaigns. Throughout this session, lawmakers have tried to remove or water down this part of the law. We believe the existing prohibition should be maintained.
- 2) Limit Corporate Donations to Candidates. A recent Supreme Court decision allows corporations and unions to spend freely on independent expenditures (e.g., political advertising). However, the court did not overturn bans on corporate donations given directly to candidates. The Legislature has attempted to increase or remove this limit throughout the session. In contrast, we believe the law should establish a ban or low limit on money transferred from a corporation's treasury to its PAC.
- 3) Ensure Transparency for Corporate Donations. The bill should require corporations to make all donations through a Political Action Committee, subject to proper reporting. Without this rule, corporate donations will be difficult to keep track of.

We are some of the Kanu Hawai'i members who feel strongly about this issue. Mahalo for the opportunity to testify on this matter.
