Aloha,

I am writing in regard to the Bill **HB2029 HD1** in regards to de-regulation of the Cosmetology industry in Hawaii.

I am a Spa Director in Hawaii, and I **STRONGLY OPPOSE** this bill. The Board of Cosmetology helps to ensure that all estheticians, nail technicians, barbers and all Cosmetologists practice safe and ethical services on clients. They also ensure that safe cleaning and maintenance of facilities is upheld. Their function is critical to the protection of consumers and necessary as a state regulatory board to keep the Day Spas, Resort Spas and individual therapists accountable. The DCCA will not be able to effectively manage this process with the necessary consistency, and I feel that this consistent oversight and regulated standards are critical to the safety of our guests.

As a Spa Director, I receive multiple comments and concerns from guests who have experienced fungal infections, allergic reactions, or other harmful care during facials. They already express high anxiety over the potential damage due to unsafe cosmetologist practices. There has been a large mount of press and research done on the potential harm caused by unsafe cleaning and treatment practices – particularly with regards to pedicure and other nail services. Additionally, barbers and cosmetologists are able to use straight razors and chemical applications to the face; By deregulating the industry and thereby invalidating the requirements for safe practice through licensure, we create a huge risk to our consumers and customers.

Please do not pass the Bill HB2029 HDI and deregulating the Cosmetology industry in Hawaii.

RE: HB 2029

I am in strong opposition to SB 2029, specifically with regard to the non regulation/licensure of hearing aid fitters & dealers. To my best knowledge, every state in the USA requires licensing and regulation of hearing aid dispensers (referred to as hearing aid fitters & dealers in Hawaii), If the licensing requirement is removed, it most likely will lead to many unintended consequences such as:

1. Ability of individuals who have lost their license in another state, presumably due to wrongdoing and/or unethical behavior to be able to freely dispense liearing aids in our state.

2. Such ease of entry and lack of rules governing the practice would most likely affect our seniors dramatically, by allowing anyone including those who have a past history of exploiting seniors to lawfully be able to dispense hearing aids.

We currently have a very low incidence of complaints against hearing aid fitters & dealers in Hawaii, as referenced by the non existence in 2008-2009. Please verify with DCCA.

In addition, since hearing aid fitters & dealers and audiologists both perform overlapping functions, such as testing the hearing, recommending the proper type of hearing aids, programming them, counseling the end users and providing follow up care, it is my opinion that the wording in HB 2029 excludes the hearing aid fitters & dealers and favors the Audiologist with the protection of regulation.

Thus, I respectfully request that the hearing aid fitters & dealers be removed from this bill. I thank you sincerely for your careful consideration in this matter.

My name is Randy Wohlers and I am writing in opposition to HB 2029 which would repeal the State regulatory process and oversight of Hearing Aid Fitters and Dispensers.

I have been a Hearing Aid fitter and dispenser for 35 years. I am board certified and have been recognized nationally for providing the highest level of competency and care for my patients. I employ over 9 fitters and dispensers state wide at 6 location state wide. My practices see over 150 people daily for service and hearing health care procedures. We have under our care over six thousand patients that we see every 3 months to assure the best possible hearing and communication is provided for all our patients. Our average patient is 75 years old, that means we take care of your mom, dad or your grandparents.

Our educational requirements are stringent and set the standard, our standard is recognized nationwide. The Board Certification requirements are stringent and administered and require yearly continued education which all my dispensers follow.

My fear is the care and level of care for my patients will diminish if we are not excluded from this bill. We would be the only state in the union that is not regulated by the state. This would encourage anyone who was dismissed from any state from practicing to come Hawaii and practice. The deregulating of our profession, which has been the main stay for our senior population would be catastrophic.

I urge you to please repeal Hearing Aid Fitters and Dispensers from this bill.

I'm a Big Island physician and was shocked to learn there's a measure up for your vote this Friday which may take the privilege of licensure away from marriage and family therapists.

I have personally worked with hundreds of LMFTs over more than thirty years. I have a close professional relationship with several here in the Kailua-Kona area who provide essential and exemplary care for thousands of people who require counseling. As you're aware, the neighbor

'lands, at least, have a critical shortage of mental health professionals. Without the FTs, the total burden of covered care will be on the shoulders of a few psychiatrists (and possible Ph.D. psychologists) who could not possibly handle the caseload.

The marriage and family therapists I know and use for my patients take clients without respect to insurance coverage. Because of this, they're already undercompensated for their level of expertise. If you take away their licensure, they will be completely unreimbursed except for those wealthy enough to pay out of pocket (of which there are very few people that I know of). This will force the vast majority to close their practices and possibly abandon our state.

These are highly-trained professionals that our populace has relied on and have been every bit as integral to our health care system as my fellow MDs, our nurses and other licensed personnel. To arbitrarily eliminate the licenses of this group would be devastating for all of us citizens of this state.

I urge you to consider voting against this ill-conceived bill or at the very least tabling it so you could have more time to assess its impact. Please do not deregulate this vital population.

I am a Marriage and Family Therapist on the island of Maui. Marriage and Family Therapists serve a vital function in our communities with the focus on treating and healing the families we serve. As a MFT in a rural area we like other health care professions are in great demand. Removing our ability to serve the families here in Hawaii will have a negative impact that will be felt in our institutions such as jails, prisons, and hospitals that struggle with overpopulation already. Insurance companies rely on our expertise to treat and prevent a variety of mental health issues and can only continue to utilize MFT's if we are regulated by a State Government agency.

Personally, I came to Hawaii to practice as a MFT because of the alignment of shared core values of my occupation with the deeply held cultural beliefs of honoring ones "Ohana". While I understand the complexities facing your committee during this challenging fiscal year, I urge you to not turn your back on Hawaii's families. As a Psychologist, I am writing to express my opposition to HB2029 and vote against its passage within your committee.

I am very grateful for my colleagues who are marriage and family therapists (MFTs), and I ask that you please consider the following reasons I am joining with them in opposing this bill:

Repealing the regulatory program managing licensure of MFTs would decrease the availability of qualified mental health services within our state, especially to those who reside in rural areas, causing hardship for clients and for the MFT industry. MFTs are important to Hawaii and its residents because:

- 1. MFTs are more likely to practice in rural areas than are other mental health professions.
- MFTs specifically work in concert with other professions as well as with families and communities.
- 3. MFTs are widely recognized as providers of mental health services throughout the country and are designated as a "core mental health profession" by the federal government. They are effective practitioners who treat the full range of mental and emotional disorders and health problems.
- MFTs provide quality mental health services. Over 98 percent of clients of marriage and family therapists report therapy services as good or excellent.
- 5. MFTs are extensively recognized as viable mental health providers within our federal and state governments.

Marriage and Family Therapists provide essential mental health services to the people of Hawaii. I ask for your support by voting <u>against</u> HB2029.
