
Thank you for this opportunity to testify. My name is Robert Peters and I currently serve as the Chair of the Early Learning Council established by Act 14 in 2008. The thirteen member council supports this bill as it would facilitate the Council's work and increase the opportunity for transparency of its meetings.

House Bill 2075 allowing the Council to meet by teleconference has three distinct advantages over the current set-up: first, it would allow those not able to be physically present at the Council's meetings to participate which has particularly positive implications for neighbor island members along with reducing travel costs; second, it enhances the possibility of achieving a quorum at all meetings since teleconference participation shall qualify as being "present" at the meeting wherever the location; and, third, it offers members of the public increased opportunities to participate since the teleconference locations will all be open to the public.

This bill offers a solution to the problems faced by some of our members who find it difficult to travel to one location and again opens the meetings to many more from the public by including alternative locations. While the cost reduction alone at this time might be justification enough for this bill, it is truly the increased transparency in which we may gain the most as the public is invited to be an on-going and increasing participant in our discussion of this vitally important topic, early childhood learning---the cornerstone of our state's future sustainability.

I strongly urge the House Committee on Education to pass this measure and in so doing both the efficacy and efficiency with which the Early Learning Council is able to carry on its most important work.

My name is Robert Witt and I am executive director of the Hawaii Association of Independent Schools (HAIS), which represents 99 private and independent schools in Hawaii and educates over 33,000 students statewide.

The Association is in **strong support of House Bill 2075** – Relating to the Early Learning Council, which allows the Early Learning Council to conduct meetings by teleconference, and sets out quorum requirements and public notice and participation requirements for teleconference meetings.

HAIS has worked collaboratively over the past few years with the leadership of the House Committee on Education to design, implement, and advance the work of the new Early Learning Council.
