Purpose of Bill: Implement, upon ratification, the constitutional amendment to abolish the Board of Education. Among other things, the bill: (1) abolishes the Board of Education; (2) authorizes the Governor to appoint the Superintendent; (3) authorizes the Superintendent to appoint the State Librarian and places the public libraries under the Department of Education; (4) allows the Governor to have two votes and a Children's Advocate to have two votes in negotiating collective bargaining for Bargaining Units 5 and 6; (5) has the Superintendent appoint the Hawaii Teacher Standards Board Executive Director; (6) has the Superintendent determine the composition of the Committee on Weights members; (7) gives the Superintendent management and operational control over the public libraries; and (8) makes the Superintendent or the Superintendent's designee a member of the Charter School Review Panel.

Board's Position: Chairperson Takumi, Vice Chairperson Berg, and members of the House Committee on Education, thank you for the opportunity to testify on H.B. No. 2178.

The Board of Education (Board) opposes H.B. No. 2178, which is

enabling legislation to abolish the Board of Education.

The State Board of Education has a fundamental role and responsibility to formulate statewide educational policy and serves as the primary advocate for a quality education for all students in our State. An elected Board of Education seeks to promote the best education possible for all students and advocates equality of access to educational opportunity.

As an elected state board, Board of Education members reflect a cross-section of viewpoints and individuals who are elected by the voting public. An elected Board of Education, like the Legislature and county councils, reflect the diverse viewpoints and interests of their membership and the community and voters who elect them to office. This diverse representation is important to a quality public education where the interests of all students are represented.

A State Board of Education also serves as a facilitator among educators, students, elected officials, business and community groups, and others in educational policymaking. The Board conveys the needs of our public school system and public library system to the Legislature, the Governor, and the public to convey the needs of students and schools, to emphasize the importance of libraries and schools for a literate and productive citizenry, and to draw support for public education and public libraries.

A State Board of Education sets state education policy for the public school system and public library system. This fundamental responsibility is separate and apart from the operational responsibilities of the Department of Education and Hawaii State Public Library System. A State Board of Education provides citizen oversight and direct accountability to the community for education.

The Board notes that the abolishment of the Board under H.B. No. 2178 would result in the following as specified in this bill: (1) the Governor would appoint the Superintendent; (2) the State Librarian would fall under the Superintendent and be subject to policies established by the Superintendent and be appointed by the Superintendent; (3) the Governor would have two votes and a children's advocate would have two votes in collective bargaining; (4) the Superintendent would appoint the Hawaii Teacher Standards Board Executive Director; and (5) the Superintendent or the Superintendent's designee would serve as a member of the Charter School Review Panel.

The Board strongly believes that the indiscriminate fusing of separate and distinct roles and responsibilities of the Superintendent of Education and State Librarian under this bill disregards the importance of public education and the important role and function of our public libraries in contributing to a literate and informed community. Folding the State Librarian position and public library services under the Superintendent neglects to understand the important responsibilities and delivery of public library services in our communities. Placing library services under the Department of Education diffuses the important role and significant responsibilities of the Department of Education in educating students and the responsibilities of the Hawaii State Public Library System in providing library services throughout our State and supporting life-long learning in the community.

The other areas identified above would raise potential conflicts in the hiring and licensing of personnel, the balance

of collective bargaining negotiations, and decisions regarding the approval and revocation of charters.

While governance has its challenges, the problems and concerns of public schools should not be attributed to educational governance. Abolishing the Board of Education and shifting control to the Executive Branch or other entity is not the solution for educational improvement. A State that is committed to strong democratic principles must have the strong involvement of the public in decision-making and embrace participatory government in public education.

Abolishing the Board of Education will eliminate direct public access to a government entity that is dedicated to and focused on educational governance and formulating statewide educational policy for our public school and public library systems. The unique role of any state education board is such that it serves as a strong advocate for quality education for all students, sets goals and expectations for the public education system, sets statewide curriculum standards, and establishes high school graduation requirements, among other areas. > State boards have always been regarded as critical to insuring education as a state function, with the responsibilities of state boards reflecting two deeply-held educational values: the lay governance of education and the separation of educational policymaking from partisan politics.

For these reasons, the Board opposes this measure. Thank you for the opportunity to testify on H.B. No. 2178.

HB 2178 – Relating to Education

The Hawaii State Public Library System (HSPLS) opposes HB 2178 Relating to Education. This bill abolishes the Board of Education (BOE). It authorizes the Governor to appoint the superintendent of education and establishes the Department of Education (DOE) to serve as a cabinet-level department within the State administration. It also authorizes the superintendent of education to appoint the state librarian and transfers the powers and duties previously held by the BOE to the Superintendent. Having the State Librarian and the HSPLS come under the direction of the DOE Superintendent will adversely impact the operations and administration of all 51 public libraries, create added bureaucracy, delay critical CIP projects, and most importantly adversely affect services to all of our patrons, statewide. If there is no BOE as a result of this bill and subsequent constitutional amendment, placing HSPLS under the DOE would be a huge mistake and would reduce our place and stature within State government. Our missions, goals, and purposes are completely different as well as separate and apart from those of the DOE. Act 150, SLH1981 specifically created HSPLS as a separate agency under the State BOE and appropriately moved us out from under the auspices of the DOE. There were strong

reasons to separate us from the DOE back then, and those reasons remain valid today. You should not undo what was rightly corrected by the Legislature 28 years ago.

With no BOE, we would like to propose another option and request that HSPLS become an attached agency under the Department of Accounting and General Services (DAGS) rather than within a division of the DOE. The reasons for this request are as follows:

HSPLS currently operates and functions like any other State agency within the Executive Branch. DAGS processes all HSPLS fiscal transactions including payroll, operating checks, vouchers, contracts, transfers, etc. DHRD handles all our personnel transactions (see below) and our Chief Procurement Officer is Aaron Fujioka, the State Procurement Officer. Under HB 2178, the DOE would be assuming and transitioning this added workload and responsibilities. We have a long standing Memorandum of Agreement with DAGS to provide repair, maintenance, servicing, etc. for all of our Library facilities. DAGS advises and administers all our construction contracts and is the designated expending agency for HSPLS CIP appropriations, as well as processing all fiscal operations including payroll, vouchering, transfers, etc. HSPLS is one of the largest State agencies serviced by DAGS, so without HSPLS' projects, DAGS would face possible staffing cuts and other downsizing due to lack of workload and revenue. We have continued to work very well with DAGS in successfully completing a record number of CIP projects including Health & Safety, Energy Efficiency projects, and several new libraries over the past few years.

Another argument in favor of this proposal is the status of our HSPLS civil service employees. Last year, the State BOE requested an Attorney General opinion to determine whether HSPLS employees were under the jurisdiction of the DOE administered civil service system or the executive branch civil service system administered by the Department of Human Resources Development (DHRD). It was concluded that our HSPLS employees remain with the DHRD executive branch system, as they would as employees under DAGS. HSPLS would be more in conformance with the other agencies administratively attached to DAGS such as the State Foundation on Culture and the Arts, Stadium Authority, Office of Elections, King Kamehameha Celebration Commission, etc. rather than in the DOE.

The Library Advisory Commission could be established by the Governor and provide direct oversight of the HSPLS including appointment of the State Librarian, similar to the authorities and boards governing DAGS' other attached agencies. As a result of our current working arrangement with these support agencies (DAGS, DHRD, etc.), we believe that HSPLS has been operating very efficiently, maintained good fiscal practices and reporting, and complied with all budgetary and personnel mandates, while still providing quality library services to the people of Hawaii.

If this bill becomes law, the DOE will have more than enough to do in transitioning to an entirely new organizational structure for the State's public education system. We believe the Superintendent does not need or would really want this new, diverse, and additional responsibility of having to oversee the public library system. We have begun discussions with the Department of Budget & Finance, DAGS, DOE, and the Governor's Policy Office to address any of their concerns regarding this proposal. In conclusion, if the BOE were to be abolished, we are not opposed to having the DOE serve as a cabinet-level department within the State administration or authorizing the Governor to appoint the Superintendent of Education. We are strongly opposed to HSPLS being transferred into a division or any other section within the DOE. We look forward to working with your Committee to address our stated concerns with this bill and on the future of the Public Library System. Thank you for the opportunity to testify on HB 2178.
